



Annual status report of the annual inventory of Hungary

1. This status report was prepared by the expert review team as part of the initial check of the annual inventory submitted in accordance with decision 15/CMP.1. It reflects the content of the inventory submission of 2013 as originally submitted by the Party, and of the resubmission received by 27 May 2013.
