Letter dated 12 September 2013 from the Permanent Representative of Israel to the United Nations addressed to the President of the Security Council

I am writing to inform the Security Council of 62 incidents in August in which Lebanon breached Israeli sovereignty in violation of Council resolution [1701 \(2006\)](#).

For years, the Government of Lebanon has repeatedly violated its international obligations in regard to the Blue Line separating Israel and Lebanon. Attached please find a complete list of all Lebanese violations of Israeli sovereignty for August 2013 (see annex).

Members of the international community must act with a common purpose and prevail upon Lebanon to cease violating Israeli sovereignty. I should be grateful if you could circulate the present letter and its annex to the members of the Security Council and have it issued as a document of the Council.
