Chapter I

Organizational matters

A. Membership

1. In its resolution 43/222 B, the General Assembly decided to retain the Committee on Conferences as a permanent subsidiary organ. Pursuant to the provisions of that resolution, in 2013 the Committee was composed of the following Member States: Austria, Bosnia and Herzegovina, China, the Congo, Côte d'Ivoire, Ethiopia, France, Iraq, Israel, Japan, Libya, Namibia, Peru, the Philippines, the Russian Federation, Senegal, Sri Lanka, the United States of America and Uruguay.

B. Officers

2. At its organizational session for 2013 (522nd meeting), held on 29 April 2013, and at its review of the provisional calendar of conferences and meetings in the economic, social and related fields for 2014 and 2015 (523rd meeting), held on 2 July 2013, the Committee elected the following officers to serve in 2013:

3. Also at its organizational session, the Committee agreed in principle that the Chair would undertake informal consultations with a view to determining the composition of its Bureau for 2014 and that the outgoing Chair and members of the Bureau would continue in their capacity until the 2014 Bureau was elected.

C. Organization of work

- 4. At its organizational session, the Committee decided to adopt at its substantive session the dates for its organizational and substantive sessions for 2014 so that the dates would be included in the calendar of conferences and meetings. The Committee also agreed to follow the guidelines adopted in 1994 and 1995 with regard to its consideration of intersessional departures from the approved calendar of conferences and meetings and to meet, as required, to review proposals affecting the schedule of conferences and meetings during sessions of the General Assembly.
- 5. Also at its organizational session, the Chair proposed that the Committee meet in order to review the provisional calendar of conferences and meetings in the economic, social and related fields for 2014 and 2015.

- 6. At the same session, the Under-Secretary-General for General Assembly and Conference Management addressed the Committee.
- 7. At the 523rd meeting, on 2 July 2013, the Secretary of the Committee introduced the provisional calendar of conferences and meetings in the economic, social and related fields for 2014 and 2015 (E/2013/L.6). The Committee reviewed the provisional calendar and recommended its adoption to the Economic and Social Council. The recommendation of the Committee was transmitted in a letter dated 10 July 2013 from the Chair of the Committee to the President of the Council (E/2013/93).
- 8. The Committee convened its substantive session from 3 to 9 September 2013 (524th to 528th meetings). At the opening of the substantive session, on 3 September, the Under-Secretary-General introduced the report of the Secretary-General on the pattern of conferences (A/68/122). During the formal meetings, statements were made by the representatives of Austria, China, the Congo, Côte d'Ivoire, Ethiopia, France, Japan, Libya, Peru, the Philippines, the Russian Federation, Senegal, the United States and Uruguay, and by the observer for the International Organization of la Francophonie.

D. Programme of work

9. At its organizational session for 2012 (517th meeting), held on 25 April 2012, the Committee requested that the Secretariat submit the provisional agenda for 2013 to the Committee at its organizational session for 2013. At its organizational session for 2013 (522nd meeting), held on 29 April 2013, the Committee adopted the provisional agenda (A/AC.172/2013/L.1) and requested that the Secretariat submit a provisional agenda for 2014 to the Committee at its organizational session for 2014. The Committee also decided to include in its programme of work for the year, prior to the Committee's substantive session or upon request, informal briefings by the Secretariat on issues relating to conference management of interest to Member States.

E. Participation of observers

10. One Member State, Egypt, was represented as an observer at the organizational session of the Committee. The following three Member States and two intergovernmental organizations were represented as observers at the substantive session: Cuba, Egypt, Qatar, the European Union and the International Organization of la Francophonie.

Chapter II

Calendar of conferences and meetings

A. Requests for exceptions to section I, paragraph 7, of General Assembly resolution 40/243

11. At its 524th meeting, on 3 September 2013, the Committee on Conferences considered the sections of the report of the Secretary-General on the pattern of conferences (see A/68/122, sect. I.A.1, and supplementary information,² sect. I) containing requests for exceptions to section I, paragraph 7, of General Assembly resolution 40/243, by which the Assembly decided that no subsidiary organ of the Assembly might meet at United Nations Headquarters during a regular session of the Assembly unless explicitly authorized by the Assembly.

Conclusions and recommendations

- 12. The Committee on Conferences recommended that the General Assembly explicitly authorize the following bodies to meet in New York during the main part of its sixty-eighth session, on the understanding that all such meetings would be allocated conference services on an "as available" basis, in such a way that the work of the Assembly and its Main Committees would not be impeded:
 - (a) Open Working Group on Sustainable Development Goals;
 - (b) Committee on Relations with the Host Country;
 - (c) Disarmament Commission;
 - (d) Independent Audit Advisory Committee;
- (e) Committee on the Exercise of the Inalienable Rights of the Palestinian People;
 - (f) United Nations System Chief Executives Board for Coordination;
- (g) Executive Board of the United Nations Entity for Gender Equality and the Empowerment of Women;
- (h) Working Group on the Financing of the United Nations Relief and Works Agency for Palestine Refugees in the Near East;
- (i) Intergovernmental Committee of Experts on Sustainable Development Financing;
 - (j) Commission on Sustainable Development.

B. Adoption of the draft biennial calendar of conferences and meetings for 2014 and 2015 and related matters

13. At its 524th meeting, on 3 September 2013, the Committee reviewed the draft biennial calendar of conferences and meetings for 2014 and 2015 (A/AC.172/2013/L.2).

C. Intersessional departures for 2013 and related matters

- 14. The General Assembly, in its resolution 67/237, approved the draft revised calendar of conferences and meetings of the United Nations for 2013, as submitted by the Committee on Conferences, and authorized the Committee to make any adjustments that might become necessary as a result of actions and decisions taken by the Assembly at its sixty-seventh session. The calendar was issued as document A/AC.172/2013/2.
- 15. At its 373rd meeting, on 26 August 1994, the Committee decided that, in future, requests for intersessional departures submitted to the Committee should be reviewed by the Bureau, in consultation with the Secretariat, for subsequent action.
- 16. At its 379th meeting, on 23 March 1995, the Committee agreed that proposed changes to the calendar that did not have programme budget implications could be dealt with by the Secretariat, in consultation with the Bureau of the Committee.
- 17. At its substantive session of 1995, the Committee decided that requests for intersessional departures submitted to the Committee that involved a change of venue should be referred to the members for approval. Departures that involved other types of changes, as decided upon by the Committee at its substantive session of 1994, should be reviewed by the Bureau, in consultation with the Secretariat, for subsequent action.
- 18. The Committee on Conferences approved several requests in 2013 from the Advisory Committee on Administrative and Budgetary Questions for additional meetings and extended meeting hours. The Committee also approved a request from the Advisory Board on Disarmament Matters for a change of venue from New York to Geneva. The Committee noted the request of the Fifth Committee for an additional meeting to conclude its work at its second resumed session.

Chapter III

Meetings management

A. Utilization of conference-servicing resources and facilities

1. Meeting statistics of United Nations organs and consultations with bodies concerning the utilization of conference-servicing resources

- 19. At its 524th meeting, on 3 September 2013, the Committee on Conferences considered the section of the report of the Secretary-General on the pattern of conferences containing statistical data and analysis of the utilization of conference resources allocated to a core sample of bodies that met in New York, Geneva, Vienna and Nairobi (see A/68/122, paras. 6-17, and supplementary information, sect. II). Pursuant to General Assembly resolution 67/237, the Department for General Assembly and Conference Management had worked closely with the secretariats and bureaux of the six intergovernmental bodies whose utilization factor over the past 10 years had fallen below the benchmark of 80 per cent, offering a number of specific suggestions to improve their use of conference services.
- 20. The Committee considered the Secretary-General's specific suggestions on measures to improve the utilization factor of those intergovernmental bodies whose average has for the past 10 years been below the benchmark of 80 per cent. While delegations agreed to urge those intergovernmental bodies to take their utilization factor into account when planning their future sessions in order to achieve the benchmark, some delegations insisted that more practical measure to reduce the costs of conference servicing, such as planning fewer meetings and shortening the duration of meetings, be considered. Given the lack of agreement on specific language to add to General Assembly resolution 67/237, the Committee decided to refer the issue to the Fifth Committee for its consideration.
- 21. The Committee also heard a report by the Chair on her mandate to hold consultations with the intergovernmental bodies whose utilization factor had fallen below the 80 per cent benchmark over the past three consecutive years: the Committee on Information, the Committee on Contributions and the Executive Board of the United Nations Children's Fund. As a result of those efforts, those bodies had tentatively agreed to either reduce the length of their meetings, reduce the number of meetings scheduled, in accordance with their needs, or provide advance notice of meeting cancellations.

2. Provision of interpretation services to meetings of bodies entitled to meet "as required"

22. At the same meeting, the Committee considered the section of the report of the Secretary-General on the pattern of conferences concerning the provision of interpretation services to meetings of bodies entitled to meet "as required" (see A/68/122, para. 18, and supplementary information, sect. III). In New York, the number of requests had increased sharply, from 577 in 2011 to 687 in 2012; 97 per cent of requests had been met in 2012, compared with 96 per cent in 2011. Geneva had continued to meet 100 per cent of requests.

3. Provision of interpretation services to meetings of regional and other major groupings of Member States

23. Also at the same meeting, the Committee considered the section of the report of the Secretary-General on the pattern of conferences concerning the provision of interpretation services to meetings of regional and other major groups of Member States (see A/68/122, para. 19, and supplementary information, sect. IV). In New York, 95 per cent of requests had been met in 2012, compared with 92 per cent in 2011. In Geneva, 86 per cent of requests had been met in 2012 as compared with 89 per cent in 2011.

4. Utilization of conference facilities at the United Nations Office at Nairobi

24. Also at its 524th meeting, the Committee considered the section of the report of the Secretary-General on the pattern of conferences concerning utilization of conference facilities at the United Nations Office at Nairobi (A/68/122, para. 20).

5. Utilization of the conference centre at the Economic Commission for Africa

25. At the same meeting, the Committee considered the section of the report of the Secretary-General on the pattern of conferences concerning the utilization of the conference centre at the Economic Commission for Africa (A/68/122, paras. 21-27).

B. Impact of the capital master plan, strategy IV (phased approach), on meetings held at Headquarters during its implementation

26. Also at the same meeting, the Committee considered the section of the report of the Secretary-General on the pattern of conferences concerning the impact of the implementation of the capital master plan on meetings held at Headquarters (see A/68/122, para. 28, and supplementary information, sect. V). In accordance with the restacking plan, staff had been relocated to the Secretariat Building and the Albano Building. Newly renovated rooms had been reopened in the Conference Building. The General Assembly Hall had been closed for the final phase of the renovation since June 2013.

27. The Committee noted with concern that several problems had been encountered in the newly renovated conference rooms, but that it had not been able to reach agreed language to address the concerns. Consequently, the Committee decided to refer the issue to the Fifth Committee for its consideration.

Chapter IV

Integrated global management

A. Status report, performance measurement and evaluation of the quality of conference services

- 28. At its 524th meeting, on 3 September 2013, the Committee on Conferences considered the section of the report of the Secretary-General on the pattern of conferences concerning integrated global management (see A/68/122, paras. 29-43, and supplementary information, sect. VI). Member States were supportive of the concept, which held that conferences should be not only serviced but also managed; the four duty stations should share resources and apply the same conference management policies and practices; and the workload and the capacities should be integrated and managed from a global perspective.
- 29. The global document management system, gDoc, would be completed in 2013. A complementary global project, called gText, would offer referencing, terminology and computer-assisted translation features with a view to improving consistency in translations and standardizing and automating the documentation process. Both projects would be implemented in the biennium 2014-2015.
- 30. Several delegations enquired why the Department for General Assembly and Conference Management had not yet codified the division of responsibilities for conference management between the Under-Secretary-General for General Assembly and Conference Management and the Directors-General of the United Nations Offices at Geneva, Nairobi and Vienna.
- 31. In response to the delegates' enquiries, a representative of the Secretariat said that, under the existing regulations, the Directors-General of the United Nations Offices at Geneva, Nairobi and Vienna were responsible for activities at their duty stations, while the budgets for conference management were managed by the Department. The General Assembly, in its resolution 67/237, had called for a report on progress in resolving the issue. In that regard, discussions were under way regarding the amendment of the relevant Secretary-General's bulletins. It was expected that the matter would be finalized by the sixty-ninth session of the General Assembly.
- 32. The gDoc and gText initiatives were not intended to reduce staff numbers, but rather to improve the quality of their work. For example, the technology would allow translators to identify previously translated text quickly, thus saving time and ensuring consistency across documents. The Department could not afford to reduce its valuable human capital; savings were instead being sought through reductions in equipment and travel costs. Quality was of paramount importance to the Department; feedback from Member States was collected through the language-specific informational meetings and the annual global e-survey. The four duty stations and the regional commissions worked together to apply the proximity rule. The savings cited in the report had been achieved through reduced travel costs and the principle of delivering as one. However, it should be noted that meeting conditions and opportunities could fluctuate greatly from year to year; it was thus impossible for the Department to predict the potential savings resulting from the implementation of the rule.

33. The Committee did not agree on a proposal to request the Secretary-General to propose ways to enhance the system of assessment of the quality of services provided. Consequently, the Committee decided to refer the issue to the Fifth Committee for its consideration.

B. Videoconference on global opportunities in addressing common challenges in conference services

- 34. At its 526th meeting, on 4 September 2013, the Committee and the representatives of conference services at the United Nations Offices at Geneva, Nairobi and Vienna held a videoconference to discuss the topic of global opportunities in addressing common challenges in conference services. For the past several years, such videoconferences have been opportunities for the Committee to be briefed by the conference managers at the four duty stations about initiatives, possibilities and concerns. Emerging concepts and ideas are being shared with the Committee and the feedback received is being incorporated in the development of policies and practices. A representative of the Economic and Social Commission for Asia and the Pacific introduced the topic, which the Commission had presented as the host of the 2013 International Annual Meeting on Language Arrangements, Documentation and Publications, the primary discussion forum available to conference managers from international organizations around the world. His statement was followed by presentations by the conference managers of the duty stations.
- 35. Several delegations expressed regret that the initiatives presented by the duty stations, including gCMA, the global terminology portal, telecommuting arrangements and the impact of the United Nations treaty body reform process on conference services, had not been included in the report of the Secretary-General on the pattern of conferences (A/68/122) or other documentation for the session. Delegations also wondered whether there were disadvantages to telecommuting, whether staff had been specifically recruited to work under telecommuting arrangements and whether staff had requested such arrangements owing to issues related to work-life balance. Responses to those and other enquiries were provided by the Secretariat orally as well as in writing.
- 36. One delegation pointed out that providing guidance to States parties to United Nations treaty bodies by setting a word limit for their periodic reports would allow the Secretary-General to better plan its documentation workload and allocate resources accordingly.

Chapter V

Matters related to documentation and publications

- 37. At its 524th meeting, on 3 September 2013, the Committee on Conferences considered section III of the report of the Secretary-General on the pattern of conferences, concerning matters related to documentation and publications (see A/68/122, paras. 44-57, and supplementary information, sect. VII), and the report of the Secretary-General on the PaperSmart concept (A/68/123). In 2012, the overall rate of timely submission of documents had been 88 per cent at United Nations Headquarters, 85 per cent at the United Nations Office at Geneva, 60 per cent at the United Nations Office at Vienna and 5 per cent at the United Nations Office at Nairobi.
- 38. The Department of Public Information was continuing to digitize important older United Nations documents and upload them to the Official Document System. Since May 2013, staff of the Department's publishing services had been reassigned to assist with the process. The output of the Department's printing operation had decreased from 300 million page impressions in 2009 to 40 million in 2012. Meeting participants could request the regular delivery of electronic documents, including the *Journal of the United Nations*, through the United Nations eSubscription portal and download them from the Official Document System. All documents continued to be available on paper.
- 39. The Department was increasingly providing documents to participants in official meetings through the PaperSmart approach, which combined a web-based portal with print-on-demand and e-publishing services and portable media solutions.
- 40. Several delegations remained concerned about the late issuance of documents for the Fifth Committee of the General Assembly, and suggested adjusting the wording of the draft resolution in order to improve timely submission.
- 41. A number of delegations expressed satisfaction at the savings achieved through the PaperSmart approach, but were concerned that the system was not fully and equally accessible to speakers of the six official languages of the United Nations. One said that it should be easily accessible to persons with disabilities. Others said that the system did not justify the abandonment of paper documents and meeting records, and that the risks of switching from paper to electronic media should be fully assessed.
- 42. The Committee considered the report of the Secretary-General on the PaperSmart concept (A/68/123), based on lessons learned from almost 500 meetings at which it had been used on a trial basis with the authorization of intergovernmental bodies. A draft of a consolidated text on the PaperSmart concept had been discussed by the Committee without agreement having been reached on the matter. Some delegations felt that the PaperSmart concept should be endorsed, while others preferred to have it continue on a trial basis. There was nevertheless a consensus that the PaperSmart concept should be further developed within existing resources, with some delegations requesting that the Secretariat advance several areas about which they were concerned. Consequently, the Committee decided to refer the issue to the Fifth Committee for its consideration.
- 43. A representative of the Secretariat said that the rate of timely issuance of documents for the Fifth Committee had improved steadily in recent years. However,

a small number of sensitive and lengthy documents were often issued late, resulting in a strong reaction from the Member States. The reasons for late issuance included the fact that no detailed programme of work was available well in advance of the Committee's meetings; the difficulty of staggering the production of long documents; delays encountered by authors in receiving information from field offices; and the need for authors to await the end of the calendar or fiscal year or the results of sessions of other bodies or to take account of changes in inflation or exchange rates before completing their draft reports. The Department for General Assembly and Conference Management had provided the presiding officers of intergovernmental bodies with lists of documents issued for their sessions, including information on the time required for their processing and distribution, so that Member States could provide feedback on its performance. The interdepartmental task force on documentation, led by the Assistant Secretary-General for General Assembly and Conference Management, was working with author departments to ensure their timely issuance.

Chapter VI

Matters related to translation and interpretation

- 44. At its 525th meeting, on 3 September 2013, the Committee on Conferences considered the section of the report of the Secretary-General on the pattern of conferences concerning matters related to translation and interpretation (see A/68/122, paras. 58-65, and supplementary information, sect. VI). As part of the academic outreach programme of the Department for General Assembly and Conference Management, the third conference of universities that had signed memorandums of understanding with the United Nations had been held in Shanghai, China, in April 2013. The language internship programme, in which 90 people participated in 2012, had proved to be a means of expanding the pool of language professionals: since 2007, 30 former interns had passed a competitive language examination and 110 had passed a freelance test that has made them eligible for temporary appointments.
- 45. In response to enquiries from delegates, a representative of the Secretariat said that coaching systems were in place to ensure the transfer of experience to new staff. The statutory retirement age allowed the Department to accurately predict the demographic transition in the language services and schedule competitive language examinations accordingly. The examination system itself was to be remodelled to better reflect the working conditions in the language services and ensure a consistent intake of new recruits.
- 46. All memorandums of understanding with universities were based on the same text, which had not been altered since the start of the outreach programme. Delegations were encouraged to propose universities in their countries in order to improve the representation of Spanish in the outreach programme. The "African project" for the training of language staff was in its infancy, and it was not yet clear which universities had the appropriate structures and teaching staff to become centres of excellence. The scope of the internship programme had been broadened through the participation of students from universities that had signed memorandums of understanding with the United Nations and of candidates who had narrowly failed to pass the competitive language examinations.
- 47. No written criteria dictated whether a document should be translated by in-house staff, short-term staff or contractors, but great care was taken by managers to assign texts, on a case-by-case basis, to translators with the appropriate expertise. The quality of the work done by contractors was managed in-house; more senior reviser posts had been established for that purpose. The use of off-site staff and contractors, made possible through recent technological advances, allowed the Department to preserve quality while making better use of resources through reductions in travel expenditure. Other questions raised by Member States were subsequently answered orally or in writing.
- 48. The Committee did not reach agreement on a proposal by one delegation on the need for the Secretary-General to report to the General Assembly on the criteria used to determine which documents would be translated by staff members and which by external contractors. Consequently, the Committee decided to refer the issue to the Fifth Committee for its consideration.
- 49. One delegation raised a concern that the Secretariat sometimes changed agreed texts of both draft and adopted resolutions beyond purely grammatical and

editorial points of view, and requested the Secretariat to refrain from making any changes of a substantive nature to agreed texts of either draft or adopted resolutions. The delegation also expressed its concern that it was neither efficient nor effective for the Secretariat to review such agreed texts multiple times. All delegations shared those concerns. The representative of the Secretariat explained that documentation workflows, including measures to enhance the efficient and cost-effective management of editing and editorial support processes, were currently being systematically reviewed under the "Languages for the future" initiative.

Reaffirming its resolution 42/207 C of 11 December 1987, in which it requested the Secretary-General to ensure the equal treatment of the official languages of the United Nations,

Having considered the report of the Committee on Conferences for 20131 and the relevant report of the Secretary-General,²

Reaffirming the provisions relating to conference services in its resolutions on multilingualism, in particular resolution 67/292 of 24 July 2013,

Reaffirming also the role of the Fifth Committee of the General Assembly in administrative and budgetary matters,

Recalling its resolution 14 (I) of 13 February 1946 and the role of the Advisory Committee on Administrative and Budgetary Questions as a subsidiary body of the General Assembly,

Calendar of conferences and meetings

- Welcomes the report of the Committee on Conferences for 2013;¹ 1.
- Approves the draft revised calendar of conferences and meetings of the United Nations for 2014 and 2015, as submitted by the Committee on Conferences,³ taking into account the observations of the Committee and subject to the provisions of the present resolution;

- 3. Authorizes the Committee on Conferences to make any adjustments to the calendar of conferences and meetings for 2014 and 2015 that may become necessary as a result of actions and decisions taken by the General Assembly at its sixty-eighth session;
- 4. *Notes with satisfaction* that the Secretariat has taken into account the arrangements referred to in General Assembly resolutions 53/208 A, 54/248, 55/222, 56/242, 57/283 B, 58/250, 59/265, 60/236 A, 61/236, 62/225, 63/248, 64/230, 65/245, 66/233 and 67/237 concerning Orthodox Good Friday and the official holidays of Eid al-Fitr and Eid al-Adha, and requests all intergovernmental bodies to observe those decisions when planning their meetings;
- 5. Requests the Secretary-General to ensure that any modification to the calendar of conferences and meetings is implemented strictly in accordance with the mandate of the Committee on Conferences and other relevant resolutions of the General Assembly;
- 6. *Invites* Member States to include in new legislative mandates adequate information on the modalities for the organization of conferences or meetings;
- 7. Recalls rule 153 of its rules of procedure, and requests the Secretary-General to include the modalities of conferences in resolutions involving expenditure, taking into account the trends of similar meetings, with a view to mobilizing conference services and documentation in the most efficient and cost-effective manner possible;
- 8. Reaffirms the need to tackle the issue of duplications and redundancies in conference servicing, and notes in this regard that the Economic and Social Council decided to consider at a later date the necessity of reviewing its provisional biennial calendar of conferences and meetings in the light of the ongoing intergovernmental consultations on the further strengthening of the Council;

II

A. Utilization of conference-servicing resources

- 1. *Reaffirms* the practice that, in the use of conference rooms, priority must be given to meetings of Member States;
- 2. Calls upon the Secretary-General and Member States to adhere to the guidelines and procedures contained in the administrative instruction for the authorization of the use of United Nations premises for meetings, conferences, special events and exhibits;⁴
- 3. *Emphasizes* that such meetings, conferences, special events and exhibits must be consistent with the purposes and principles of the United Nations;
- 4. *Notes* that the overall utilization factor at the four main duty stations in 2012 was 84 per cent, and that in 2011 it was 85 per cent, as in 2010, which is above the established benchmark of 80 per cent;
- 5. Welcomes the steps taken by those bodies that have adjusted their programmes of work in order to achieve the optimum utilization of conference-servicing resources, and requests the Committee on Conferences to intensify

consultations with the secretariats and bureaux of bodies that underutilize their conference-servicing resources;

- 6. Recognizes that late starts and unplanned early endings seriously affect the utilization factor of the bodies owing to the amount of time lost, and invites the secretariats and bureaux of bodies to pay adequate attention to avoiding late starts and unplanned early endings;
- 7. Notes that the percentage of meetings held by the bodies entitled to meet "as required" that were provided with interpretation services in New York in 2012 was 97 per cent, and that in 2011 it was 96 per cent, as compared with 94 per cent in 2010, and requests the Secretary-General to continue to impress upon such bodies the need to continue to improve the utilization of the conference services provided and to report on the provision of conference services to those bodies through the Committee on Conferences;
- 8. Reiterates its request to intergovernmental bodies to review their meeting entitlements and to plan and adjust their programmes of work on the basis of their actual utilization of conference-servicing resources in order to improve their efficient use of conference services;
- 9. Recognizes the importance of meetings of regional and other major groupings of Member States for the smooth functioning of the sessions of intergovernmental bodies, requests the Secretary-General to ensure that, as far as possible, all requests for conference services for the meetings of regional and other major groupings of Member States are met, and requests the Secretariat to inform the requesters as early as possible about the availability of conference services, including interpretation, as well as about any changes that might occur before the holding of meetings;
- 10. *Notes* that the percentage of meetings held by regional and other major groupings of Member States that were provided with interpretation services at the four main duty stations was 95 per cent in 2012, as compared with 91 per cent in 2011, and requests the Secretary-General to continue to employ innovative means to address the difficulties experienced by Member States owing to the lack of conference services for some meetings of regional and other major groupings of Member States and to report thereon to the General Assembly through the Committee on Conferences;
- 11. Once again urges intergovernmental bodies to spare no effort at the planning stage to take into account the meetings of regional and other major groupings of Member States, to make provision for such meetings in their programmes of work and to notify conference services, well in advance, of any cancellations so that unutilized conference-servicing resources may, to the extent possible, be reassigned to meetings of regional and other major groupings of Member States:
- 12. *Welcomes* the efforts of all users of conference services to inform the Secretariat as early as possible of any cancellation of service requests so as to allow for such services to be smoothly redeployed to other meetings;
- 13. *Notes with satisfaction* that, in accordance with several resolutions of the General Assembly, including resolution 67/237, section II.A, paragraph 13, in conformity with the headquarters rule, all meetings of Nairobi-based United Nations

bodies were held in Nairobi in 2012, and requests the Secretary-General to report thereon to the Assembly at its sixty-ninth session through the Committee on Conferences:

- 14. Notes with concern the recurring underutilization of the conference centre of the Economic Commission for Africa, specifically given the ongoing renovation of its facilities, recognizes the continuing promotional efforts and initiatives of the Commission, and requests the Secretary-General to report thereon to the General Assembly at its sixty-ninth session through the Committee on Conferences:
- 15. Requests the Secretary-General to continue to explore additional means to increase the utilization of the conference centre of the Economic Commission for Africa, including with its partners such as the African Union, and to report thereon, including on the impact of the initiatives of the Commission, to the General Assembly at its sixty-ninth session;
- 16. Also requests the Secretary-General to encourage the heads of entities of the United Nations system to use as a matter of priority, when applicable, the conference centre of the Economic Commission for Africa to ensure greater utilization of the conference facilities;
- 17. Recalls section II.A, paragraph 17, of its resolution 67/237, reiterates its request that the Secretary-General formulate a competitive pricing structure and an appropriate marketing strategy for the conference centre of the Economic Commission for Africa and requests the Secretary-General to report thereon to the General Assembly at its sixty-ninth session;
- 18. *Recognizes* the proactive efforts of the Secretary-General to identify ways to enhance efficiency and effectiveness in conference services;
- 19. Requests the Secretary-General to propose, at the sixty-ninth session of the General Assembly, a comprehensive review of conference servicing, highlighting any duplication or redundancy, with a view to identifying innovative ideas, potential synergies and other cost-saving measures, without compromising the quality of the services;
- 20. Reiterates its request to the Committee on Conferences that it consult those bodies that have consistently utilized less than the applicable benchmark figure of their allocated resources for the past three years, with a view to making appropriate recommendations in order to achieve the optimum utilization of conference-servicing resources, and urges the secretariats and bureaux of bodies that underutilize their conference-servicing resources to work more closely with the Department for General Assembly and Conference Management of the Secretariat and to consider changes to their programmes of work, as appropriate, including adjustments based on previous patterns of recurring agenda items, with a view to making improvements in their utilization factors;
- 21. Requests the Chair of the Committee on Conferences to address a letter to the presiding officers of intergovernmental bodies based at duty stations other than New York if their utilization factor falls below the benchmark of 80 per cent;

B. Impact of the capital master plan, strategy IV (phased approach), on meetings held at Headquarters during its implementation

- 1. Requests the Secretary-General to ensure that the implementation of the capital master plan, including the reassignment of conference-servicing staff to swing spaces, will not compromise the quality of conference services provided to Member States in the six official languages and the equal treatment of the language services, which should be provided with equally favourable working conditions and resources, with a view to receiving the maximum quality of services;
- 2. Requests all meeting requesters and organizers to liaise closely with the Department for General Assembly and Conference Management on all matters relating to the scheduling of meetings to allow maximum predictability in coordinating activities at Headquarters during the construction period;
- 3. Requests the Committee on Conferences to keep the matter under constant review, and requests the Secretary-General to report regularly to the Committee on matters pertaining to the calendar of conferences and meetings of the United Nations during the construction period;
- 4. Requests the Secretary-General to continue to provide adequate information technology support for conference services, within the existing resources of the Department for General Assembly and Conference Management, in order to ensure their seamless operation throughout the implementation of the capital master plan;
- 5. Notes that, for the duration of the implementation of the capital master plan, a part of the conference-servicing staff and information technology resources of the Department for General Assembly and Conference Management has been temporarily relocated to swing spaces, and requests the Secretary-General to continue to provide adequate support, within the existing resources of the Department, to ensure continued maintenance of the information technology facilities of the Department, implementation of the global information technology initiative and delivery of high-quality conference services;
- 6. *Requests* the Secretary-General to consult Member States on initiatives that affect the utilization of conference services and conference facilities;

Ш

Integrated global management

- 1. Notes with appreciation the efforts of the Secretary-General in the context of the integrated global management initiative to establish and implement in the four main duty stations common performance indicators and single information technology systems (such as gData, gMeets, gDoc and gText), and requests the Secretary-General to report thereon to the General Assembly at its sixty-ninth session;
- 2. Reiterates with concern its request that the Secretary-General complete the internal reviews concerning accountability mechanisms and the clear delineation of responsibility between the Under-Secretary-General for General Assembly and Conference Management and the Directors-General of the United Nations Offices at Geneva, Nairobi, and Vienna for conference management policies, operations and resource utilization, and requests the Secretary-General to report thereon to the

General Assembly at its sixty-ninth session, and in this regard recalls section III, paragraph 15, of its resolution 66/233, and section III, paragraph 2, of its resolution 67/237:

- 3. *Notes* the initiatives undertaken in the context of integrated global management aimed at streamlining procedures, achieving economies of scale and improving the quality of conference services, and in this regard stresses the importance of ensuring equal treatment of conference-servicing staff, as well as the principle of equal grade for equal work at the four main duty stations;
- 4. Also notes that the effects of workload-sharing in the context of global document management remain minimal, and requests the Secretary-General to continue to seek ways to promote workload-sharing among the four main duty stations and to report thereon to the General Assembly at its sixty-ninth session;
- 5. *Emphasizes* that the major goals of the Department for General Assembly and Conference Management are to provide high-quality documents in a timely manner in all official languages, in accordance with established regulations, as well as high-quality conference services to Member States at all duty stations, and to achieve those aims as efficiently and cost-effectively as possible, in accordance with the relevant resolutions of the General Assembly;
- 6. *Notes* that the pool of language professionals at duty stations is uneven in terms of language combinations, and requests the Secretary-General to develop recruitment, subcontracting and outreach policies that take full account of these imbalances and to report thereon to the General Assembly at its sixty-ninth session;
- 7. Requests the Secretary-General to ensure that all language services are given equal treatment and are provided with equally favourable working conditions and resources, with a view to achieving the maximum quality of services, with full respect for the specificities of the six official languages and taking into account their respective workloads;
- 8. *Reiterates* the need for the Secretary-General to ensure the compatibility of technologies used in all duty stations and to ensure that they are user-friendly in all official languages;
- 9. *Also reiterates* that the satisfaction of Member States is a key performance indicator in conference management and conference services;
- 10. Requests the Secretary-General to continue to ensure that measures taken by the Department for General Assembly and Conference Management to seek the evaluation by Member States of the quality of the conference services provided to them, as a key performance indicator of the Department, provide equal opportunities to Member States to present their evaluations in the six official languages of the United Nations and are in full compliance with relevant resolutions of the General Assembly, and requests the Secretary-General to report to the Assembly, through the Committee on Conferences, on progress made in this regard;
- 11. Also requests the Secretary-General to continue to explore best practices and techniques in client satisfaction evaluations and to report regularly to the General Assembly on the results achieved;
- 12. *Welcomes* the efforts made by the Department for General Assembly and Conference Management to seek the evaluation by Member States of the quality of

the conference services provided to them, taking into consideration comments and complaints raised by Member States either in writing or during meetings, and requests the Secretary-General to intensify his exploration of innovative ways to systematically capture and analyse feedback from Member States and chairs and secretaries of committees on the quality of conference services and to report thereon to the General Assembly through the Committee on Conferences;

- 13. Requests the Secretary-General to continue to seek evaluation by Member States of the quality of the conference services provided to them, including through the language-specific informational meetings held once a year, ahead of the substantive session of the Committee on Conferences, or any necessary meeting scheduled upon the request of Member States, not to exceed two meetings per year, and to ensure that such measures provide equal opportunities to Member States to present their evaluations in the six official languages of the United Nations and that they are in full compliance with the relevant resolutions of the General Assembly;
- 14. Also requests the Secretary-General to keep the General Assembly and its Committee on Conferences apprised of progress made in achieving integrated global management and to provide accurate and up-to-date information on new initiatives falling under the purview of the Committee;
- 15. Reiterates its concern that the Secretary-General did not include in his report on the pattern of conferences² information about the financial savings achieved through the implementation of the integrated global management projects, as requested in section III, paragraph 4, of its resolution 63/248, in section III, paragraph 12, of its resolution 64/230, in section III, paragraph 14, of its resolution 65/245, in section III, paragraph 14, of its resolution 66/233, and in section III, paragraph 15, of its resolution 67/237, and reiterates its request that the Secretary-General redouble his efforts to include this information in his next report on the pattern of conferences;
- 16. *Notes* the Flextime pilot project initiated by the United Nations Office at Vienna, stresses that the rules and regulations of the United Nations governing human resources issues should be applied uniformly during the implementation of the pilot project, and requests the Secretary-General to report to the General Assembly at its sixty-ninth session on the evaluation of the pilot project, including a recommendation on whether the project should be continued at the United Nations Office at Vienna and further implemented at other duty stations;
- 17. Welcomes the proximity rule as an efficient approach, where feasible, to servicing meetings away from duty stations, and in this regard requests the Secretary-General to strengthen his efforts to realize further savings by rigorously applying the proximity rule to applicable meetings without jeopardizing the quality of services and to report thereon to the Committee on Conferences at its substantive session in 2014:

IV

Matters related to documentation and publications

- 1. *Emphasizes* the paramount importance of the equality of the six official languages of the United Nations;
- 2. Reaffirms its decision in section IV of its resolution 64/230 that all reports adopted by the Working Group on the Universal Periodic Review of the

Human Rights Council shall be issued as documents in all official languages of the United Nations in a timely manner before their consideration by the Council, in accordance with General Assembly resolutions 36/117 A of 10 December 1981, 51/211 A to E, 52/214, 53/208 A to E and 59/265, and requests the Secretary-General to ensure the support necessary to that effect and to report to the General Assembly thereon at its sixty-ninth session;

- 3. Recalls section III, paragraph 5, of its resolution 55/222, and reiterates with concern its request that the Secretary-General ensure strict respect for the rules concerning the simultaneous distribution of documents in all six official languages as regards both the distribution of printed copies and the posting of parliamentary documentation on the Official Document System and the United Nations website;
- 4. *Stresses* that matters related to conference management, including documentation, fall within the purview of the Fifth Committee;
- 5. *Reiterates* the importance of the timely issuance of documents for the Fifth Committee;
- 6. Acknowledges that a multipronged approach is required to find a solution to the perennial difficulties of the late issuance of documents for the Fifth Committee;
- 7. Notes with concern the perennial difficulties of the late issuance of documents for the Fifth Committee, and urges the Secretary-General to ensure the timely presentation of these official documents to the Committee and to find a lasting and sustainable solution to the problem, so as to guarantee the quality of the intergovernmental process;
- 8. *Takes note* of the work done by the interdepartmental task force on documentation chaired by the Department for General Assembly and Conference Management in positively addressing the problem of issuance of documents for the Fifth Committee;
- 9. *Encourages* the Chairs of the Fifth Committee and the Advisory Committee on Administrative and Budgetary Questions to continue to promote cooperation between the two bodies in the sphere of documentation;
- 10. *Welcomes* the continued efforts of the task force to shepherd the submission of documents by the author departments of the Secretariat;
- 11. *Notes* that accurate, timely and consistent information provided by the Secretariat to the Fifth Committee during its informal consultations facilitates the decision-making process in the Committee;
- 12. Notes with satisfaction that all documents submitted on time and within the word limit were processed by the Department for General Assembly and Conference Management within four weeks, and encourages the Secretary-General to sustain that level of performance;
- 13. *Reaffirms* its decision in section III, paragraph 9, of its resolution 59/265 that the issuance of documents in all six official languages on planning, budgetary and administrative matters requiring urgent consideration by the General Assembly shall be accorded priority;

- 14. *Reiterates its request* that the Secretary-General direct all departments of the Secretariat to include the following elements in their reports:
 - (a) A summary of the report;
 - (b) Consolidated conclusions, recommendations and other proposed actions;
 - (c) Relevant background information;
- 15. Also reiterates its request that all documents submitted to legislative organs, including the Committee on Conferences, by the Secretariat and intergovernmental and expert bodies for consideration and action have conclusions and recommendations in bold print;
- 16. Notes with concern that only 55 per cent of the author departments reached the compliance rate of 90 per cent in the timely submission of their reports to the Department for General Assembly and Conference Management, and reiterates its request that the Secretary-General enforce the slotting system more rigorously through a dedicated focus, such as the interdepartmental task force on documentation, and to report thereon to the General Assembly at its sixty-ninth session;
- 17. *Urges* author departments to fully adhere to deadlines in meeting the goal of 90 per cent submission compliance, and requests the Secretary-General to ensure that documents submitted late do not adversely affect the issuance of documents submitted on time and in compliance with set guidelines;
- 18. Reiterates its request in section IV, paragraph 17, of its resolution 67/237 that the Secretary-General provide information on the waiver process for documents that are submitted over the word limit:
- 19. Welcomes the interactions between the Department for General Assembly and Conference Management and the author departments on waiver management, and requests the Secretary-General to ensure continuous efforts in this regard and to report thereon to the General Assembly at its sixty-ninth session;
- 20. *Emphasizes* the role of Member States and their intergovernmental bodies in determining the policies on conference management;
- 21. *Stresses* that proposals to change such policies are to be approved by Member States in their relevant intergovernmental bodies;
- 22. *Notes* that the Official Document System is the official digital repository of the United Nations;
- 23. Requests the Secretary-General to complete the task of uploading all important older United Nations documents onto the United Nations website in all six official languages on a priority basis so that these archives will also be available to Member States through that medium;
- 24. Also requests the Secretary-General to report to the General Assembly at its sixty-ninth session on a detailed time frame for the digitization of all important older United Nations documents, including parliamentary documents, and on options for expediting this process within existing resources;
- 25. *Notes* the pilot project undertaken by the Committee on the Peaceful Uses of Outer Space at the United Nations Office at Vienna to make a transition to

digital recordings of meetings in the six official languages of the Organization as a cost-saving measure;

- 26. *Emphasizes* that the further expansion of this measure would require consideration, including of its legal, financial and human resources implications, by the General Assembly and full compliance with the relevant resolutions of the Assembly, and reiterates its request that the Secretary-General report thereon and on the evaluation of the pilot project referred to in paragraph 25 above to the Assembly at its sixty-ninth session;
- 27. Recalls paragraph 5 of its resolution 49/221 B of 23 December 1994, and stresses that the timely issuance of verbatim records constitutes an important part of the services provided to Member States;

V

Matters related to translation and interpretation

- 1. *Requests* the Secretary-General to redouble his efforts to ensure the highest quality of interpretation and translation services in all six official languages;
- 2. Underlines that the translation of official documents of the Organization must be provided in all required languages and in due time, in full compliance with the rules of procedures of the respective legislative bodies;
- 3. Reiterates its request that the Secretary-General ensure that the terminology used in the translation and interpretation services reflects the latest linguistic norms and terminology of the official languages in order to ensure the highest quality, and in this regard welcomes the development, within existing resources, of a global terminology portal that will be equally accessible to United Nations staff, Member States and civil society;
- 4. Reaffirms section V, paragraph 3, of its resolution 67/237, and reiterates its request that the Secretary-General, when recruiting temporary assistance in the language services, including through the use of international or local contracts, as appropriate, ensure that all language services are given equal treatment and are provided with equally favourable working conditions and resources, with a view to achieving maximum quality of their services, with full respect for the specificities of each of the six official languages and taking into account their respective workloads:
- 5. Reiterates its request that the Secretary-General consider further measures aimed at decreasing the vacancy rates at the United Nations Office at Nairobi, and requests the Secretary-General to report thereon to the General Assembly at its sixty-ninth session;
- 6. Requests the Secretary-General to hold competitive examinations for the recruitment of language staff sufficiently in advance in order to fill current and future vacancies in the language services in a timely manner and to inform the General Assembly at its sixty-ninth session of efforts in this regard;
- 7. Also requests the Secretary-General to continue to improve the quality of translation of documents into the six official languages, giving particular significance to the accuracy of translation;

- 8. Reiterates paragraph 8 of the annex to resolution 2 (I) of 1 February 1946 on the rules of procedure concerning languages, whereby all resolutions and other important documents shall be made available in the official languages and, upon the request of any representative, any other document shall be made available in any or all of the official languages;
- 9. *Stresses* the need to ensure the highest possible quality of contractual translation, and requests the Secretary-General to report on measures to be taken in this regard;
- 10. Reiterates its request that the Secretary-General provide, at all duty stations, adequate staff at the appropriate level, with a view to ensuring appropriate quality control for external translation, with due consideration of the principle of equal grade for equal work;
- 11. Requests the Secretary-General to report to the General Assembly at its sixty-ninth session on the experience, lessons learned and best practices of the main duty stations in performing quality control of contractual translations, including on requirements relating to the number and appropriate level of staff needed to carry out this function;
- 12. *Encourages* the Secretary-General to establish globally standardized performance indicators and costing models aimed at a more cost-effective strategy for the in-house processing of documents, and requests the Secretary-General to submit such information to the General Assembly at its sixty-ninth session;
- 13. Notes with appreciation the measures taken by the Secretary-General, in accordance with its resolutions, to address, among other things, the issue of the replacement of retiring staff in the language services, and requests the Secretary-General to maintain and intensify those efforts, including the strengthening of cooperation with institutions that train language specialists, in order to meet the needs in the six official languages of the United Nations;
- 14. *Notes* the need for energetic measures to avoid a disruptive shortage of applicants and a high turnover rate in the language career fields, particularly where rare language combinations are involved, and requests the Secretary-General to use the appropriate means to improve the internship programme, including through partnerships with organizations that promote the official languages of the United Nations:
- 15. Also notes, in this regard, that recent efforts have led to the signing of memorandums of understanding and collaboration agreements with two universities in Africa and that a memorandum of understanding has been signed with a Latin American institution;
- 16. Welcomes the existing memorandums of understanding between the Organization and 22 universities as a way to strengthen the training of language professionals in order to improve the recruitment of qualified language staff, and requests the Secretary-General to continue his efforts to assess the appropriate number of memorandums of understanding in order to fulfil the needs of the Organization;
- 17. Requests the Secretary-General to make further concerted efforts to promote outreach programmes, such as traineeships and internships, and to introduce innovative methods to increase awareness of the programmes, including

through partnerships with Member States, relevant international organizations and language institutions in all regions, in particular to close the wide gap in Africa and Latin America, and to report to the General Assembly thereon at its sixty-ninth session:

- 18. *Notes* that the "African project" has the aim of establishing postgraduate university programmes in translation, conference interpreting and public service interpreting through centres of excellence on the African continent, and requests the Secretary-General to continue to report on the achievements of this project;
- 19. Requests the Department for General Assembly and Conference Management, in cooperation with the Office of Human Resources Management, to continue to increase its efforts to raise awareness among all Member States about opportunities for employment and internships in the language services at the four main duty stations;
- 20. Notes with appreciation the positive experience with traineeships at Headquarters and at the United Nations Office at Vienna in training young professionals in and attracting them to the translation and interpretation services of the United Nations, while enhancing the pool of qualified language professionals in language combinations that are critical for succession-planning purposes, and requests the Secretary-General to develop the initiative further, to extend it to all duty stations and to report thereon to the General Assembly at its sixty-ninth session:
- 21. Notes that the consolidated lists of individuals and entities subject to sanctions, according to the sanctions committees of the Security Council, have not yet been translated into all six official languages, reiterates its recommendation that the Informal Working Group on Documentation and Other Procedural Questions of the Security Council look further into the practices related to the issuance of these consolidated lists, including their translation, and requests the Secretary-General to report thereon at its sixty-ninth session;
- 22. Requests the Secretary-General to refrain from making any change of a substantive nature to agreed texts of both draft and adopted resolutions, and to report thereon to the General Assembly at its sixty-ninth session, including measures to enhance the quality, efficiency and cost-effectiveness of editing services within existing resources.
