

1. The Vice-Chair-cum-Rapporteur will be a representative of one of the States members on list B.

Item 3

Review of the proposed UNCTAD Biennial Programme Plan for the period 2016-2017

3. In accordance with the relevant United Nations Regulations and Rules Governing Programme Planning, the Working Party will review the draft proposed UNCTAD Biennial Programme Plan for the period 2016–2017. The Working Party will submit its recommendations to the Trade and Development Board for consideration and transmittal of those approved to the Secretary-General of UNCTAD, with a view to their incorporation into the draft proposed UNCTAD Biennial Programme Plan prior to its submission to the Office of Programme Planning, Budget and Accounts and subsequent review by the Committee for Programme and Coordination of the official version issued by the United Nations Secretary-General. For this purpose, the Working Party will have before it a document prepared by the UNCTAD secretariat entitled "Draft proposed UNCTAD Biennial Programme Plan for the period 2016–2017" (TD/B/WP(66)/CRP.1).

Follow-up on evaluations:

(a) Follow-up on recommendations from the external evaluation of UNCTAD subprogramme 1: Globalization, interdependence and development

4. At its sixty-fifth session, the Working Party requested that member States further discuss the conclusions and recommendations contained in the evaluation report on the UNCTAD subprogramme on globalization, interdependence and development (TD/B/WP/252) and in the management response to the evaluation (TD/B/WP(65)/CRP.1). The Working Party decided that the outcome of such discussions would be taken up at its sixty-sixth session.

5. At its sixty-fifth session, the Working Party requested that member States further discuss the recommendations contained in the evaluation report on the UNCTAD programme on science and technology for development (TD/B/WP/234, TD/B/WP(59)/CRP.1) and agreed that regional coordinators would, before the sixty-sixth session of the Working Party, inform the UNCTAD secretariat once consensus had been reached.
