**Statement by the States members of the Collective Security Treaty Organization on the situation in Syria and the surrounding area**

The States members of the Collective Security Treaty Organization are seriously concerned by the development of the situation in Syria and the surrounding area. They call for the achievement of peace, stability, prosperity and progress in that country and in the whole of the Middle East region.

The States members of the Collective Security Treaty Organization consider that external intervention, including by force, is unacceptable and may lead to even greater destabilization of the situation in the country and far beyond the region. In addition, any international intervention in the Syrian conflict which bypasses the United Nations Security Council and violates the Organization's charter is illegitimate.

The States members of the Collective Security Treaty Organization support the efforts of the Russian Federation to achieve a settlement to the Syrian crisis exclusively through political and diplomatic means, and endorse the implementation of the Russian and United States proposals, agreed in Geneva from 12 to 14 September 2013, on measures relating to Syrian chemical weapons, believing that they will help to achieve the overall aim of eliminating all stocks of chemical weapons.

The States members of the Collective Security Treaty Organization believe that the crisis must be resolved as rapidly as possible by the Syrian people themselves, with respect for the sovereignty of the Syrian Arab Republic, an end to violence in the country, and the launch of broad political dialogue between the authorities and the opposition, without preconditions and on the basis of the Geneva communiqué of 30 June 2012.

The States members of the Collective Security Treaty Organization support the efforts to convene an international conference to lay the foundation for reconciliation and normalization in Syria. They condemn decisively any manifestation of terrorism and any violence against a peaceful population, especially on the grounds of religion or nationality, and oppose illegitimate acts aimed at further militarization of the internal conflict in Syria.
