ADMINISTRATION OF THE UNION TERRITORY OF LAKSHADEEP

KAVARATTI 13.8.75

Notification F. No.1/16/72-Genl.

In exercise of the powers conferred by Section 13 of the Opium Act 1878 Act 1 of 1878) read with clause (b) of subsection (1) of section 6 of the Lakshadeep (Laws) Regulation 1965 (No. 8 of 1965), the Administrator, Union Territory of Lakshadeep hereby makes the following rules:

- 1. (a) These Rules may be called the Lakshadeep Opium Rules 1975
 - (b) These Rules shall be applicable to the entire Union Territory of Lakshadeep with effect from the date on which the Rules are published in the Lakshadeep gazette.
- 2. In these Rules, unless there is anything repugnant in the subject or context:
 - (a) "Act" means the Opium Act, 1878 (1 of 1878),

- (b) "Administrator" means the Administrator of the Union Territory of Lakeshadeep;
- (c) "Collector" means the Collector-Cum-Development Commission of Lakshadeep and
- (d) "Section" means a section of the Act.
- 3. Raw opium confiscated under the Act shall be forwarded by the Magistrate ordering confiscation to the Collector and the Collector shall keep in safe custody the raw opium so received from the Magistrate and take action to sell it to the Government of India Opium Factory, Ghazipur.
- 4. Whenever any confiscated opium or other articles has to be destroyed as it is liable to speedy and natural decay, it shall be destroyed with the sanction of the Administrator and under the supervision of such officer as authorized by the Administrator in each case.
- 5. The disposal of confiscated opium or other articles shall be deferred until the period of appeal against the order of confiscation has expired, or, if an appeal is filed against such an order, until the appeal is finally disposed of.
- 6. If an order of confiscation of any opium or other articles be reversed on appeal, such opium or articles or the sale proceedings thereof, after the deduction of the expenditure, if any, incurred in its maintenance or sale, shall be returned to the owner thereof or his duly authorized agent.
- 7. Opium or other articles in respect of which an offence has been committed under the Act and the offender is not known or cannot be found, shall be dealt with under Rule 3 above.
- 8. When any Magistrate convicts an offender under section 9 or when any magistrate or authorized officer orders the confiscation of raw opium or opium mixture under section 12, the Administrator may grant reward in such proportion as he may think fit to any officer of officers or informer of informers who have contributed to the seizure of raw opium or opium mixture, provided the total rewards so granted shall not exceed 50 per cent of the fine imposed or the value of the opium or opium mixture confiscated.

GUJARAT POPPY CAPSULES (AMENDMENT) RULES 1976

Notification No. SH/GH/567/BPA/1272/1180-P

The Gujarat Government Gazette Notification

Bombay-Prohibition Act, 1949

WHEREAS certain draft rules further to amend the Gujarat Poppy Capsules Rules, 1963 1/were published as required by subsection (3) of section 143 of the Bombay Prohibition Act, 1949 (Bombay XXV of 1949) at pages 492 to 494 of the Gujarat Government Gazette, Part IV-B, dated 10 April 1975, under Government Notification, Education and Labour Department, No. GH/SH/220/BPA/1272/28222/P, dated 5 April 1975 inviting objections and suggestions from all persons likely to be affected thereby, till 28 May 1975.

And whereas objections or suggestions received on the said draft have been considered by the Government. NOW, THEREFORE, in exercise of the powers conferred by clause (G) of subsection (2) of section 143 of the Bombay Prohibition Act, 1949. (Bombay XXV of 1949), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Poppy Capsules Rules, 1963, namely:

- 1. These rules may be called the Gujarat, Poppy Capsules (Amendment) Rules, 1976.
- 2. In rule 7 of the Gujarat Poppy Capsules Rules, 1963 (hereinafter referred to as "the said rules"):
 - (1) in subrule (2), item (x) shall be deleted;
 - (2) after subrule (3), the following subrules shall be inserted, namely:
 - "(4) The importer shall obtain from the exporter a certificate in the form prescribed on the reverse of the quadruplicate of the pass in form Poppy-3.
- (5) The importer shall produce before the licensing authority within 48 hours a quadruplicate copy of the pass in Form Poppy 3 from the time of the receipt of the Poppy Capsules consignment under the relevant import pass with the certificate of the exporter".
- (3) In the counterfoil, duplicate and triplicate of Form Poppy 3 appended to the said rules, for condition (2), the following condition shall be substituted, namely:-
 - "(2) This pass shall remain in force for 15 days from the date of issue".
 - 4. In the quadruplicate of form Poppy 3 appended to the said rules:-
 - (i) for condition (2), the following condition shall be substituted, namely:-

- "(2) This pass shall remain in force for 15 days from the date of its issue".
- (ii) after the words "signature and designation of the officer issuing the pass", the following shall be added, namely:

"Reverse of quadruplicate of the Form Poppy 3 Certified that a quantity of kgs. of Poppy capsules duly packed in in bags have been despatched by -

Railway under, receipt No. dated Road on through truck No. of (name of transport agent).

From Station to Station.
