I. INTRODUCTION

1. In its resolution 43/182 of 20 December 1988, entitled "Preparation of an international development strategy for the fourth United Nations development decade", the General Assembly decided to establish an Ad Hoc Committee of the Whole for the Preparation of the International Development Strategy for the fourth United Nations Development Decade, and requested the Ad Hoc Committee to submit a progress report to the General Assembly for consideration at its forty-fourth session, with a view to finalizing the strategy in time for its adoption in 1990. The present report has been prepared in accordance with that request.
2. In the same resolution, the Assembly also invited the Committee for Development Planning and the United Nations Conference on Trade and Development (UNCTAD), the regional commissions and other organizations and specialized agencies of the United Nations system to contribute effectively to the preparatory process for the strategy for providing appropriate input, including relevant documentation, using comprehensive analytical studies.
3. The Assembly also requested the Secretary-General to entrust the Director-General for Development and International Economic Co-operation with the responsibility for overall co-ordination of the contributions of relevant secretariats of the United Nations system to the formulation of the strategy.
4. In its resolution 43/188 of 20 December 1988 on the report of the Trade and Development Board, the General Assembly invited the Board to contribute effectively to the preparations for the international development strategy, in close co-operation with the Ad Hoc Committee of the Whole.
5. In its resolution 43/194 also of 20 December 1988 on the examination of long-term trends in economic and social development, the General Assembly requested the Secretary-General to update, as appropriate, the report on the overall socio-economic perspectives of the world economy to the year 2000, in co-operation with the Secretary-General of UNCTAD, taking into account the debate on the subject in the General Assembly at its forty-third session and in the Economic and Social Council at its second regular session of 1988, as well as the views expressed by the Committee for Development Planning, so as to enhance its utility as one of the background documents for the preparation of the development strategy.
6. In its decision 43/460, the General Assembly decided to convene from 23 to 27 April 1990 a special session devoted to international economic co-operation, in particular to the revitalization of economic growth and development of the developing countries. In the annex to the decision it is noted that the special session could provide useful guidelines for an international development strategy for the 1990s, and it is stressed that the preparatory processes for the special session and for the international development strategy should be complementary and mutually supportive.

ORGANIZATIONAL SESSION

II. ORGANIZATIONAL MATTERS

A. Opening and duration of the session

7. The Committee held its organizational session at United Nations Headquarters from 15 to 17 March 1989. The Committee held two meetings (1st and 2nd).
8. The session was opened by the Under-Secretary-General for Technical Co-operation for Development.
9. At the 1st meeting, on 15 March 1989, the Director of the Office of the Director-General for Development and International Economic Co-operation and the Director of the General Analysis and Policies Division, Department of International Economic and Social Affairs, made introductory statements.

III. ARRANGEMENTS FOR FUTURE SESSIONS

16. At the 1st meeting, opening statements were made by the representatives of the United States of America, the German Democratic Republic (on behalf of the Eastern European States), Japan, Spain (on behalf of the States Members of the United Nations that are members of the European Community), India, Pakistan, Malaysia (on behalf of the States Members of the United Nations that are members of the Group of 77), China, Argentina, Bangladesh, Tunisia, Cuba, Senegal, Guyana and the observer for Switzerland.

17. At its 2nd meeting, on 17 March 1989, the Committee decided to hold its first session from 5 to 16 June and its second session from 11 to 15 September 1989.

18. At the same meeting, the Chairman stated that the Committee might wish to be flexible regarding the use of the time and facilities allocated to it, depending on the contributions to its first session in June 1989 and the progress made at each session. The Ad Hoc Committee was due to receive reports from the various organizations and specialized agencies of the United Nations system, as requested by the General Assembly in resolution 43/182. The Chairman suggested that informal consultations be held by the Vice-Chairmen with the regional groups and that there should be interaction among members of the Ad Hoc Committee, in preparation for the first session. He noted that the Secretariat expected to make a number of documents available prior to the first session, including an update of the Secretary-General's report to the second regular session of the Economic and Social Council of 1988 on information for the preparation and elaboration of an international development strategy (E/1988/67), the report of the Committee on Development Planning, and the report of the Advisory Committee on Co-ordination Task Force on Long-term Development Objectives.

FIRST SESSION

IV. ORGANIZATIONAL MATTERS

A. Opening and duration of the session

19. The Ad Hoc Committee held its first session at United Nations Headquarters from 5 to 9 June 1989. The Committee held five meetings (3rd to 7th meetings). It also held informal consultations.

20. As a result of informal consultations, the Ad Hoc Committee decided at its 7th meeting to conclude its first session on 9 June instead of 16 June, as previously envisaged, with the understanding that the five days saved would be used by the Committee at later meetings.

26. At its 4th meeting, on 6 June, the Committee, on the proposal of the Bureau, decided to designate the Vice-Chairman, Mr. Ahmed Djoghlaïf (Algeria), as Rapporteur.

D. Adoption of the agenda

27. At its 3rd meeting, on 5 June, following statements by the representatives of Algeria, Brazil and France, the Committee revised the provisional agenda contained in document A/AC.232/2 by deleting item 4, "Progress report of the Ad Hoc Committee", and adopted the following agenda.

1. Adoption of the agenda.
2. Election of officers.
3. Preparation of an international development strategy for the fourth United Nations development decade (1991-2000).
4. Future organization of work of the Ad Hoc Committee.

V. PREPARATION OF AN INTERNATIONAL DEVELOPMENT STRATEGY FOR
THE FOURTH UNITED NATIONS DEVELOPMENT DECADE (1991-2000)

28. The Committee considered the question of the preparation of an international development strategy for the fourth United Nations development decade (agenda item 3) at its 3rd to 7th meetings, from 5 to 9 June. It had before it the report of the Secretary-General on the preparation of a strategy (A/AC.232/3).

29. At its 3rd meeting, on 5 June, the Committee heard introductory statements by the Director-General for Development and International Economic Co-operation and the Secretary-General of UNCTAD and the Under-Secretary-General for International Economic and Social Affairs.

30. Also at the 3rd meeting the Chairman noted that the documentation and informal papers submitted by the Secretariat, the specialized agencies, the regional commissions, United Nations bodies and organizations could serve as useful bases for a well-organized discussion of substantive issues. He summarized the contributions and grouped them according to three main concerns:

(a) The overall orientation of the strategy and the likely prospects for development. The submissions from the agencies appeared to hold out dim prospects for the 1990s or an only slightly better performance than in the 1980s. Therefore there was need to explore all the possibilities to make the 1990s a better decade;

(b) The context of a rapidly changing world, for example, globalization of financial markets, advances in science and technology and so on;

(c) The need to give a new orientation to the process of development itself and to address new problems.

31. The Ad Hoc Committee held a general discussion of the item at its 4th to 7th meetings, on 6 to 9 June. Statements were made by the representatives of Malaysia (on behalf of the States Members of the United Nations that are members of the Group of 77), Brazil, the Ukrainian Soviet Socialist Republic (on behalf of the Byelorussian Soviet Socialist Republic, Bulgaria, Czechoslovakia, the German Democratic Republic, Hungary, Poland and the Union of Soviet Socialist Republics), China, Canada, Spain (on behalf of the States Members of the United Nations that are members of the European Community), the Union of Soviet Socialist Republics, the German Democratic Republic, Algeria, the Byelorussian Soviet Socialist Republic, Tunisia, Japan, Sweden (on behalf of the Nordic countries), India, Bangladesh, Jamaica, Guyana, the United States of America, Turkey, Australia and Romania.

32. Statements were also made by the Assistant Director-General for the Economic and Social Policy Department of the Food and Agriculture Organization of the United Nations (FAO). The representatives of the International Labour Organisation (ILO) and of the World Bank also made statements.

33. In a closing statement, the Chairman said useful contributions to the new international development strategy had been made both by Governments and by the Secretariat. Although individual approaches to the strategy might differ, the ensuing convergence of themes in the discussion should enable the Ad Hoc Committee to begin tackling issues related to the preliminary outline of the international development strategy at its session in September.

VI. ARRANGEMENTS FOR FUTURE SESSIONS

34. At its 7th meeting, on 9 June, the Ad Hoc Committee confirmed the dates of its second session (11 to 15 September 1989) and agreed provisionally to hold its third session from 15 to 26 January 1990 and its fourth session from 4 to 15 June 1990. The Committee also recommended that the five working days saved from its first session could be used at a later stage of its work.

35. The Chairman stated that at the September session the Committee could continue its discussions of the broad character and outline of the strategy and leave sectoral and specific issues to a later meeting.

A. Opening and duration of the session

36. The Ad Hoc Committee held its second session at United Nations Headquarters from 11 to 15 September 1989. The Committee held three meetings (8th to 10th). It also held informal consultations.

37. The session was opened by the Chairman. Statements were made by the Director-General for Development and International Economic Co-operation and the Assistant Secretary-General for Development Research and Policy Analysis.

VIII. PREPARATION OF AN INTERNATIONAL DEVELOPMENT STRATEGY FOR
THE FOURTH UNITED NATIONS DEVELOPMENT DECADE (1991-2000)

44. The Committee considered the question of the preparation of an international development strategy for the fourth United Nations development decade (agenda item 2) at its 8th to 10th meetings, on 11, 12 and 15 September 1989. It had before it the note by the Secretariat on preparation of an international development strategy for the fourth United Nations development decade (A/AC.232/5) and the note by the Secretariat on actions required by the Committee arising from resolutions adopted by the Economic and Social Council at its second regular session of 1989 (A/AC.232/L.2).

45. At the 8th meeting, the Assistant Secretary-General for Development Research and Policy Analysis introduced the notes by the Secretariat (A/AC.232/5 and A/AC.232/L.2).

46. The Committee held a general discussion of the item at its 8th to 10th meetings. Statements were made by the representatives of Malaysia (on behalf of the Member States that are also members of the Group of 77), Canada, Bulgaria (also on behalf of the Byelorussian Soviet Socialist Republic, Czechoslovakia, the German Democratic Republic, Hungary, Poland, the Ukrainian Soviet Socialist Republic and the Union of Soviet Socialist Republics), France (on behalf of the European Community), and Denmark (also on behalf of Finland, Iceland, Norway and Sweden), Japan, China and the German Democratic Republic. Statements were also made by the representatives of FAO and the International Monetary Fund (IMF), UNCTAD and the World Food Council (WFC).

47. At the 10th meeting, on 15 September, the Chairman, in a concluding statement, observed that the main substantive task of the session had been to put together a structure or outline for the strategy and for the work connected with it. A number of crucially important presentations on the structure had been proposed, which provided a valid and valuable basis on which consultations had taken place. In the course of those consultations, a strong convergence of views of what would need to be the main issues in the strategy and on the way in which they would need to be treated or structured had emerged.

48. He noted that, owing to a lack of time, it had not been possible to come to a final conclusion, but sufficient material existed on which to build the future work of the Committee. What was needed for the January and June meetings was a set of guidelines on which to structure the Committee's deliberations. There appeared to be broad agreement on the need to begin work in January by focusing first on the goals for the decade of the 1990s. There also seemed to be agreement that specific issues should next be addressed, including the question of accelerating development and other issues such as the alleviation of poverty, the environment, human resources development, sectoral issues, regional questions and special groups of countries. Within these broad categories other subjects would need to be treated, such as finance, trade and technology, agriculture and industry. He noted that he was not attempting to present a comprehensive list but trying to illustrate the approach that should be followed. And finally, there would be the question of follow-up and of implementation.

49. The Chairman hoped that, with this kind of structure in mind, the Committee would be able in January to get to the substance of the matter in the light of the material submitted to it by Governments, the United Nations Secretariat, specialized agencies and other organizations. The process of informal

consultation, which had proved to be so fruitful during the second session, should continue between now and the January session. He would be glad to make himself available to delegations for further consultations that would help in those preparations. In his absence, he should encourage the Vice-Chairmen also to be involved so that at the January meeting enough material would exist on which to organize substantive discussions in order to permit Governments to say what their views were on the key issues of relevance to the 1990s.

IX. ARRANGEMENTS FOR FUTURE SESSIONS

50. At its 10th meeting, the Ad Hoc Committee confirmed the dates of its third session from 15 to 26 January 1990 and the fourth session from 4 to 15 June 1990. It also agreed to recommend to the General Assembly that a fifth session be held for a period of two weeks during the months of August and/or September, if the need should arise (see paras. 20 and 34).

X. ADOPTION OF THE PROGRESS REPORT OF THE AD HOC COMMITTEE

51. At the same meeting, the Committee adopted the draft report (A/AC.232/L.7) on its organizational, first and second sessions as orally amended and authorized the Rapporteur to complete the report for submission to the General Assembly at its forty-fourth session pursuant to paragraph 1 of resolution 43/182.
