Programme budget implications of the draft resolution recommended by the Second Committee (A/39/790/Add.2, para. 7)

Report of the Fifth Committee

- 1. At its 45th meeting, on 11 December 1984, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/39/85) on the programme budget implications of the draft resolution recommended by the Second Committee in paragraph 7 of its report (A/39/790/Add.2). The related report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 2. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary record (A/C.5/39/SR.45).

DECISION OF THE FIFTH COMMITTEE

3. The Fifth Committee decided, by a recorded vote of 89 to 12, with 9 abstentions to inform the General Assembly that, should it adopt the draft resolution contained in paragraph 7 of document A/39/790/Add.2, conference-servicing requirements would arise which are estimated, on a full-cost basis, at \$319,800. The actual additional appropriations that might be required in that respect would be considered in the context of the consolidated statement of conference-servicing requirements to be submitted at a later stage during the current session.
