Declaration by the Ministers for Foreign Affairs of the States members of the Collective Security Treaty Organization on the escalation of tensions in north-western Syria

[Original: Russian]

We express our great concern at the worsening of the situation in north-western Syria as a result of conflict between Government forces and extremist groups linked to Al-Qaida, which has led to loss of life and the forced displacement of thousands of inhabitants of the town of Kassab, most of whom are Armenians.

We strongly condemn the terrorist acts and use of force against the civilian population.

We call for an immediate end to the violence and the safe return of refugees. We are convinced that normal conditions can be restored if outside interference and violence are rejected in favour of a broad-based political dialogue that takes into account the interests of all Syrians, regardless of their ethnicity and religious affiliation.

We urge all interested parties and those involved in the conflict to act in strict compliance with international law in the interests of a rapid end to the bloodshed and the achievement of a peaceful political settlement in Syria on the basis of the Geneva Communiqué of 30 June 2012.
