
Status of submission and review of sixth national communications and first biennial reports

Note by the secretariat

- 1. This note provides information on the status of submission and review of sixth national communications (NC6s) and first biennial reports (BR1s) from Parties included in Annex I to the Convention (Annex I Parties) as at 15 May 2014.
- 2. The Conference of the Parties (COP), by decisions 9/CP.16, paragraph 5, and 2/CP.17, paragraph 13, requested Annex I Parties to submit their NC6s and BR1s, respectively, by 1 January 2014.
- 3. In addition, the COP, by decision 2/CP.17, paragraph 12, adopted the "UNFCCC biennial reporting guidelines for developed country Parties", noting that developed country Parties shall use the reporting guidelines for the preparation of their biennial reports (BRs). By decision 19/CP.18, paragraph 1, it also adopted the common tabular format (CTF) for those guidelines and decided that developed country Parties shall use the format when preparing and submitting their BRs in accordance with decision 2/CP.17.
- 4. By decision 7/CMP.8, the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) requested Annex I Parties that are also Parties to the Kyoto Protocol to include, in their NC6s, the necessary supplementary information required by the "Guidelines for the reporting of supplementary information under Article 7, paragraph 2, of the Kyoto Protocol" (contained in the annex to decision 15/CMP.1).
- 5. At the time of the preparation of this note, the secretariat had received NC6s from all 44 Annex I Parties. A total of 26 Annex I Parties submitted their NC6s before the due date of submission in accordance with decision 9/CP.16, while 18 Annex I Parties submitted their NC6s after that date (12 of which submitted them within six weeks after that date). national communications (NCs) received have been posted on the UNFCCC website.¹ Dates of submission and of scheduled review weeks are presented in the table below.

- 6. At the time of the preparation of this note, the secretariat had received 42 BR1s and 43 BR1 CTFs.² A total of 21 Annex I Parties submitted their BR1s and 19 Annex I Parties submitted their BR1 CTFs before the due date of submission in accordance with decision 2/CP.17, while 21 Annex I Parties submitted their BR1s and 24 Annex I Parties submitted their BR1 CTFs after that date (14 of which submitted their BR1s and 16 of which submitted their BR1s CTFs within six weeks after that date). The BR1s of Kazakhstan and Turkey, as well as the CTF of Turkey, have not been submitted. All BR1s and BR1 CTFs received have been posted on the UNFCCC website.³ Dates of submission of BR1s and BR1 CTFs and dates of scheduled review weeks are presented in the table below.
- 7. The COP, by decision 23/CP.19, adopted the "Guidelines for the technical review of information reported under the Convention related to greenhouse gas inventories, biennial reports and national communications by Parties included in Annex I to the Convention" and decided to use the review guidelines for the review of BR1s and NC6s starting in 2014 and for subsequent reviews of BRs and NCs until any revisions are decided upon by the COP. The review guidelines state that, in the years in which NCs and BRs are submitted together, both will be subject to an in-country review.
- 8. The "Guidelines for review under Article 8 of the Kyoto Protocol" (contained in the annex to decision 22/CMP.1) specify that each NC submitted by an Annex I Party that is also a Party to the Kyoto Protocol shall be subject to a scheduled in-country in-depth review. By decision 9/CMP.9, the CMP requested the secretariat to organize centralized reviews of NC6s for Parties with total greenhouse gas emissions of less than 50 Mt carbon dioxide equivalent (excluding land use, land-use change and forestry) in accordance with their most recent greenhouse gas inventory submission, with the exception of Parties included in Annex II to the Convention, for which the secretariat will organize in-country in-depth reviews.
- 9. As at 12 May 2014, the secretariat had coordinated 15 in-country in-depth reviews of NC6s. In accordance with the provision of decision 9/CMP.9 mentioned in paragraph 8 above, centralized reviews of NC6s were organized by the secretariat for the following 10 Parties: Croatia, Cyprus, Estonia, Latvia, Liechtenstein, Lithuania, Malta, Monaco, Slovakia and Slovenia.
