Corrigendum

1. The first sentence in the *Summary* box on page 1 *should read*:

The Global Programme supports countries to achieve the eradication of poverty and significant reduction of inequalities and exclusion.

2. Paragraph 25 *should read*:

25. The Programme focuses on the overarching priority of poverty eradication and reduction of inequalities and exclusion, and issues that fall within the major priorities below. They are drawn directly from the areas of development work in the strategic plan and based on the criteria in paragraph 13 above:

- (a) eradication of poverty, reduction of inequalities and exclusion;
- (b) the post-2015 development agenda and sustainable development goals;
- (c) inclusive and sustainable development pathways;
- (d) climate and disaster risks;
- (e) inclusive and effective governance; and
- (f) gender equality and women's empowerment.

3. After paragraph 25, insert a new paragraph *reading*:

Eradication of poverty and reduction of inequalities and exclusion

25 bis. The Quadrennial Comprehensive Policy Review identifies poverty eradication as the greatest global challenge and emphasizes the criticality of broad-based, inclusive and equitable growth. Whether it be defining the post-2015 development agenda and advancing the sustainable development goals, achieving a step change in the quality of growth towards a more inclusive model, addressing climate and disaster risks, strengthening institutions and governance to be more inclusive and effective, or promoting gender equality and women's



empowerment, they must all lead to the highest priority of UNDP: the eradication of poverty and reduction of inequality and exclusion. This requires all UNDP programmes and projects to explicitly target those living in poverty (both in relative and absolute terms), and groups that are experiencing the greatest inequalities and persistent exclusion based on sound research and analysis. The Programme will share good practices, lessons learned, and strategies based on the UNDP mandate, and assist in strengthening national capacities and resource mobilization to contribute to poverty eradication and promote active participation of those living in poverty in designing and implementing programmes and policies.

4. Paragraph 37 *should read:*

37. For UNDP, gender equality is centered in international human rights, norms and standards. The fulfillment of women's and men's civil, cultural, economic, political and social rights is central to the human development framework of UNDP and vital to achieving sustainable development. Consequently, advancing gender equality and empowering women are cross cutting components of the strategic plan and are the focus of outcome 4 in particular. The Programme will support organizational efforts to mainstream gender across all outcome areas through the implementation of the gender equality strategy and elaboration and use of institution-wide tools for gender mainstreaming and monitoring progress.

5. Paragraph 51 (a) *should read:*

(a) under 'Global Programmes – global window', \$69.024 million;
