

States parties to the Convention on the Rights of the Child and its two Optional Protocols and related status of submission of reports

Note by the Secretary-General

- 1. The Convention on the Rights of the Child was adopted by the General Assembly in resolution 44/25 of 20 November 1989, and entered into force on 2 September 1990, on the thirtieth day after the date of the deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession.
- 2. As at 15 November 2013, the Convention had been ratified or acceded to by 193 States. A list of States parties, as well as information on the status of the submission of reports by States parties, is to be found in annex I to the present document. Reports of States parties are due two years after the date of the entry into force of the Convention in the State party, and thereafter every five years.
- 3. To date the Committee has received 605 reports pursuant to article 44 of the Convention, including 197 initial, 157 second periodic, 120 third periodic, 107 fourth periodic and 24 fifth periodic reports.
- 4. In addition to its guidelines for reporting (see CRC/C/5, CRC/C/58/Rev.2 and Corr. 1, CRC/C/OPAC/2 and CRC/C/OPSC/2), the Committee on the Rights of the Child also adopted recommendations that are relevant to States parties' reporting obligations. They are included in the introductory part of document CRC/C/46/2. Two of these recommendations provide guidance to States parties that are encountering problems in complying with the strict time frame for submission of reports established by the Convention in article 44, paragraph 1, or the consideration of whose reports has been delayed. These recommendations apply as an exceptional measure taken for one time only. The exceptional measures taken in regard to certain States parties are indicated in the last column of annex I. For more details, please refer directly to the concluding observations adopted by the Committee on the Rights of the Child and issued after its consideration of each State party's reports (CRC/C/country acronym/CO..., series available on www.ohchr.org).

- 5. As at 15 November 2013, the Optional Protocol on the involvement of children in armed conflict has been ratified or acceded to by 152 States. The Optional Protocol entered into force on 12 February 2002. As at the same date, the Optional Protocol on the sale of children, child prostitution and child pornography has been ratified or acceded to by 166 States. It entered into force on 18 January 2002. The two Optional Protocols to the Convention were adopted by the General Assembly in resolution 54/263 of 25 May 2000, and opened for signature and ratification or accession in New York on 5 June 2000. The status of the submission of reports by States parties, is to be found in annexes II and III to the present document. Initial reports are due two years after the date of the entry into force of the Optional Protocols in the State party. Following the submission of the initial comprehensive report, each State party shall include in the reports it submits to the Committee on the Rights of the Child, in accordance with article 44 of the Convention, any further information with respect to the implementation of the Optional Protocol. Other States parties to the Optional Protocol shall submit a report every five years.
- 6. To date the Committee has received 100 reports and one second periodic report under the Optional Protocol to the Convention on the Rights of the Child on the involvement of children in armed conflict, and 85 reports and one second periodic report under the Optional Protocol to the Convention on the Rights of the Child on the sale of children, child prostitution and child pornography.
