SPECIAL SESSION OF THE GENERAL ASSEMBLY TO CONSIDER THE QUESTION OF INTERNATIONAL CO-OPERATION AGAINST ILLICIT PRODUCTION, SUPPLY, DEMAND, TRAFFICKING AND DISTRIBUTION OF NARCOTIC DRUGS, WITH A VIEW TO EXPANDING THE SCOPE AND INCREASING THE EFFECTIVENESS OF SUCH CO-OPERATION

Australia, Austria, Netherlands and United Kingdom of Great Britain and Northern Ireland: draft resolution

The General Assembly,

<u>Desirous of</u> ensuring adequate co-ordination and preparation of arrangements for the holding of a special session of the General Assembly to consider the question of enhanced international co-operation against illicit production, supply, demand, trafficking and distribution of narcotic drugs,

- 1. Requests the Commission on Narcotic Drugs at its eleventh special session, taking into account all relevant resolutions and decisions of the General Assembly at its forty-fourth session, to consider the question of the enhancement of the role of the United Nations in the fight against illicit drugs and to formulate its views thereon for the benefit of the work of the Assembly at its special session;
- 2. Requests the Secretary-General to prepare a report, for submission to the Commission on Narcotic Drugs at its eleventh special session and to the Assembly at its special session, on progress on:
- (a) Development of a United Nations system-wide plan of action on drug abuse control, taking into account the recommendations of the International Conference on
