انتخاب أعضاء اللجنة الاستشارية لمجلس حقوق الإنسان

مذكرة من الأمين العام\*

١- وفقاً لقرار مجلس حقوق الإنسان ١/٥، تتألف اللجنة الاستشارية لمجلس حقوق الإنسان من ١٨ خبيراً يعملون بصفتهم الشخصية وترشحهم الدول الأعضاء في الأمم المتحدة بعد التشاور مع المؤسسات الوطنية لحقوق الإنسان ومنظمات المجتمع المدني، وينتخب المجلس أعضاء اللجنة الاستشارية في اقتراع سري، من قائمة المرشحين الذين تقدم أسماءهم وفقاً للشروط المتفق عليها.

٢- ويكون التوزيع الجغرافي لأعضاء اللجنة الاستشارية على النحو التالي: (أ) خمسة أعضاء من الدول الأفريقية؛ (ب) وخمسة أعضاء من الدول الآسيوية؛ (ج) وعضوان من دول أوروبا الشرقية؛ (د) وثلاثة أعضاء من دول أمريكا اللاتينية ومنطقة الكاريبي؛ (هـ) وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

٣- وانتخب مجلس حقوق الإنسان في دورته السابعة، أعضاء اللجنة الاستشارية البالغ عددهم ١٨ عضواً، حيث انتُخب أربعة منهم لمدة سنة واحدة وسبعة لمدة سنتين وسبعة لمدة ثلاث سنوات.

٤- وأعاد مجلس حقوق الإنسان، في دورته الثالثة عشرة، انتخاب عضوين في اللجنة الاستشارية لمدة ثلاث سنوات أخرى، وانتخب أربعة أعضاء جديداً. وعملاً بمقرر المجلس ١٨/١٢١، تنتهي مدة ولاية الأعضاء السبعة في ٣٠ أيلول/سبتمبر ٢٠١٤.

٥- وسيُنتخب المجلس، في دورته السابعة والعشرين، وفقاً لبرنامج عمله السنوي، أعضاء لشغل المقاعد السبعة الشاغرة في اللجنة الاستشارية. ومن المقاعد السبعة الشاغرة، يعود مقعدان للدول الأفريقية ومقعدان للدول الآسيوية، ومقعد واحد لدول أوروبا الشرقية، ومقعد واحد لدول أمريكا اللاتينية ومنطقة الكاريبي، ومقعد واحد لدول أوروبا الغربية ودول أخرى.

٦- واعتمد مجلس حقوق الإنسان، في دورته السادسة، المقرر ١٠٢/٦ المتعلق بمتابعة تنفيذ القرار ١/٥، الذي حدد فيه الشروط التقنية والموضوعية لتقديم أسماء المرشحين. وتشمل هذه الشروط ما يلي: (أ) الكفاءة والخبرة المشهود بهما في مجال حقوق الإنسان؛ (ب) أن يكون على خلق؛ (ج) والاستقلال والتزاهة.

٧- ويتعين على الدول، عند اختيار مرشحها، أن تطبق المبادئ التوجيهية التالية المتعلقة بالشروط التقنية والموضوعية لتقديم مرشحها:

(أ) الكفاءة والخبرة:

'١' دراسات أكاديمية في مجال حقوق الإنسان أو الميادين المتصلة به و/أو الخبرة مع أداء أدوار قيادية في مجال حقوق الإنسان على المستوى الوطني أو الإقليمي أو الدولي؛

'٢' خبرة طويلة (لا تقل عن خمس سنوات) وإسهامات شخصية في مجال حقوق الإنسان؛

'٣' الدراية بمنظومة الأمم المتحدة وبالولايات والسياسات المؤسسية المتصلة بالعمل في مجال حقوق الإنسان، وكذلك الدراية بالصكوك والمعايير والتخصصات الدولية في مجال حقوق الإنسان؛ ويجذب الإلمام بالنظم القانونية والحضارية المختلفة؛

'٤' إجادة لغة واحدة على الأقل من لغات الأمم المتحدة الرسمية؛

'٥' توافر الوقت الكافي لأداء عمل اللجنة الاستشارية على نحو فعال، بحضور دورات اللجنة والاضطلاع بالأنشطة التي تصدر بها تكليفات بين الدورات كذلك؛

(ب) أن يكون على خلق؛

(ج) الاستقلال والتمتع بالحرية: يستبعد الأفراد الذين يشغلون مناصب صنع القرارات في الحكومة أو أية منظمات أو كيانات أخرى قد يترتب على تقلدها تعارض في المصالح مع المسؤوليات الأساسية للدولة؛ ويعمل أعضاء اللجنة الاستشارية المنتخبون بصفتهم الشخصية؛

(د) اعتبارات أخرى: يجب احترام مبدأ عدم الجمع في آنٍ واحد بين عدة مهام في مجال حقوق الإنسان.

- ٨- وعلى مجلس حقوق الإنسان أن يولي الاعتبار الواجب للتوازن بين الجنسين والتمثيل المناسب للنظم القانونية والحضارية المختلفة عند انتخاب أعضاء اللجنة الاستشارية.
- ٩- وعملاً بأحكام الفقرة ٧١ من قرار مجلس حقوق الإنسان ١/٥، تُقفل قائمة المرشحين قبل شهرين من تاريخ الانتخاب، وتُتيح الأمانة قائمة المرشحين والمعلومات ذات الصلة بهم للدول الأعضاء والجمهور قبل شهر على الأقل من تاريخ الانتخاب.
- ١٠- وفي ١٦ نيسان/أبريل ٢٠١٤، وجهت أمانة مجلس حقوق الإنسان مذكرة شفوية إلى المنسقين الإقليميين المعنيين، تحث فيها على اقتراح أسماء مرشحين وتوضح أن الموعد النهائي لتقديم أسماء المرشحين هو ١٦ حزيران/يونيه ٢٠١٤، وقد مُدِّد فيما بعد<sup>(١)</sup>.
- ١١- وحتى ٢٧ حزيران/يونيه ٢٠١٤، تلقت الأمانة أسماء ستة مرشحين لانتخابات عام ٢٠١٤ لاختيار أعضاء اللجنة الاستشارية من حكومات باكستان، وجمهورية كوريا، وغواتيمالا، وفرنسا، والمغرب، ونيجيريا.
- ١٢- وترد أدناه قائمة بالترشيحات؛ وترد بيانات السير الذاتية للمرشحين في المرفق.

Mr. Soofi is a leading lawyer from Pakistan practicing before the Supreme Court and is also a senior partner of law firm with offices in both Lahore and Islamabad. He served as Federal Minister for Law, Justice & Parliamentary Affairs and Human Rights during caretaker setup in 2013. He is also the founding President of Research Society of International Law, the only think tank of international law in Pakistan that is dedicated to activities for lawyers, journalists and Government officials for improving capacity and awareness about legal commitments of Pakistan under various treaties and conventions.

Mr Soofi acted as an expert from Pakistan and to provide country report that became part of the ICRC Customary Study on IHL. He has done extensive work for improving legislation in Pakistan relating to HR and IHL. In this regard Mr. Soofi and his team carried out a one volume comprehensive comparison of Pakistan's entire legislation with the Geneva Conventions, Additional Protocols and the Rome Statute.
