<u>Programme of work of the Special Committee against</u> <u>Apartheid</u>

The General Assembly,

Having considered the report of the Special Committee against Apartheid, 1/

- 1. <u>Commends</u> the Special Committee against <u>Apartheid</u> for its work in the discharge of its responsil ities in promoting international action against <u>apartheid</u>;
- 2. <u>Takes note</u> of the report of the Special Committee and endorses its recommendations relating to its programme of work;

- 3. <u>Authorizes</u> the Special Committee, in accordance with its mandate and acting as a focal point for the international campaign against <u>apartheid</u> and with the support services of the Centre against <u>Apartheid</u> of the Secretariat:
- (a) To continue monitoring closely the situation in South Africa and the actions of the international community regarding the imposition and implementation of sanctions and other restrictive measures and their impact on apartheid South Africa:
- (b) To continue mobilizing international action against <u>apartheid</u>, <u>inter alia</u>, through collation, analysis and dissemination of information, and liaison with non-governmental organizations and relevant individuals and groups able to influence public opinion and decision-making, and through hearings, conferences, consultations, missions, publicity and other relevant activities;
- 4. Appeals to all Governments, intergovernmental and non-governmental organizations to increase their co-operation with the Special Committee in the discharge of its mandate;
- 5. Requests all United Nations bodies, organs and agencies to co-operate with the Special Committee and the Centre against Apartheid of the Secretariat in their activities in order to ensure consistency and improve co-ordination and greatest use of available resources in the implementation of the relevant resolutions of the General Assembly and the Security Council;
- 6. Requests Governments and organizations to provide financial and other assistance for the special projects of the Special Committee and to make generous contributions to the Trust Fund for Publicity against Apartheid;
- 7. Appeals to all Governments, intergovernmental organizations, information media, non-governmental organizations and individuals to co-operate with the Centre against Apartheid and the Department of Public Information of the Secretariat in their activities relating to apartheid and, in particular, in disseminating information on the situation in South Africa in order to mitigate the effects of the restraints on the press in South Africa and to counteract South African propaganda effectively;
- 8. <u>Decides</u> to make a special allocation of 430,000 dollars to the Special Committee for 1990 from the regular budget of the United Nations to cover the cost of special projects to be decided upon by the Committee.
