**Sixty-ninth year****Letter dated 20 October 2014 from the Chargé d'affaires a.i. of the  
Permanent Mission of Cyprus to the United Nations addressed to  
the Secretary-General**

Upon instructions from my Government, I enclose herewith two separate annexes recording the infringements of international air traffic regulations and violations of the national airspace of the Republic of Cyprus by Turkey (see annex I) and the illegal use of closed ports by Turkish warships during the month of August 2014 (see annex II). It should also be noted that Turkish commercial aircrafts systematically use the illegal Tymvou airport. I have the honour to draw your attention to the systematic infringements by Turkey of the sovereignty and territorial integrity of the Republic of Cyprus through blatant violations of international law, in a way that seriously jeopardizes safety and security in the greater region.

I should be grateful if you would have the present letter and its annexes circulated as a document of the General Assembly, under agenda item 42, and of the Security Council.

26 May-October	One Turkish research/survey vessel violated the territorial waters of the Republic of Cyprus and illegally used the closed port of Ammochostos.
24 July-15 August	One C-141 Turkish tank landing ship violated the territorial waters of the Republic of Cyprus and illegally used the closed port of Kerynia.
24 July-15 August	One C-142 Turkish tank landing ship violated the territorial waters of the Republic of Cyprus and illegally used the closed port of Kerynia.
14-19 August	One AG-6 (P-306) Turkish net laying ship violated the territorial waters of the Republic of Cyprus and illegally used the closed port of Ammochostos.
29 August-October	One S-358 Turkish submarine violated the territorial waters of the Republic of Cyprus and illegally used the closed port of Kerynia, while participating in naval exercises of the occupation forces.
