Draft resolution E/2014/L.28: Programme of Action for the Least Developed Countries for the Decade 2011-2020

1. **Mr. Çubukcu** (Observer for Turkey), introducing the draft resolution, said that his Government remained willing to host a mid-term review of the implementation of the Programme of Action.
2. **The President** said that the draft resolution had no programme budget implications.
3. *Draft resolution E/2014/L.28 was adopted.*
4. **Mr. Mitra** (Bangladesh) said that the least developed countries welcomed the adoption by consensus of the draft resolution, which was both substantive and action-oriented. He encouraged the Council members to collaborate to ensure the successful implementation of the Istanbul Programme of Action. His delegation was confident that the attention devoted by developed and developing countries alike to the causes of the least developed countries would continue and indeed increase, allowing the world's most marginalized countries to experience development.
5. **The President** said he took it that the Council wished to withdraw the draft resolution contained in document E/2014/L.25.
6. *It was so decided.*
7. *Draft resolution E/2014/L.25 was withdrawn.*

Draft resolution E/2014/L.29: Human settlements

8. **Mr. Maturu** (Observer for Kenya), introducing the draft resolution, said that over half of the world's population lived in urban areas, with the trend expected to increase in coming years. It was important to implement measures to address the challenges of urbanization as well as those issues that would affect human settlements in general. Adopting the draft resolution was of crucial importance, especially with

the approach of the United Nations Conference on Housing and Sustainable Urban Development (Habitat III).

9. **The President** said that the draft resolution had no programme budget implications.
10. *Draft resolution E/2014/L.29 was adopted.*
11. **The President** said he took it that the Council wished to withdraw the draft resolution contained in document E/2014/L.20.
12. *It was so decided.*
13. *Draft resolution E/2014/L.20 was withdrawn.*
