Appointment of members of the Committee on Contributions

Note by the Secretary-General

1. As indicated in document [A/69/102/Rev.1](#), the General Assembly will be required, at its current session, to appoint six persons to fill the vacancies that will occur in the membership of the Committee on Contributions, for a three-year term of office beginning on 1 January 2015.
2. The following persons have been nominated by their respective Governments for appointment or reappointment:

 - Kunal Khatri (United Kingdom of Great Britain and Northern Ireland)
 - Nikolay Lozinskiy (Russian Federation)
 - Henrique da Silveira Sardinha Pinto (Brazil)

 - Dae-jong Yoo (Republic of Korea)
3. There is a further existing vacancy in the Committee for a term of office expiring on 31 December 2016,¹ and the Government of Libya has nominated Mohamed A. Elshakshuki to fill the vacancy beginning on the date of adoption of the decision by the General Assembly and ending on 31 December 2016.
