The President: As members are aware, there is still one vacancy on the Court to be filled. The Assembly will now proceed to vote with respect to the remaining vacancy.

I should like to remind representatives that, pursuant to rule 88 of the rules of procedure,

“After the President has announced the beginning of voting, no representative shall interrupt the voting except on a point of order in connection with the actual conduct of the voting.”

We shall now begin the voting process. Ballot papers will now be distributed.

All the candidates whose names appear on the ballot paper are eligible. I would like to remind delegations that the name of only one candidate should be marked with a cross. Any ballot paper on which more than one name is marked will be considered invalid. Votes may be cast only for those whose names appear on the ballot papers.

At the invitation of the President, Ms. Mansouri (Algeria), Ms. Mohd Salleh (Brunei Darussalam), Mr. Ona Garcés (Ecuador), Mr. Stefanik (Poland), Ms. Lyngdorf (Sweden) and Mr. do Carmo Vieira (Timor-Leste) acted as tellers.

A vote was taken by secret ballot.

The meeting was suspended at 10.30 a.m. and resumed at 11.05 a.m.

a term of office beginning on 6 February 2015, Ms. Susana Ruiz Cerutti obtained an absolute majority of votes.”

We therefore do not have a match between our decision here and that of the Security Council. As a result of the voting that has taken place independently in the General Assembly and the Security Council, no candidate has obtained an absolute majority in both

bodies. In accordance with the provisions of Article 11 of the Statute of the Court, it will therefore be necessary to hold another meeting to fill the remaining vacancy.

I propose that the present meeting be adjourned and the 41st meeting held immediately to vote on the remaining vacancy.
