Annotations

1. Election of officers

Rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council stipulates that, at the commencement of the first meeting of a regular session, the Commission shall elect from among the representatives of its members a Chair, one or more Vice-Chairs and such other officers as may be required. Following the established practice, the Commission shall elect a Chair and four Vice-Chairs and also designate one of the Vice-Chairs as Rapporteur.

In subparagraph (c) of its decision 2002/210, the Economic and Social Council decided that, immediately following the closure of a regular session, the Commission for Social Development would hold the first meeting of its subsequent regular session for the sole purpose of electing the new Chair and other members of the Bureau. In its resolution 2014/3, the Council reaffirmed that the officers elected to the Bureau of the Commission should continue to be elected for a term of office of two years, in parallel with the review and policy cycle of 2015-2016. Accordingly, the Commission held the first meeting of its fifty-third session on 21 February 2014, immediately following the closure of the fifty-second session, and elected by acclamation Simona Mirela Miculescu (Romania) as Chair and Janina Hasse-Mohsine (Germany), Amina Smaila (Nigeria) and Ana Peña (Peru) as Vice-Chairs.

Subsequently, the Asia-Pacific States nominated Do Hung Viet (Viet Nam) to represent the regional group on the Bureau as Vice-Chair. In addition, following the resignation of Ms. Peña, the Latin American and Caribbean States nominated Ronnie Habich (Peru) to replace her on the Bureau as Vice-Chair. At the opening meeting of the fifty-third session of the Commission, on 4 February 2015, the two nominees will be elected as Vice-Chairs. At the same meeting, the Commission will designate one of its Vice-Chairs as also having rapporteurial responsibilities.

2. Adoption of the agenda and other organizational matters

Rule 7 of the rules of procedure requires that, after the election of its officers at the beginning of each session, the Commission shall adopt the agenda for that session on the basis of the provisional agenda. The provisional agenda and documentation for the fifty-third session of the Commission were approved by the Economic and Social Council in its decision 2014/217.

The proposed organization of work of the Commission at its fifty-third session (see annex I) has been prepared pursuant to relevant decisions of the General Assembly and the Economic and Social Council to facilitate the consideration of agenda items within the time frame available and in accordance with the conference services allocated to the Commission. The timetable should be considered tentative and indicative: if the Commission completes its consideration of an item ahead of schedule, it may wish to proceed immediately to the next item.

The Commission is scheduled to meet from Wednesday, 4 February, to Friday, 13 February 2015. Arrangements have been made to hold morning and afternoon meetings during the session: morning meetings will be held from 10 a.m. to 1 p.m. and afternoon meetings from 3 p.m. to 6 p.m.

3. Follow-up to the World Summit for Social Development and the twenty-fourth special session of the General Assembly

In accordance with General Assembly resolution 55/46 on the implementation of the outcome of the World Summit for Social Development and of the twenty-fourth special session of the Assembly entitled "World Summit for Social Development and beyond: achieving social development for all in a globalizing world", the Commission will undertake regular assessment of the implementation of the Copenhagen commitments and the further initiatives adopted at Geneva.

In its resolution 2014/3, the Economic and Social Council decided that the priority theme for the 2015-2016 review and policy cycle would be "Rethinking and strengthening social development in the contemporary world". The Commission will review the theme at its fifty-third session in 2015. The Commission will have before it the report of the Secretary-General on the priority theme.

The Commission, at its fifty-third session, will be called upon to nominate a number of new members and to renominate some existing members of the Board. The Council will be called upon to confirm those nominated in 2015.
