1. The amounts so appropriated above by the General Assembly were apportioned among Member States in accordance with the provisions laid out in section III.A to G below.

B. Apportionment of the costs of peacekeeping operations

2. On 11 December 1973, the General Assembly adopted resolution 3101 (XXVIII) on the financing of the United Nations Emergency Force (UNEF II). Under the resolution, the membership of the United Nations was divided into four groups: (a) the States permanent members of the Security Council; (b) specifically named economically developed Member States that were not permanent members of the Security Council; (c) economically less developed Member States; and (d) economically less developed Member States that were specifically named. The resolution also specified the amounts of the total appropriation to be distributed among each of the four groups.

3. The four amounts specified in the resolution were established by a methodology intended to produce the following results: the Member States in group D would pay 10 per cent of the assessment rates established for the regular budget, those in group C would pay 20 per cent, those in group B would pay 100 per cent and those in group A would pay 100 per cent plus the amounts not otherwise apportioned.

4. Within each group, according to the terms of resolution 3101 (XXVIII), the amount appropriated was to be distributed among the respective group members on the basis of the relative weight of each group member's regular rate of assessment in relation to the total rate for the group.

5. The scheme for the apportionment of costs set out in resolution 3101 (XXVIII) continued to be applied since that time for all peacekeeping operations financed through assessed contributions, including UNPROFOR. The composition of the four groups of Member States changed repeatedly since 1973, however, as a result of the admission of new Member States and the decisions contained in the various General Assembly resolutions, the latest of which was resolution 43/232 of 1 March 1989, as adjusted by resolutions 44/192 B of 21 December 1989, 45/269 of 27 August 1991, 46/198 A of 20 December 1991, 47/218 A of 23 December 1992, 49/249 A of 20 July 1995 and 49/249 B of 14 September 1995, 50/224 of 11 April 1996, 51/218 A to C of 18 December 1996 and its decisions 48/472 A of 23 December 1993 and 50/451 B and 50/471 A of 23 December 1995. The percentage shares shown in section III.A to G below demonstrate the results of the application of the scheme, using the scale of assessments for the period 1995-1997, adopted by the Assembly in its resolution 49/19 B of 23 December 1994.

II. Basis for credits in respect of the Tax Equalization Fund

6. Under regulation 3.2 (e) of the Financial Regulations of the United Nations, adjustments shall be made to the assessment of Member States in respect of Members' credits in the Tax Equalization Fund estimated to be not required to meet charges for tax refunds for the financial periods below:
