Overall orientation

- 4.1 General and complete disarmament under strict and effective international control remains the ultimate goal of all efforts exerted in the field of disarmament. The main responsibilities for disarmament lie with Member States. The United Nations, in accordance with its Charter, has a central role and primary responsibility in supporting Member States in this area.
- 4.2 The mandate for the programme is derived from the priorities established in relevant General Assembly resolutions and decisions in the field of disarmament, including the Final Document of the Tenth Special Session of the General Assembly, the first special session devoted to disarmament (resolution S-10/2). The programme is also guided by the United Nations Millennium Declaration (resolution 55/2). Weapons of mass destruction, in particular nuclear weapons, continue to be of primary concern to the Organization owing to their destructive power and the threat that they pose to humanity. Conventional weapons, small arms, light weapons, landmines and cluster munitions have received increased attention from the international community.
- 4.3 Within the Secretariat, substantive responsibility for the programme is vested in the Office for Disarmament Affairs. The strategy of the Office in meeting the programme's objectives is designed around five subprogrammes and is based on its role in and responsibility for facilitating and encouraging, as appropriate, measures aimed at disarmament and non-proliferation in all its aspects and at all levels, in particular weapons of mass destruction. The Office will continue to assist Member States in promoting, strengthening and consolidating multilaterally negotiated principles

- and norms in all areas of disarmament and non-proliferation in all its aspects. It will support efforts of Member States in the areas of disarmament and non-proliferation in all its aspects in order to promote international peace and security and contribute to global efforts against terrorism. The Office will enhance its capacity for more in-depth analysis, keeping track of developments in those areas, and provide Member States with timely and practical advice, as requested.
- 4.4 The Office will assist States in increasing understanding of the relationship between disarmament and development. It will promote transparency, based on the principle of undiminished and increased security for all, and confidence-building measures in the field of disarmament. Through its regional centres for peace and disarmament, the Office will assist Member States in promoting regional approaches to disarmament and non-proliferation in all its aspects and regional and international peace and security.
- 4.5 The Office will seek to achieve the objectives of the programme by facilitating the process of multilateral deliberation and negotiation. This will include providing substantive organizational support to the First Committee, the Disarmament Commission and other subsidiary bodies of the General Assembly, the Conference on Disarmament and its subsidiary bodies, review conferences and other meetings of parties to multilateral disarmament agreements as required by States parties to such instruments and entities, as well as to expert groups mandated by the General Assembly.
- 4.6 The Office will continue to be a source of impartial and factual information on disarmament and related security matters for Member States, organizations of the United Nations system and intergovernmental, regional and non-governmental organizations and will expand its educational outreach programmes. Training and advisory services will continue to be provided, through the United Nations Disarmament Fellowship, Training and Advisory Services Programme and the United Nations Institute for Disarmament Research, to Member States, in particular developing countries, to enable them to enhance their expertise in disarmament so that they can participate more effectively in international deliberating and negotiating forums.
- 4.7 The continued implementation of a gender plan of action aimed at raising awareness of gender mainstreaming in disarmament affairs will continue to be an integral part of the activities of the programme.

Overview of resources

- 4.8 The overall resources proposed for the biennium 2016-2017 for this section amount to \$24,572,800 before recosting, reflecting a net decrease of \$806,900 (or 3.2 per cent) compared with the appropriation for 2014-2015. Resource changes result from four factors, namely: (a) technical adjustments relating to the removal of non-recurrent requirements; (b) new or expanded mandates and inter-component/departmental changes; (c) resource changes in line with General Assembly resolution 69/264 (further reductions); and (d) resource changes in line with General Assembly resolution 69/264 (efficiencies). The proposed reductions will not have an impact on full and effective mandate implementation.
- 4.9 Pursuant to General Assembly resolution 46/37 B, the Secretary-General established the United Nations Standing Advisory Committee on Security Questions in Central Africa, designating the then Centre for Disarmament Affairs of the Department of Political Affairs to serve as the secretariat of the Committee. In order to avoid duplicative peace and security mechanisms in the subregion, the Secretary-General proposed the transfer of the secretariat functions of the Standing Advisory Committee from the Office for Disarmament Affairs to the Department of Political Affairs in May 2011 following the establishment of the United Nations Regional Office for Central Africa. The transfer was conveyed to the members of the Security Council (see para. 7 of

S/2011/704, dated 10 November 2011) and to States members of the Committee (see A/67/359, A/67/410 and resolution 67/70). Individual letters were also sent to all States members of the Committee. In the light of this, the proposed requirements for the biennium 2016-2017 also reflect the redeployment of resources associated with the transfer of responsibilities for the convening of the ministerial and other meetings of the Committee amounting to \$324,400 in subprogramme 1 from the Office for Disarmament Affairs to the Department of Political Affairs.

- 4.10 Resource changes in line with General Assembly resolution 69/264 reflect a proposal aimed at freezing recruitment against established posts, as well as reductions in non-post resources that are anticipated in 2016-2017.
- 4.11 The proposed reductions will be influenced by the future impact of the deployment of Umoja (Foundation and Extension 1) by the end of 2015. As it is too early to determine the specific future impact of Umoja, the proposed reductions, while firm in financial terms, are flexible in operational terms. The flexibility means that the specific composition of the post freezes, and the reorganization of functions and roles as a result of the freezing of posts, will be determined only during 2016-2017, when the impact of Umoja becomes more clear. Proposed reductions in non-post resources, including travel of staff, reflect the anticipated impact of approved standards of accommodation for air travel, as well as further efficiencies that the Office for Disarmament Affairs plans to bring about in 2016-2017.
- 4.12 The distribution of resources is reflected in tables 4.3 to 4.5.

Technical adjustments

4.13 Resource changes reflect the removal of non-recurrent requirements totalling \$1,455,500, relating to: (a) the travel of 20 experts and the secretary of the group of experts, as well as a consultant, to provide technical and substantive support to the Office for Disarmament Affairs, pursuant to General Assembly resolution 68/243; and (b) the unforeseen requirements of the Secretary-General in support of the United Nations mission to investigate alleged use of chemical weapons in Syria.

New mandates and inter-component/departmental changes

4.14 Resources in the amount of \$837,700 have been provided in support of new mandates associated with the convening of the group of governmental experts to review the operation and further development of the United Nations Report on Military Expenditures and the group of governmental experts to prepare a report on the continuing operation of the United Nations Register of Conventional Arms that takes into account the work of the Conference on Disarmament, as well as the convening of the Sixth Biennial Meeting of States to Consider the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects, pursuant to General Assembly resolutions 68/23, 68/43 and 69/51. The proposed requirements also reflect the redeployment of resources associated with the transfer of responsibilities for the convening of the ministerial and other

meetings of the Standing Advisory Committee on Security Questions in Central Africa, amounting to \$324,400, in subprogramme 1 from the Office for Disarmament Affairs to the Department of Political Affairs.

Resource changes in line with General Assembly resolution 69/264 (further reductions)

4.15 Resource changes of \$142,000 are proposed in line with General Assembly resolution 69/264, under non-post resources, including: (a) general temporary assistance (\$56,300); (b) consultants (\$50,000); and (c) travel of staff (\$35,700), resulting from the anticipated impact of the approved standards of accommodation for air travel.

Resource changes in line with General Assembly resolution 69/264 (efficiencies)

4.16 Resource changes of \$47,100 are proposed under the programme support component in line with General Assembly resolution 69/264, including posts (\$33,700), as a result of freezing recruitment against established posts, and non-post items (\$13,400), owing to reduced requirements for miscellaneous services and supplies.

Extrabudgetary resources

- 4.17 Under extrabudgetary resources, a revised amount of \$24,692,100 is estimated for 2014-2015, including \$4,824,200 for the United Nations Institute for Disarmament Research (UNIDIR), owing mainly to an increase in contributions under the newly established sub-account to support the implementation of the Arms Trade Treaty and the Programme of Action on Small Arms within the Trust Fund for Global and Regional Disarmament Activities.
- 4.18 For the biennium 2016-2017, a total amount of \$25,606,200, including \$4,872,400 for UNIDIR, is anticipated. The projected increase is due to additional contributions expected under: (a) the Trust Fund for Global and Regional Disarmament Activities, for the Vienna office; (b) the Trust Fund for the United Nations Regional Centre for Peace and Disarmament in Africa; and (c) the newly established sub-account to support the implementation of the Arms Trade Treaty and the Programme of Action on Small Arms within the Trust Fund for Global and Regional Disarmament Activities.

Other information

4.19 Pursuant to General Assembly resolutions 64/259, 67/253 and 68/264, the Office for Disarmament Affairs continues to take steps to promote accountability by promoting personal accountability among managers and staff, reviewing and revising processes to improve efficiency in programme delivery, and recognizing the important role of oversight bodies and the efficient implementation of accepted recommendations. Through close monitoring and oversight, the Office ensures that managers exercise their delegated human resources management authority in line with General Assembly mandates and priorities, consistent with policies and in an efficient and effective manner to facilitate the achievement of programmatic objectives. In order to strengthen personal accountability at all levels, the Office has worked to ensure that the performance appraisal system is functioning effectively. Staff members undergo training to ensure a smooth transition to Inspira-based performance management by setting milestones and closely monitoring the timely completion of each performance cycle. The Office continues to encourage staff to avail themselves of training opportunities and has increased its offerings of training courses in the areas of ethics, integrity and professional development. These include the course entitled "Working together: professional ethics and integrity", the Leadership Development Programme, the Management Development Programme and the course entitled "Competency-based selection and interviewing skills". In order to improve accountability and efficiency in programme delivery, the Office has implemented a system for the

- electronic processing of the parliamentary documentation falling under its purview and is relying increasingly on available information technology tools and options to streamline its activities and procedures. The Office embraces the Organization's management reform agenda and is in compliance with the Secretariat's digital road map and the Secretariat-wide information and communications technology (ICT) strategy.
- 4.20 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation would amount to \$24,200, consisting of \$18,000 for a total of 1.0 workmonth of Professional staff funded from the regular budget and \$6,200 for a total of 0.5 workmonth of Professional staff funded from extrabudgetary resources.
- 4.21 The Office carries out its activities in cooperation with other departments and offices of the Secretariat, entities of the United Nations system and entities external to the United Nations, including treaty organizations, intergovernmental, interregional, regional and national organizations, non-governmental organizations and academic communities. Such cooperation includes the preparation of reports, participation in meetings, briefings, technical and substantive support and sharing of information and experience.
- 4.22 The issuance of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 4.6 and as distributed in the output information for each subprogramme.

A. Policymaking organs

Resource requirements (before recosting): \$34,500

4.23 The Conference on Disarmament was set up in accordance with paragraph 120 of the Final Document of the Tenth Special Session of the General Assembly (S-10/2) as the single multilateral disarmament negotiating forum of the international community. Following the expansions of its membership in 1996 and 1999, the Conference is open to the five nuclear-weapon States and 60 other States, including key militarily significant States. In addition, every year, some 40 non-member States are invited, at their request, to participate in its work. The Conference on Disarmament conducts its work by consensus, adopts its own rules of procedure, rotates its presidency among all its members every four weeks, adopts its own agenda taking into account the recommendations made to it by the General Assembly and the proposals presented by the members of the Conference, and submits a report to the General Assembly annually, or more frequently, as appropriate. The Conference divides its 24-week annual session into three parts and, if necessary, continues its negotiations on priority issues between sessions. Meetings thus may take place during six to nine months each year.

- 4.24 Pursuant to paragraph 120 (c) of the Final Document of the Tenth Special Session of the General Assembly, the Secretary-General, following consultations with the Conference on Disarmament, appoints the Secretary-General of the Conference, who also acts as his Personal Representative, to assist the Conference and its Presidents in organizing the Conference. As requested by the Assembly in its resolution 34/83 L, the Secretary-General provides staff, as well as the assistance and services needed by the Conference and any subsidiary bodies that it might establish, in accordance with the arrangements set out in its rules of procedure. The secretariat of the Conference consists of officers of the Conference on Disarmament secretariat and Conference Support Branch (Geneva) of the Office for Disarmament Affairs.
- 4.25 The Conference on Disarmament successfully concluded the negotiation of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction (1992) and the Comprehensive Nuclear-Test-Ban Treaty (1996), with the participation of all five nuclear-weapon States and other militarily significant States.
- 4.26 The distribution of resources for policymaking organs is reflected in table 4.7.

4.27 A provision amounting to \$34,500, reflecting a decrease of \$3,800, relates to the travel and subsistence allowance of the Secretary-General of the Conference on Disarmament and Personal Representative of the Secretary-General of the United Nations and the Deputy Secretary-General of the Conference on Disarmament to attend the seventy-first and seventy-second sessions of the General Assembly, as well as consultative meetings in New York. The reduced requirements under travel of staff take into account the anticipated impact of the approved standards of accommodation for air travel, proposed in line with General Assembly resolution 69/264.

B. Executive direction and management

Resource requirements (before recosting): \$4,134,800

- 4.28 The Office of the High Representative for Disarmament Affairs comprises the immediate Office of the High Representative, the Office of the Director and Deputy to the High Representative, the Strategic Planning Unit and the Vienna office. The High Representative for Disarmament Affairs, in the performance of her activities, is assisted by a Director who serves as Deputy to the High Representative and is accountable to the High Representative.
- 4.29 The High Representative undertakes appropriate advocacy work to advance the disarmament agenda and is responsible for all the overall direction, supervision and management of the

activities of the Office for Disarmament Affairs. The High Representative provides the Secretary-General with advice and support on all arms control, disarmament, non-proliferation and related security matters and, in that respect, represents the Secretary-General as required. The High Representative is also responsible for providing authoritative analysis and assessment of developments for policy guidance and decision-making purposes and acts as focal point on these matters between the Secretariat and Member States.

- 4.30 The Office of the Director is responsible for providing support to the High Representative on the executive direction and management of the Office; preparing and monitoring the implementation of the programme of work of the Office for Disarmament Affairs and ensuring efficient coordination, synergy between the branches and the effective delivery of the programmatic mandates of the Office; preparing reports and notes on political and managerial issues; and providing advice to the High Representative on all substantive, organizational, administrative, personnel and budgetary matters, including the overall coordination in the preparation and revision of the Office's inputs to the biennial programme plan and the programme budget. The Office of the Director also oversees the Vienna office.
- 4.31 The Strategic Planning Unit advises on overall strategic issues, policy planning and fundraising strategies as well as normative and analytical research activities in support of the Secretary-General's priority agenda related to disarmament issues. The Unit is also responsible for the preparation of political analyses and substantive background notes on a broad range of initiatives and topics, with a particular emphasis on priority as well as emerging issues, particularly salient cross-cutting issues. The Unit serves as a coordination and liaison node on programmatic issues with other Secretariat offices (such as the Policy Committee). The Unit coordinates the preparation of substantive assessments and input to reports to intergovernmental and oversight bodies.

4.35 The amount of \$4,134,800, reflecting a decrease of \$662,100 provides for the continuation of 12 posts (1 Under-Secretary-General, 1 D-2, 3 P-5, 1 P-4, 1 P-3, 1 P-2 and 4 General Service (Other level)) as well as related non-post operational requirements within the Office of the High Representative and the Office of the Director. The reduced requirements under travel of staff take

- into account the anticipated impact of the approved standards of accommodation for air travel, proposed in line with General Assembly resolution 69/264.

- 4.42 The amount of \$5,194,900 would provide for the continuation of seven posts (1 D-2, 1 P-5, 2 P-4 and 3 General Service (Other level)) as well as non-post operational requirements such as general temporary assistance, experts, travel of staff, supplies and the fellowship programme of \$1,396,700 and a subvention of \$584,600 to UNIDIR. The net increase in non-post resources of \$1,088,500 reflects the following increases: (a) under grants and contributions resulting from the reversal of the responsibilities of the fellowship programme from subprogramme 5 to subprogramme 1 (\$1,396,700); (b) under general temporary assistance (\$3,900); (c) replacement of office automation equipment (\$13,400); and (d) general operating expenses and supplies (\$2,900), which are offset in part by the reductions under experts (\$324,400) due to the transfer of responsibilities in support of the activities of the United Nations Standing Advisory Committee on Security Questions in Central Africa to the Department of Political Affairs, and travel of staff (\$4,000) that take into account further reductions projected in 2016-2017 owing to the anticipated impact of the approved standards of accommodation for air travel, proposed in line with General Assembly resolution 69/264.

- 4.48 The amount of \$2,458,300 would provide for the continuation of the seven posts (1 D-1, 1 P-5, 1 P-4, 1 P-3 and 1 P-2/1 and 2 General Service (Other level)) and non-post resources for operational requirements under other staff costs, experts and travel of staff. The net increase in non-post resources of \$63,200 reflects increased support for the annual Conference of States Parties of the Organization for the Prohibition of Chemical Weapons, the expert meetings of the Biological and Toxin Weapons Convention, and the coordination and cooperation meetings of experts with the World Health Organization, the Organization for the Prohibition of Chemical Weapons, the International Criminal Police Organization (INTERPOL), the World Organization for Animal Health and the Food and Agriculture Organization of the United Nations (\$59,900), as well as increased requirements under general temporary assistance (\$6,000), offset in part by a reduction in travel of staff (\$2,700) that takes into account the anticipated impact of the approved standards of accommodation for air travel, proposed in line with General Assembly resolution 69/264.
- 4.49 The estimated amount of \$1,818,800 from extrabudgetary resources will continue to be used to support and organize outreach and country-specific activities designed to facilitate the implementation of Security Council resolution 1540 (2004) by Member States, as well as the management and enhancement by the Office for Disarmament Affairs of the Secretary-General's Mechanism for Investigation of Alleged Use of Chemical, Biological or Toxin Weapons, and in particular the training of experts and development of closer operational interaction with international organizations.

- 4.54 The amount of \$3,527,900 would provide for the continuation of the seven posts (1 D-1, 2 P-5, 1 P-4, 1 P-3 and 2 General Service (Other level)) and non-post resources for operational requirements under other staff costs, consultants and experts, and travel of staff. - 4.60 The amount of \$3,239,100, reflecting a decrease of \$723,200, provides for the continuation of the nine posts (1 P-5, 2 P-4, 1 P-3 and 1 P-2/1, 2 General Service (Principal level) and 2 General Service (Other level)) and non-post resources for operational requirements under other staff costs, consultants and travel of staff. The reduction of \$723,200 in non-post resources is due mainly to the removal of non-recurrent provisions under experts (\$632,300) and consultants (\$46,500) pursuant to General Assembly resolution 68/243 and further reductions under consultants (\$50,000) and travel of staff (\$4,400) that take into account the anticipated impact of the approved standards of accommodation for air travel in line with General Assembly resolution 69/264, offset by the increased requirements under general temporary assistance (\$10,000).

- 4.66 The amount of \$4,516,400, representing a decrease of \$1,353,300, provides for the continuation of the 15 posts (1 D-1, 4 P-5, 1 P-4, 3 P-3, 1 P-2/1, 1 General Service (Other level) and 4 Local level) as well as non-post resources for operational requirements under other staff costs, core operation costs of the Regional Activities Unit in New York, the Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean, the Regional Centre for Peace and Disarmament in Asia and the Pacific and the Regional Centre for Peace and Disarmament in Africa. The reduction of \$1,353,300 in non-post resources reflects mainly the retention of the responsibility for the fellowship programme under subprogramme 1 (\$1,396,700), as well as further reductions under travel of staff (\$7,200) that take into account the anticipated impact of the approved standards of accommodation for air travel, proposed in line with General Assembly resolution 69/264, offset in part by increased requirements under general temporary assistance (\$50,600).
- 4.67 The estimated amount of \$9,871,100 from extrabudgetary resources will continue to fund the operation and activities of the three regional centres for peace and disarmament, including: (a) the organization of seminars, training courses, weapons and ammunition destruction events, stockpile management activities, technical and legal advisory missions and studies, and the provision of

practical disarmament-related equipment and assistance; and (b) the promotion of existing disarmament and non-proliferation agreements. The resource change reflects shifts in the voluntary contributions by donor States.

D. Programme support

Resource requirements (before recosting): \$1,466,900

- 4.68 The Executive Office provides support services to the Office for Disarmament Affairs in connection with personnel, budgetary and financial administration, resource planning and use of common services, together with administrative support for policymaking organs and other meetings, as required.
- 4.69 The distribution of resources for programme support is reflected in table 4.21.

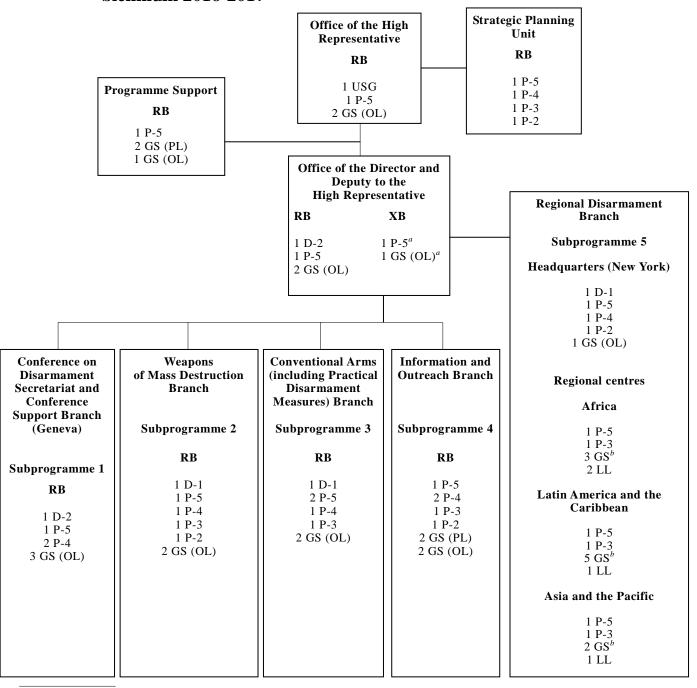

- 4.70 The amount of \$1,466,900, reflecting a decrease of \$47,100, provides for the partial financing of four posts (1 P-5, 2 General Service (Principal level) and 1 General Service (Other level)) as well as non-post operational requirements under other staff costs, contractual services for data processing, infrastructure costs and general operating requirements. The net decrease of \$47,100 is due primarily to the freezing of recruitment against established posts, as well as the reduced requirements under miscellaneous services and supplies, proposed in line with General Assembly resolution 69/264.
- 4.71 The estimated amount of \$550,000 from extrabudgetary resources relates to general temporary assistance for support in the management of the various trust funds in the Office.
