NOTE

The resolutions and decisions of the General Assembly are identified as follows:

Regular sessions

Until the thirtieth regular session, the resolutions of the General Assembly were identified by an arabic numeral followed by a roman numeral in parentheses indicating the session (for example: resolution 3363 (XXX)). When several resolutions were adopted under the same number, each of them was identified by a capital letter placed between the two numerals (for example: resolution 3367 A (XXX), resolutions 3411 A and B (XXX), resolutions 3419 A to D (XXX)). The decisions were not numbered.

Since the thirty-first session, as part of the new system adopted for symbols of General Assembly documents, resolutions and decisions have been identified by an arabic numeral, indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution 31/1, decision 31/301). When several resolutions or decisions were adopted under the same number, each of them has been identified by a capital letter placed after the two numerals (for example: resolution 31/16 A, resolutions 31/6 A and B, decisions 31/406 A to E).

Special sessions

Until the seventh special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letter "S" and a roman numeral indicating the session (for example: resolution 3362 (S-VII)). The decisions were not numbered.

Since the eighth special session, resolutions and decisions have been identified by the letter "S" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution S-8/1, decision S-8/11).

Emergency special sessions

Until the fifth emergency special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letters "ES" and a roman numeral indicating the session (for example: resolution 2252 (ES-V)). The decisions were not numbered.

Since the sixth emergency special session, resolutions and decisions have been identified by the letters "ES" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution ES-6/1, decision ES-6/11).

In each of the series described above, the numbering follows the order of adoption.

69/401. Appointment of the members of the Credentials Committee

At its 1st plenary meeting, on 16 September 2014, the General Assembly, in accordance with rule 28 of its rules of procedure, appointed a Credentials Committee for its sixty-ninth session consisting of the following Member States: BANGLADESH, BRAZIL, CHINA, DENMARK, JAMAICA, NAMIBIA, RUSSIAN FEDERATION, SENEGAL and UNITED STATES OF AMERICA.

69/402. Election of five non-permanent members of the Security Council

At its 25th plenary meeting, on 16 October 2014, the General Assembly, in accordance with Article 23 of the Charter of the United Nations and rule 142 of the rules of procedure of the Assembly, elected Angola, Malaysia, New Zealand, Spain and Venezuela (Bolivarian Republic of) as non-permanent members of the Security Council for a two-year term of office beginning on 1 January 2015 to fill the vacancies occurring on the expiration of the terms of office of Argentina, Australia, Luxembourg, the Republic of Korea and Rwanda.

At its 29th plenary meeting, on 21 October 2014, the General Assembly, pursuant to its resolutions 60/251 of 15 March 2006 and 65/281 of 17 June 2011, elected Albania, Bangladesh, Bolivia (Plurinational State of), Botswana, the Congo, El Salvador, Ghana, India, Indonesia, Latvia, the Netherlands, Nigeria, Paraguay, Portugal and Qatar as members of the Human Rights Council for a three-year term of office beginning on 1 January 2015 to fill the vacancies occurring on the expiration of the terms of office of Austria, Benin, Botswana, Burkina Faso, Chile, the Congo, Costa Rica, the Czech Republic, India, Indonesia, Italy, Kuwait, Peru, the Philippines and Romania.

At its 32nd plenary meeting, on 29 October 2014, the General Assembly, on the basis of nominations by the Economic and Social Council ¹ and in accordance with the annex to Council resolution 2008 (LX) of 14 May 1976, paragraph 1 of Council resolution 1987/94 of 4 December 1987, as well as Assembly decision 42/450 of 17 December 1987, elected Armenia, Belarus, Brazil, Burkina Faso, Cameroon, Cuba, Equatorial Guinea, Iran (Islamic Republic of), Italy, Namibia, Ukraine, Uruguay and Venezuela (Bolivarian Republic of) as members of the Committee for Programme and Coordination for a three-year term of office beginning on 1 January 2015 to fill the vacancies occurring on the expiration of the terms of office of Argentina, Belarus, Brazil, Bulgaria, Cameroon, Cuba, Guinea, Guinea Bissau, Iran (Islamic Republic of), Italy, Kazakhstan, Malaysia, Pakistan, the Republic of Moldova, the United Kingdom of Great Britain and Northern Ireland, the United States of America, Uruguay and Zimbabwe.

At its 68th plenary meeting, on 10 December 2014, the General Assembly, on the basis of nominations by the Economic and Social Council, elected PAKISTAN, SAUDI ARABIA and the UNITED STATES OF AMERICA as members of the Committee for Programme and Coordination for a three-year term of office beginning on 1 January 2015.

At the same meeting, the General Assembly was informed that an election would be held at a later date, on the basis of nominations by the Economic and Social Council, for the seven seats that remained to be filled on the Committee for Programme and Coordination.³

At its 32nd plenary meeting, on 29 October 2014, the General Assembly, in accordance with Article 61 of the Charter of the United Nations and rule 145 of the rules of procedure of the Assembly, elected Argentina, Austria, Brazil, Burkina Faso, Estonia, France, Germany, Ghana, Greece, Honduras, India, Japan, Mauritania, Pakistan, Portugal, Trinidad and Tobago, Uganda and Zimbabwe as members of the Economic and Social Council for a three-year term of office beginning on 1 January 2015 to fill the vacancies occurring on the expiration of the terms of office of Austria, Belarus, Brazil, Burkina Faso, Cuba, the Dominican Republic, El Salvador, Ethiopia, France, Germany, Greece, India, Indonesia, Japan, Lesotho, Libya, Nigeria and Portugal.

At its 47th plenary meeting, on 10 November 2014, the General Assembly, in accordance with rule 140 of the rules of procedure of the Assembly, elected AUSTRALIA, FINLAND and SWITZERLAND as members of the Economic and Social Council for the remainder of the terms of office of CANADA, DENMARK and NEW ZEALAND, respectively, beginning on 1 January 2015.

69/406. Election of five members of the International Court of Justice

The General Assembly, at its 39th plenary meeting, on 6 November 2014, and the Security Council, at its 7297th meeting, on the same date, proceeded independently of one another to elect, in accordance with Articles 2 to 4, 7 to 12 and 14 and 15 of the Statute of the International Court of Justice, rules 150 and 151 of the rules of procedure of the Assembly and rules 40 and 61 of the provisional rules of procedure of the Council, four members of the Court for a nine-year term of office beginning on 6 February 2015 to fill the vacancies occurring on the expiration of the terms of office of Mr. Mohamed Bennouna (Morocco), Ms. Joan E. Donoghue (United States of America), Mr. Kenneth Keith (New Zealand), Mr. Bernardo Sepúlveda Amor (Mexico) and Mr. Leonid Skotnikov (Russian Federation).

Having obtained the required absolute majority of votes in both the General Assembly and the Security Council, Mr. Mohamed Bennouna (Morocco), Mr. James Richard Crawford (Australia), Ms. Joan E. Donoghue (United States of America) and Mr. Kirill Gevorgian (Russian Federation) were elected as members of the Court for a nine-year term of office beginning on 6 February 2015.

The General Assembly, at its 53rd plenary meeting, on 17 November 2014, and the Security Council, at its 7313th meeting, on the same date, continued independently of one another to elect one member of the Court to fill the remaining vacancy.

Having obtained the required absolute majority of votes in both the General Assembly and the Security Council, Mr. Patrick Lipton Robinson (Jamaica) was elected as a member of the Court for a nine-year term of office beginning on 6 February 2015.
