### **Report on operational support provided by French forces to the United Nations Multidimensional Integrated Stabilization Mission in Mali from 24 February to 19 May 2015**

Pursuant to paragraph 26 of Security Council resolution 2164 (2014), please find below the report on actions undertaken by French forces in support of the United Nations Multidimensional Integrated Stabilization Mission in Mali (MINUSMA), from 24 February to 19 May 2015.

The report is the fourth of its kind since the adoption of resolution 2164 (2014), and the eighth since MINUSMA was established.

Previously, France submitted four reports to the Security Council which outlined six combat actions undertaken in response to “an imminent and serious threat” to MINUSMA.

Since 24 February 2015, no combat action has been undertaken in response to an “imminent and serious threat”.

Nonetheless, French forces provided support to MINUSMA in several areas:

- Through many joint patrols and the direct support of French specialists (explosive ordnance disposal, medical teams, intelligence), the French liaison and operational support detachments deployed in support of MINUSMA battalions participate daily in fulfilling their mission to control the major cities and highways in the north of Mali, and improve the security situation for the inhabitants of the region. They also conduct training sessions for MINUSMA battalions in various operational areas, including shooting, tactical planning and explosives.
- At the request of MINUSMA, the Barkhane force has carried out 10 aerial shows of presence in the Ménaka area since 10 May 2015.
- As part of the support provided by French forces in caring for wounded MINUSMA elements, two health support missions were undertaken:
  - On 17 March, at the request of MINUSMA, a Dutch pilot deployed with MINUSMA was airlifted by a French helicopter ambulance following the crash of a MINUSMA Apache attack helicopter.
  - On 24 March, following an explosion on the runway in Kidal, a French peacekeeper deployed with MINUSMA was airlifted by a French helicopter ambulance and underwent surgery at the role II hospital in Gao.

In addition, Operation Barkhane provides community health services at its outposts, such as the one in Tessalit, to some MINUSMA personnel on an ad hoc basis.
