### **Identical letters dated 16 June 2015 from the Permanent Representative of the Syrian Arab Republic to the United Nations addressed to the Secretary-General and the President of the Security Council**

On instructions from my Government, I wish to transmit the following information:

Once again, the peaceful civilians of Aleppo city have become the victims of a heinous crime. On Monday 15 June 2015, the armed terrorist groups — known by the sponsors of terrorism as the “moderate armed opposition” — committed another savage massacre, indiscriminately firing more than one hundred rockets onto the areas of Suryan, Suryan al-Jadidah, Aziziyah, Rashidin, Salah al-Din and Isma‘iliyah, and onto Nil street, the surroundings of Shayhan hospital and the peaceful residential quarter of Masakin al-Sabil. Their aim was to terrorize civilians and inflict the greatest possible human losses. As a result, 36 civilians were killed, including the following 12 children: Lujayn Hamami, aged four; Abdullah al-Hamad, aged four; Nur Siraj, aged five; Sa’dah al-Hamad, aged six; Mustafa Badri, aged five; Fatimah al-Zahra’, aged two; Adib Dar’uzi, aged three; Ayah Dar’uzi, aged two; Bisan Dar’uzi, aged five months; Samirah Malqi, aged 12; Ahmad Ghalib, aged 16; and Rahab Muhammad, aged 13. Over 120 others were wounded, most of them women and children. The death toll could rise further, as several civilians were seriously wounded and some of the body parts that were collected have yet to be identified. Residential buildings and public and private property sustained extensive damage. A list of the victims is annexed hereto.

This latest massacre is one of a series of terrorist acts that have systematically targeted Syria for over four years. They were a reprisal against the people of Aleppo city, who have remained steadfast against the armed terrorist groups, refusing to leave their land in defiance against obscurantist, *takfirist* ideology. Responsibility for this latest crime rests not only with the so-called moderate armed opposition, but also with the regimes of Saudi Arabia, Qatar, Jordan, Turkey and Israel, which sponsor and finance the armed terrorist groups, providing funds, safe haven, training and weapons. Those regimes persistently ignore the counter-terrorism resolutions of the Security Council. Certain members of the Security Council and the international community have maintained a suspicious silence that verges on collusion with the terrorist groups. Their silence is a testament to their double standards regarding counter-terrorism.



Such double standards and politicization of the Syrian crisis can no longer be accepted, now that all and sundry have witnessed the savagery and barbarity of the armed terrorist groups and their crimes against the people, land, civilization and culture of Syria. The claims of those who seek to posit a “moderate armed opposition” are no longer tenable. The international community must now stand together as one and coordinate with the Government of the Syrian Arab Republic. For several years now, the latter has borne the burden of the fight against terrorism. On behalf of the peoples of the region and the world, it has defended humanity and the noble values of justice and freedom, and endeavoured to uphold all of the Security Council counter-terrorism resolutions, particularly resolutions 2170 (2014), 2178 (2014) and 2199 (2015).

The Government of the Syrian Arab Republic is determined to continue fighting terrorism in Syria. In accordance with its constitutional responsibility, it will continue to defend and protect its people. It therefore calls on the Security Council and the Secretary-General of the United Nations to condemn the recent massacre; call things by their names, eschewing politicization and double standards; and take firm preventive action against the armed terrorist groups and the States that sponsor and support them.

I should be grateful if you would have the present letter and its annex issued as a document of the Security Council.
