Election to fill a vacancy on the Finance Committee in accordance with section 9 of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea

Note by the Secretary-General

1. The Assembly is invited to note that Han Thein Kyaw (Myanmar) has resigned from the Finance Committee effective 17 May 2015. Mr. Kyaw was elected by the Assembly at the eighteenth session of the International Seabed Authority, in 2012, as a member of the Finance Committee to serve out the remainder of the term of Zaw Minn Aung (Myanmar), who had resigned.
2. Section 9, paragraph 5, of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea provides that, in the event of the death, incapacity or resignation of a member of the Finance Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
3. In accordance with section 9 of the annex to the Agreement, the Finance Committee shall be composed of 15 members with appropriate qualifications relevant to financial matters. Members of the Finance Committee shall be elected by the Assembly.
4. By a note verbale dated 10 June 2015, the Permanent Mission of Myanmar to the United Nations informed the Secretary-General of the Authority of the nomination of Ye Minn Thein to fill the vacant seat on the Finance Committee left by Mr. Kyaw for the remainder of his term ending on 31 December 2016. The curriculum vitae of Mr. Thein appears in the annex to the present document.
