Lesotho*: draft resolution

International Conference on the Plight of Refugees, Roturnees and Displaced Persons in Southern Africa

The General Assembly,

Recalling its resolution 43/116 of 8 December 1988 on the International Conference on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa,

Gravely concerned at the constant deterioration of the situation in southern Africa arising from the domination and oppression of the peoples of South Africa by the minority racist régime of South Africa,

Having examined the report of the Secretary-General on the International Conference on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa, 1/

Conscious of its responsibility to provide economic, material and humanitarian assistance to independent States in southern Africa in order to assist them in coping with the situation resulting from the acts of aggression and destabilization committed by the apartheid régime of South Africa,

Noting with appreciation the consultations watertaken by the Secretary-General to establish within the Une ed Nations system a mechanism to ensure the implementation and overall co-ordination of relief programmes to internally displaced persons,

Noting with indignation that South Africa's policy of <u>apartheid</u> and its direct and indirect acts of aggression, intimidation and destabilization through armed terrorists continue to be the main causes of refugee flows and increasing displacement of persons in southern Africa,

Convinced that there is an urgent need for the international community to extend maximum and concerted assistance to southern African countries sheltering refugees, returnees and displaced persons and also to highlight the plight of these persons,

- 1. <u>Takes note with satisfaction</u> of the report of the Secretary-General on the International Conference on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa;
- 2. Reaffirms the need to continue the implementation of the Oslo Declaration and Plan of Action on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa adopted by the Conference; 2/
- 3. Expresses its gratitude to the countries and organizations that have given assistance to the countries in southern Africa to enable them to cope with the situation of refugees, returnees and displaced persons in their countries;
- 4. <u>Calls upon</u> the international community to provide increased assistance to the countries of southern Africa to enable them to strengthen their capacity to provide the necessary facilities and services for the care and well-being of the refugees, returned and displaced persons in their countries;
- 5. Reiterates its appreciation to the Secretary-General for his effc.ts, on behalf of the international community, to organize and mobilize special programmes of economic assistance for the front-line and other neighbouring States to help them to withstand the effects of the acts of aggression and destabilization committed by the apartheid régime of South Africa;
- 6. Notes with appreciation the efforts made by the Secretary-General, the Office of the United Nations High Commissioner for Refugees and the Administrator of the United Nations Development Programme to implement those specific tasks and responsibilities attributed to them in the Oslo Declaration and Plan of Action and encourages them to continue their efforts;
- 7. Endorses the Secretary-General's recommendation aimed at attributing to the United Nations Resident Co-ordinators, the function of co-ordinating assistance for internally displaced persons in close co-operation with Governments, local representatives of donor countries and United Nations agencies in the field;

- 8. <u>Urges once again</u> all Member States, organizations of the United Nations system and governmental and non-governmental organizations to undertake such measures as would be required of them by the Oslo Declaration and Plan of Action;
- 9. <u>Decides</u> to consider this question at its forty-fifth session on the basis of a report to be submitted by the Secretary-General.
