Note verbale datée du 1^{er} juillet 2015, adressée au Cabinet du Président du Conseil des droits de l'homme par la Mission permanente de l'Érythrée auprès de l'Office des Nations Unies à Genève

La Mission permanente de l'État d'Érythrée auprès de l'Office des Nations Unies et des autres organisations internationales à Genève présente ses compliments au Cabinet du Président du Conseil des droits de l'homme et a l'honneur d'appeler l'attention du Cabinet sur ce qui suit.

La Mission permanente a appris que le communiqué de presse du Ministère des affaires étrangères (« Commission of inquiry ») report : Cynical political travesty that undermines human rights) dont le texte avait été présenté afin d'être distribué comme document officiel du Conseil des droits de l'homme avait été soumis à des modifications peu professionnelles, et qu'il s'agit d'une falsification. Ainsi, les deux paragraphes ci-après, qui provenaient d'un document de la République populaire démocratique de Corée, ont été insérés dans le texte du communiqué de presse, ce qui en a modifié la teneur et l'esprit :

« We are fully ready for any confrontation with the U.S. and will shatter the reckless “human rights” racket by the hostile forces through our toughest reaction.

The moves of the hostile forces to dare provoke the socialist system of the DPRK which was chosen and has been consolidated by the Korean people will not be able to escape disgraceful doom. ».

Les tentatives de créer un mythe selon lequel l'Érythrée serait liée à la République populaire démocratique de Corée, qui font partie des efforts délibérés de désinformation et de chantage menés contre l'Érythrée, n'ont rien de nouveau. La Mission déplore ce manquement au professionnalisme et ne peut croire que l'insertion des passages cités ci-dessus soit véritablement le résultat d'une erreur.

La Mission permanente souhaite également informer le Cabinet du Président du Conseil des droits de l'homme que le document falsifié a été cité et diffusé par des organes de presse, des organisations et des individus qui s'emploient sans relâche à ternir l'image de l'Érythrée pour servir d'autres mobiles politiques, sous le couvert des droits de l'homme.



Enfin, la Mission permanente prie le Cabinet de bien vouloir :

1. Prendre des mesures correctrices en remplaçant ledit document par le texte original du communiqué de presse, qui avait été envoyé par la Mission permanente aux formats PDF et Word;
2. Publier une déclaration publique condamnant l'acte peu professionnel en question afin de prévenir la commission d'actes similaires à l'avenir et de rectifier l'image erronée qui a été donnée de l'Érythrée par les médias en général et les médias sociaux en particulier;
3. Enquêter sur cette affaire et amener les responsables à répondre de leurs actes, puis informer la Mission permanente de l'Érythrée, les membres du Conseil et le grand public des résultats de l'enquête et des mesures prises;
4. Faire distribuer le texte de la présente note verbale et de ses pièces jointes comme document officiel du Conseil des droits de l'homme.
