Добавление

- 1. Во исполнение соответствующих резолюций Экономического и Социального Совета, и в частности резолюции 1986/35, Комиссия по правам человека на своей сорок шестой сессии должна избрать половину членов Подкомиссии и, если это необходимо, соответствующих заместителей, срок полномочий которых истечет через два года, по следующей сжеме: три члена от африканских государств; три члена от азиатских государств; один член от восточноевропейских государств; три члена от латиноамериканских государств и три члена от западноевропейских и других государств.
- 2. В документе E/CN.4/1990/48 и Add.1 Генеральный секретарь информировал Комиссию о выдвижениях кандидатов и заместителей для избрания в Подкомиссию, полученных по состоянию на 20 ноября 1989 года. В этом документе также содержатся полученные биографические данные кандидатов и заместителей.
- 3. После 20 ноября 1989 года были получены дополнительные кандидатуры и биографические данные. В настоящем документе содержится обновленный список кандидатов в члены Подкомиссиии по состоянию на 6 декабря 1989 года. В него также включены биографические данные, которые не были воспроизведены в документе E/CN.4/1990/48 и Add.1 и/или были получены после 20 ноября 1989 года (см. приложение).

RESEARCH/PUBLICATIONS

Successfully conducted research work for the Master of Laws (LL.M.) degree on the theme: "Self-determination of the people of Zimbabwe in the light of international law".

Presented doctoral thesis on the topic "Certain international legal problems relating to exercise of economic self-determination by African States", and was awarded the Doctor of Philosophy Degree in International Law. Published articles in students journals and newspapers, while a student in Moscow. Presently pursuing the publication of my thesis in book form.

The manuscript examines salient legal problems relating to exercise of economic sovereignty of peoples and nations; looks into the question of economic sovereignty and utilization of natural resources; prescribes the legal framework for international co-operation; examines the legal and

institutional aspects of utilization of international river basins; and looks into the question of self-determination and territorial controversies. The settlement of international disputes is also examined.

WORKING EXPERIENCE

In 1974, I joined the Inner London Magistrates' Courts at Clerkenwell Magistrates' Court as an Assistant to the Clerk of Court, a post I held prior to taking up a post-graduate Research Fellowship at the University of Edinburgh.

From April 1981 to August 1982 I was employed in the Prime Minister's Department as an Assistant Secretary to Cabinet. Thus I became exposed to the entire Government Administration and Policy.

On 1 September 1982 I was promoted to the post of Senior Law Officer (Under-Secretary level) in the Legal Advice Department - International Law Section, Ministry of Justice, Legal and Parliamentary Affairs.

On 13 September 1985 I was further promoted to the post of Chief Law Officer, Legal Advice Department - International Law Section, Ministry of Justice, Legal and Parliamentary Affairs (Attorney-General's Office).

DUTIES/RESPONSIBILITIES

My duties/responsibilities as Chief Law Officer/Adviser include heading the International Law Section of the Ministry as well as rendering legal advice to Government and its other bodies on all matters of international law. Where need arises, one is also called upon to give legal advice on national or domestic law. Other responsibilities relate to drafting, negotiation and monitoring of the application of international legal instruments of both bilateral and multilateral character. The interpretation of international law in general, and in particular, interpretation of treaties, forms my major function as an international lawyer in Government. I have been involved in the negotiation and now in monitoring the application of the Treaty for the Establishment of the Preferential Trade Area for Eastern and Southern African States (P.T.A.). Certain legal instruments of Southern African Development Co-ordination Conference (SADCC) have been drafted and their application is being monitored.

I am Chairman of the Public Agreements Advisory Committee (PAAC), which is responsible for advising Government on treaty matters.

I have represented Zimbabwe, either as head of delegation or as legal adviser accompanying delegations, at numerous international; interregional; regional; subregional conferences and meetings.

Birth and nationality

Mr. Chikove is a Zimbabwean born in Zimbabwe on 19 August 1950.

2. Present position

Mr. E. Chikove is at the moment, <u>Deputy Secretary</u> responsible for <u>Policy</u> in the <u>Ministry of Justice</u>, <u>Legal and Parliamentary Affairs</u>.

His functions include policy formulation, legislation, execution of statutory functions of the Ministry, transformation of the legal system of Zimbabwe, co-ordination of legal training courses and seminars, co-ordination of the Ministry's professional and legal services, co-ordination of the Ministry's parliamentary responsibilities, Supervision of the Legal Aid Scheme in the Ministry, Supervision of the Petitions Office which recommends presidential pardon for prisoners, responsible for all the legal aspects of the Ministry's administration, and attends all Cabinet Committee meetings in which his Ministry is a member.

3. Qualifications

- (a) An Upper Second Class Honours Bachelor of Laws Degree (LL.B. Hons.);
- (b) A Master of Laws Degree (LL.M.) in which he specialized in:
 - (i) Public International Law;

He wrote a thesis on "The Status of Liberation Movements in International Law", which <u>inter alia</u>, extensively dealt with areas as self-determination, human rights and liberation movements, and international humanitarian law.

4. Working experience

(a) Mr. Chikove is a former <u>lecturer</u> and <u>tutor</u> at the School of Law of the University of Zambia. He taught mainly Public International Law and International Organizations Law.

- (b) From the School of Law of the University of Zambia, he joined the then (1978) Zambian Prime Minister's Office, on contract (i.e. as an expatriate) as a Staff Training Officer in which capacity he trained magistrates, police and civilian prosecutors, diplomats, immigration officers and local government personnel.
- (c) In October 1980 he moved to Zimbabwe where he was appointed Assistant Secretary, in the then Ministry of Justice and Constitutional Affairs, with a special responsibility for reforming the lower law courts and our legal system and training judicial personnel. He successfully did it and eight months later he was promoted to the post of <u>Under-Secretary</u> with the same responsibility.
- (d) In October 1982 he was moved to the then newly created Ministry of Legal and Parliamentary Affairs as <u>Senior Legal Officer</u> in the Department of Legal Advice. His duties were: giving legal advice to the whole Government, preparation of legal opinions, advising on international law matters generally, review of a variety of treaties entered into by previous Governments on behalf of Zimbabwe.
- (e) In 1984 he was asked to create and establish a Legal Research Department which he did and the Department started functioning.
 - (f) In 1985 he was called to the Department for legal advice again.
- (g) In early 1986 he was moved to the Division of Policy and was promoted to the post of Chief Law Officer. In March 1989 he was promoted to the post of Deputy Secretary for Policy.

5. Other activities

- (a) Mr. Chikove has served as a Chairman or member in several Commissions of Inquiry in the Government.
- (b) He is a Member of UNESCO's Special Standing Committee on Social and Human Sciences since June 1987.
