Conrod C. Hunte joined the Diplomatic Service in 1982 and has served in various capacities in the Ministry of Foreign Affairs/Permanent Mission of Antigua and Barbuda to the United Nations. He was Ambassador and Deputy Permanent Representative of Antigua and Barbuda to the United Nations until 31 December 2012.

Mr. Hunte has extensive and relevant experience in the United Nations system, including environmental, sustainable development and finances. He represented the Antigua and Barbuda delegation in the Fifth Committee (administrative and budgetary issues) of the General Assembly, as well as in the work of various United Nations funds and programmes. In that position, he has promoted measures aimed at making the Organization more efficient and effective and increasing the budgetary discipline of the United Nations systems (July 2007-2012).

Mr. Hunte also worked as an international civil servant for the Convention on Biological Diversity as the Liaison Officer in New York (2003-2006), where his duties were to maintain close linkage with delegations and organizations at United Nations Headquarters on matters related to the Convention on Biological Diversity. Assisted with the promotion of the common objectives of both conventions on relevant issues, including dryland, subhumid, agriculture biological diversity and forest biodiversity.

Mr. Mohanad Al-Musawi commenced his career in the Iraqi public sector, holding many positions in the Ministry of Foreign Affairs since May 2004.
