Report of the Special Political Committee

I. INTRODUCTION

1. The item entitled "United Nations Relief and Works Agency for Palestine Refugees in the Near East" was included in the provisional agenda of the forty-fourth session of the General Assembly in accordance with Assembly resolutions 43/57 A to J of 6 December 1988.

2. At its 3rd plenary meeting, on 22 September 1989, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the Special Political Committee.

3. The Special Political Committee considered the item at its 5th to 8th and 25th meetings, held from 24 to 27 October and on 22 November 1989 (see A/SPC/44/SR.5-8 and 25).

6. At its 5th meeting, on 24 October, the Committee heard a statement by the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), who introduced his report. 1/

7. At the same meeting, the representative of Norway, Rapporteur of the Working Group on the Financing of UNRWA, introduced the report of the Working Group (A/44/641).

### **II. CONSIDERATION OF PROPOSALS**

8. In the course of its deliberations, the Special Political Committee considered 11 draft resolutions, as set forth below.

# A. Draft resolution A/SPC/44/L.5 and Corr.1

2. <u>Expresses its thanks</u> to the Commissioner-General and to all the staff of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, recognizing that the Agency is doing all it can within the limits of available resources, and also expresses its thanks to the specialized agencies and private organizations for their valuable work in assisting the refugees;

3. <u>Reiterates its request</u> that the headquarters of the Agency should be relocated to its former site within its area of operations as soon as practicable;

4. <u>Notes with regret</u> that the United Nations Conciliation Commission for Palestine has been unable to find a means of achieving progress in the implementation of paragraph 11 of General Assembly resolution 194 (III), <u>3</u>/ and requests the Commission to exert continued efforts towards the implementation of that paragraph and to report to the Assembly as appropriate, but no later than 1 September 1990;

5. <u>Directs attention</u> to the continuing seriousness of the financial position of the Agency, as outlined in the report of the Commissioner-General;

6. Notes with profound concern that, despite the commendable and successful efforts of the Commissioner-General to collect additional contributions, this increased level of income to the Agency is still insufficient to cover essential budget requirements in the present year and that, at currently foreseen levels of giving, deficits will recur each year;

7. <u>Calls upon all Governments</u>, as a matter of urgency, to make the most generous efforts possible to meet the anticipated needs of the Agency, particularly in the light of the budgetary deficit projected in the report of the Commissioner-General, and therefore urges non-contributing Governments to contribute regularly and contributing Governments to consider increasing their regular contributions;

8. <u>Decides to extend</u> until 30 June 1993, without prejudice to the provisions of paragraph 11 of General Assembly resolution 194 (III), the mandate of the United Nations Relief and Works Agency for Palestine Refugees in the Near East.

<u>Recalling</u> that the Universal Declaration of Human Rights <u>11</u>/ and the principles of international law uphold the principle that no one shall be arbitrarily deprived of his or her private property,

<u>Considering</u> that the Palestine Arab refugees are entitled to their property and to the income derived therefrom, in conformity with the principles of justice and equity,

<u>Recalling in particular</u> its resolution 394 (V) of 14 December 1950, in which it directed the United Nations Conciliation Commission for Palestine, in consultation with the parties concerned, to prescribe measures for the protection of the rights, property and interests of the Palestine Arab refugees,

<u>Taking note</u> of the completion of the programme of identification and evaluation of Arab property, as announced by the United Nations Conciliation Commission for Palestine in its twenty-second progress report, 12/ and of the fact that the Land Office had a schedule of Arab owners and file of documents defining the location, area and other particulars of Arab property,

1. <u>Requests</u> the Secretary-General to take all appropriate steps, in consultation with the United Nations Conciliation Commission for Palestine, for the protection and administration of Arab property, assets and property rights in Israel and to establish a fund for the receipt of income derived therefrom, on behalf of the rightful owners;

2. <u>Calls once more upon</u> Israel to render all facilities and assistance to the Secretary-General in the implementation of the present resolution;

3. <u>Calls upon</u> the Governments of all the other Member States concerned to provide the Secretary-General with any pertinent information in their possession concerning Arab property, assets and property rights in Israel, which would assist the Secretary-General in the implementation of the present resolution;

4. <u>Deplores</u> Israel's refusal to co-operate with the Secretary-General in the implementation of the resolutions on the question;

5. <u>Requests</u> the Secretary-General to report to the General Assembly at its forty-fifth session on the implementation of the present resolution.

The General Assembly,

<u>Recalling</u> Security Council resolutions 508 (1982) of 5 June 1982, 509 (1982) of 6 June 1982, 520 (1982) of 17 September 1982 and 523 (1982) of 18 October 1982,

<u>Also recalling, in particular</u>, recent Security Council resolutions 605 (1987) of 22 December 1987, 607 (1988) of 5 January 1988, 608 (1988) of 14 January 1988, 636 (1989) of 6 July 1989 and 641 (1989) of 30 August 1989,

Further recalling its resolutions ES-7/5 of 26 June 1982, ES-7/6 and ES-7/8 of 19 August 1982, ES-7/9 of 24 September 1982, 37/120 J of 16 December 1982, 38/83 I of 15 December 1983, 39/99 I of 14 December 1984, 40/165 I of 16 December 1985, 41/69 I of 3 December 1986, 42/69 I of 2 December 1987, 43/21 I of 3 November 1988 and 43/57 I of 6 December 1988,

Taking note of the report of the Secretary-General dated 21 January 1988, <u>13</u>/ submitted in accordance with Security Council resolution 605 (1987),

Having considered the report of the Secretary-General, 14/

<u>Having also considered</u> the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, covering the period from 1 July 1988 to 30 June 1989, <u>2</u>/

<u>Gravely concerned and alarmed</u> by the deteriorating situation in the Palestinian territory occupied by Israel since 1967, including Jerusalem,

Taking into account the need to consider measures for the impartial protection of the Palestinian civilian population under Israeli occupation,

<u>Referring</u> to the humanitarian principles of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, <u>15</u>/ and to the obligations arising from the regulations annexed to the Hague Convention IV of 1907, <u>16</u>/

<u>Deeply concerned</u> at the marked deterioration in the security situation experienced by the Palestine refugees as stated by the Commissioner-General in his report, 2/

<u>Deeply distressed</u> at the suffering of the Palestinian and Lebanese population, which has resulted from continuing Israeli acts of aggression against Lebanon and other hostile acts,

<u>Deeply distressed also</u> at the continuing tragic, difficult and uncertain situation of the civilian population in and around the Palestinian refugee camps in Lebanon,

<u>Reaffirming</u> its support for sovereignty, unity and territorial integrity of Lebanon, within its internationally recognized boundaries,

1. Holds Israel responsible for the security of the Palestine refugees in the occupied Palestinian territory including Jerusalem, and other Arab territories occupied by Israel since 1967, and calls upon it to fulfil its obligations as the occupying Power in this regard, in accordance with the pertinent provisions of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949;

2. <u>Calls upon</u> all the High Contracting Parties to the Convention to take appropriate measures to ensure respect by Israel, the occupying Power, for the Convention in all circumstances in conformity with their obligation under article I thereof;

3. <u>Urges</u> the Security Council to consider the current situation in the occupied Palestinian territory, taking into account the recommendations contained in the report of the Secretary-General; 1/

4. <u>Urges</u> the Secretary-General, in consultation with the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, to continue his efforts in support of the upholding of the safety and security and the legal and human rights of the Palestine refugees in all the territories under Israeli occupation in 1967 and thereafter;

5. <u>Calls once again upon</u> Israel, the occupying Power, to release forthwith all arbitrarily detained Palestine refugees, including the employees of the United Nations Relief and Works Agency for Palestine Refugees in the Near East;

6. <u>Welcomes</u> the provision by the Commissioner-General, in consultation with the Government of Lebanon, to provide housing to the Palestine refugees whose houses were demolished or razed;

7. <u>Calls once again upon</u> Israel to compensate the Agency for the damage to its property and facilities resulting from the Israeli invasion of Lebanon, without prejudice to Israel's responsibility for all damages resulting from that invasion;

8. <u>Requests</u> the Secretary-General, in consultation with the Commissioner-General, to report to the General Assembly, before the opening of its forty-fifth session, on the implementation of the present resolution.

University of Jerusalem "Al-Ouds" for Palestine Refugees

The General Assembly,

<u>Recalling</u> its resolutions 36/146 G of 16 December 1981, 37/120 C of 16 December 1982, 38/83 K of 15 December 1983, 39/99 K of 14 December 1984, 40/165 D and K of 16 December 1985, 41/69 K of 3 December 1986, 42/69 K of 2 December 1987 and 43/57 J of 6 December 1988,

Having considered the report of the Secretary-General, 17/

<u>Having also considered</u> the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, covering the period from 1 July 1988 to 30 June 1989,  $\underline{2}/$ 

1. <u>Emphasizes</u> the need for strengthening the educational system in the Palestinian territory occupied by Israel since 5 June 1967, including Jerusalem, and specifically the need for the establishment of the proposed university;

2. <u>Requests</u> the Secretary-General to continue to take all necessary measures for establishing the University of Jerusalem "Al-Quds", in accordance with Assembly resolution 35/13 B of 3 November 1980, giving due consideration to the recommendations consistent with the provisions of that resolution;

3. <u>Calls once more upon</u> Israel, the occupying Power, to co-operate in the implementation of the present resolution and to remove the hindrances that it has put in the way of establishing the University of Jerusalem "Al-Quds";

4. <u>Requests</u> the Secretary-General to report to the General Assembly at its forty-fifth session on the progress made in the implementation of the present resolution.

Protection of Palestinian students and educational institutions and safeguarding of the security of the facilities of the United Nations Relief and Works Agency for Palestine Refugees in the Near East in the occupied Palestinian territory

The General Assembly,

Recalling Security Council resolution 605 (1987) of 22 December 1987,

Recalling its resolutions 43/21 of 3 November 1988, 43/57 I of 6 December 1988 and 44/2 of 6 October 1989,

Taking note of the report of the Secretary-General dated 21 January 1988, <u>13</u>/ submitted in accordance with Security Council resolution 605 (1987),

Having considered the statement of the Secretary-General of 19 October 1989 on the incidents in which Israeli soldiers broke into the premises of installations of the United Nations Relief and Works Agency for Palestine Refugees in the Near East in the occupied Palestinian territory,

<u>Having also considered</u> the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, covering the period from 1 July 1988 to 30 June 1989, 2/

Taking note, in particular, of paragraph 104 of that report, in which it is stated that, in the occupied Gaza Strip "between September 1988 and June 1989, two students were killed inside Agency schools, 376 were injured by live rounds and rubber bullets and 76 were detained. Outside the schools, 11 were killed, 3,655 injured and 657 detained",

<u>Gravely concerned and alarmed</u> by the deteriorating situation in the Palestinian territory occupied by Israel since 1967, including Jerusalem,

1. <u>Condemns</u> the repeated Israeli raids on the premises and installations of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, and calls upon Israel, the occupying Power, to refrain from such raids;

2. <u>Also condemns</u>, in particular, Israeli policies and practices against Palestinian students and faculties in educational institutions in the occupied Palestinian territory, especially the opening of fire on defenceless students, causing many casualties;

3. <u>Deplores</u> the policy and practices of Israel, the occupying Power, which have led to the prolonged closure of educational institutions, a large number of which are operated by the United Nations Relief and Works Agency for Palestine Refugees in the Near East, and the repeated disruption of medical services;

4. <u>Calls upon</u> Israel, the occupying Power, to open immediately all closed educational institutions and to refrain from closing them thereafter;

5. <u>Requests</u> the Secretary-General to report to the General Assembly at its forty-fifth session on the implementation of the present resolution.
