APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS: APPOINTMENT OF MEMBERS OF THE INTERNATIONAL CIVIL SERVICE COMMISSION

Note by the Secretary-General

- 1. In his note of 22 February 1989 (A/44/106), the Secretary-General advised the General Assembly that the terms of office of five members of the International Civil Service Commission (ICSC) would expire on 31 December 1989 and that it would be necessary for the Assembly, at its forty-fourth session, to appoint five persons to fill the resulting vacancies for terms of office of four years, beginning on 1 January 1990.
- 2. The members of the Commission whose terms of office expire on 31 December 1989 are:
 - Mr. Michol Jean Bardoux (France)
 - Ms. Claudia Cooley (United States of America)
 - Mr. Antônio Fonsoca Pimentel (Brazil)
 - Mr. Alexis Stephanou (Greece)
 - Mr. Ku Tashiro (Japan)
- 3. In his note of 26 June 1989 (A/44/106/Add.1), the Secretary-General recalled the request of the General Assembly contained in paragraph 3 of section II of its resolution 43/226 of 21 December 1988 that, in the context of article 4 of the statute of the Commission, he should propose an appropriate deadline for the submission of candidatures for appointment to the Commission so as to allow for full and timely consultations with the three parties concerned, i.e., Member States, the executive heads of the other organizations and staff representatives. Consequently, the Secretary General proposed that a deadline of 15 October 1989 be established for the submission of candidatures for the five vacancies mentioned in paragraph 1 above.

- 4. In paragraph 4 of section II of the same resolution, the General Assembly also requested the Secretary-General, in his report to the Assembly at its forty-fourth session, to reflect the views resulting from the consultations referred to in paragraph 3 above.
- 5. In his note of 15 September 1989 (A/44/106/Add.2), the Secretary-General advised the General Assembly of the resignation of Mr. Karel Houska (Czechoslovakia) as a member of ICSC and that it would be necessary for the Assembly, at its forty-fourth session, to appoint a person to fill the unexpired portion of the term of office of Mr. Houska until 31 December 1990.
- 6. The Member States have submitted the following candidatures:
 - (a) For a four-year term of office beginning 1 January 1990:

(ii) For the Group of Latin American States (one va uncy):

Mr. Antônio Fonseca Pimentel (Brazil);

Ms. Claudia Cooley (United States of America);

Mr. Anthony Mango (United Kingdom of Great Britain and Northern Ireland);

Mr. Alexis Stephanou (Greece);

(b) For a one-year term of office beginning 1 January 1990:

Mr. Ladislav Šmíd (Czechoslovakia) for the unexpired portion of the term of office of Mr. Houska.

- 7. The appointment of the members of ICSC is governed by the provisions of articles 4 and 5 of the Commission's statute. Pursuant to these provisions, and in accordance with paragraphs 3 and 4 of General Assembly resolution 43/226, the Secretary-General is required to undertake consultations with Member States, through the Chairmen of the various regional groups, with the executive heads of the other organizations, with staff representatives through the Federation of International Civil Servants' Associations (FICSA) and the Co-ordinating Committee for Independent Staff Unions and Associations of the United Nations System (CCISUA), and with the Advisory Committee on Administrative and Budgetary Questions (ACABQ).
- 8. With regard to the consultations with Member States, to which reference is made in paragraph 7, it should be pointed out that, for the three vacancies arising in the Western L ropean and Other States group, all four nominations have been put forward by individual Member States, and none has received endorsement by the group as a whole.

- 9. On the occasion of the second regular session of the Administrative Committee on Co-ordination (ACC), which took place on 18 and 19 October 1989, the executive heads of the other organizations reviewed the list of candidatures received by the Secretary-General. Some executive heads stressed the need for continuity in the membership of the Commission in the context of the finalization of the comprehensive review of conditions of service and the forthcoming comprehensive review of pensions. Consequently, the executive heads considered it appropriate to endorse the four outgoing members who had been renominated by Member States. They also endorsed the candidature of Mr. Smid to serve for the unexpired portion of the term of office of Mr. Houska.
- 10. In early October, both FICSA and CCISUA ware requested to provide their views on the matter. No response has been received so far from either staff body.
- 11. On the basis of these consultations, the Secretary-General, in his capacity as Chairman of ACC, is now in the position to suggest that the Fifth Committee recommend to the General Assembly the following appointments to ICSC:
 - (a) For four-year terms of office beginning 1 January 1990:

 - Ms. Claudia Cooley (United States of America);
 - Mr. Antônio Fonseca Pimentel (Brazil);

Ladislav Šmíd

Mr. Ladislav Šmíd, Czechoslovakia, has been associated with the activities of various United Nations bodies since 1959. He participated in a number of the sessions of the General Assembly: in the fifteenth to nineteenth and in the twenty-eighth to thirty-fourth sessions, as well as in the sixth and seventh special sessions. He was Vice-Chairman of the Special Political Committee at the twenty-eighth session, Vice-Chairman of the Ad Hoc Committee of the seventh special session and Chairman of the Third Committee (social, humanitarian and cultural) at the thirtieth session.

He has also taken part in the work of the Security Council, the Economic and Social Council and some of its subsidiary bodies. He was Vice-Chairman of the Preparatory Committee of the United Nations Conference on Trade and Development (UNCTAD) in 1963-1964; Chairman of the Commission for Social Development, 1967; Vice-President of the Trade and Development Board of UNCTAD, 1969/70 and 1972/73; Vice-President of the Economic and Social Council, 1974-1976 (serving as Chairman of its Social Committee in 1974, Policy and Programme Co-ordination Committee in 1975 and Economic Committee in 1976) and President of the Economic and Social Council in 1977. In 1980-1982 he was a member of the Committee on Contributions.

He has also attended the meetings of the Economic Commission for Europe (ECE) and some of the specialized agencies of the United Nations, particularly UNESCO: he was a member of the UNESCO Executive Board in 1981-1985 and its Vice-Chairman in 1984-1985.

Mr. Šmíd was born on 16 July 1925 at Kladno, Czechoslovakia, and, prior to his entry into the Foreign Service of Czechoslovakia in 1956, he held the post of Associate Professor in Modern History, Social Sciences and Economics at Charles University at Prague.

While in the Foreign Service, he served at the Czechoslovak Embassy at New Delhi (1957-1959), and later as Deputy Head of the Department for International Organizations in the Ministry of Foreign Affairs (1960-1962). He was Deputy Permanent Representative of Czechoslovakia to the United Nations (1962-1965), Head of Division in the Federal Ministry of Foreign Affairs (1966-1972) and Permanent Representative of Czechoslovakia to the United Nations (1973-1977).
