APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS: APPOINTMENT OF MEMBERS OF THE ADVISORY COMMITTEE ON ADMINISTRATIVE AND BUDGETARY OUESTIONS

Note by the Secretary-General

- 1. As indicated in document A/44/101 of 22 February 1989, it will be necessary for the General Assembly, during its current session, to appoint six persons to fill vacancies in the membership of the Advisory Committee on Administrative and Budgetary Questions (ACABQ) resulting from the expiration, on 31 December 1989, of the terms of office of Ms. Maria Elisa de Bittencourt Berenguer, Mr. Michel Brochard, Mr. Tadanori Inomata, Mr. Ma Longde, Ms. Irmeli Mustonen and Mr. Banbit Roy.
- 2. Furthermore, in document A/44/101/Add.2, of 31 October 1989, the Secretary-General informed the General Assembly that Mr. Ferguson O. Iheme (Nigeria) had resigned from the membership of ACABQ and that, accordingly, the Assembly would be required at the same time to appoint a person to fill the unexpired portion of the term of office of Mr. Iheme, that is, until 31 December 1991.
