I. INTRODUCTION

- 1. At its 3rd plenary meeting, on 22 September 1989, the General Assembly, on the recommendation of the General Committee, decided to include in its agenda the item entitled "Report of the Economic and Social Council" and to allocate to the Second Committee chapters of the Council's report (A/44/3) 1/ that were considered under the relevant items of the agenda (see A/C.2/44/1).
- 2. In the context of item 12, the Second Committee considered the following questions referred by the Economic and Social Council to the General Assembly that did not fall within the purview of items specifically allocated to the Second Committee:
 - (a) Protection against products harmful to health and the environment;
 - (b) World Decade for Cultural Development;
 - (c) International economic security;
 - (d) World Tourism Organization;

- 5. At the 15th meeting, on 16 October, the Assistant Secretary-General for Development Research and Policy Analysis presented an oral report in pursuance of Economic and Social Council resolution 1989/112 (see A/C.2/44/SR.15).
- 6. At the same meeting, introductory statements were made by the Under-Secretary-General for International Economic and Social Affairs, the Assistant Director-General for Culture and Communications of the United Nations Educational, Scientific and Cultural Organization, and the Director of the Global Programme on AIDS of the World Health Organization. A statement was also made by the Executive Director of the World Food Council (see A/C.2/44/SR.15).
- 7. At the 20th meeting, on 25 October, the Under-Secretary-General for Special Political Questions, Regional Co-operation, Decolonization and Trusteeship made an introductory statement (see A/C.2/44/SR.20).

II. CONSIDERATION OF PROPOSALS

A. Draft resolution contained in document A/C.2/44/L.3

8. By its resolution 1989/121 of 28 July 1989, the Economic and Social Council recommended to the General Assembly the adoption of a draft resolution entitled "Target for World Food Programme pledges for the period 1991-1992" (see A/C.2/44/L.3).

- 9. At the 34th meeting, on 15 November, the Vice-Chairman of the Committee, Mr. David Bruce Payton (New Zealand), informed the Committee of the results of informal consultations held on draft resolution A/C.2/44/L.3.
- 10. At the same meeting, the Committee adopted draft resolution A/C.2/44/L.3 by consensus (see para. 17, draft resolution I).

B. Draft resolutions A/C.2/44/L.14 and L.39

11. At the 25th meeting, on 31 October, the representative of the <u>Union of Soviet Socialist Republics</u> introduced a draft resolution (A/C.2/44/L.14) entitled "Implementation of General Assembly resolution 42/165", which read as follows:

"The General Assembly,

"Recalling its resolution 42/165 of 11 December 1987,

"Noting the report of the Secretary-General on international economic security, $\underline{\mathbf{2}}/$

"Emphasizing the role of the United Nations and the interest felt by its States Members in strengthening international co-operation for ensuring sustained development, particularly in the developing countries, and balanced growth in the world economy,

- "1. Takes note with appreciation of the work undertaken by the Secretary-General on international economic security;
- "2. Recognizes that the discussions that have taken place on the subject have contributed to growing common understanding of economic interdependence and have played a useful role in the continuing efforts to increase the efficiency and effectiveness of United Nations economic activities and strengthen multilateral co-operation in international economic affairs to the benefit of all countries;
- "3. <u>Emphasizes</u> that constructive, universal and action-oriented dialogue aimed at revitalizing growth and development, in particular the development of developing countries, is essential if effective and co-ordinated approaches to international economic issues are to be found and international peace is to be strengthened;
- "4. Invites relevant organs and organizations of the United Nations and the United Nations system, in accordance with their respective mandates, to consider in their current activities the conclusions and recommendations contained in the report of the Secretary-General; $\underline{1}$ /

- "5. Requests the Secretary-General to take the present resolution into account when preparing documentation for the special session of the General Assembly devoted to international economic co-operation, in particular to the revitalization of economic growth and development of the developing countries."
- 12. At the same meeting, the Secretary of the Committee orally corrected operative paragraph 1 of the draft resolution by replacing the words "on international economic security" by the words "on the subject".
- 13. At the 34th meeting, on 15 November, the Vice-Chairman of the Committee, Mr. Badam Ochiryn Doljintseren (Mongolia), introduced a draft resolution (A/C.2/44/L.39) entitled "Report of the Secretary-General on General Assembly resolution 42/165", submitted on the basis of informal consultations held on draft resolution A/C.2/44/L.14.
- 14. At the same meeting, the Committee adopted draft resolution A/C.2/44/L.39 by consensus (see para. 17, draft resolution II).
- 15. After the adoption of the draft resolution, statements were made by the representatives of the Union of Soviet Socialist Republics, the United States of America and Japan.
- 16. In light of the adoption of draft resolution A/C.2/44/L.39, draft resolution A/C.2/44/L.14 was withdrawn by its sponsor.

III. RECOMMENDATIONS OF THE SECOND COMMITTEE

17. The Second Committee recommends to the General Assembly the adoption of the following draft resolutions:

DRAFT RESOLUTION I

Target for World Food Programme pledges for the period 1991-1992

The General Assembly,

Recalling the provisions of its resolutions 2095 (XX) of 20 December 1965 to the effect that the World Food Programme is to be reviewed before each pledging conference,

Recalling also the provisions of paragraph 4 of General Assembly resolution 42/164 of 11 December 1987 stipulating that, subject to the review mentioned above, the next pledging conference, at which Governments and appropriate donor organizations should be invited to pledge contributions for 1991 and 1992, with a view to reaching such a target as may then be recommended by the General Assembly and by the Conference of the Food and Agriculture Organization of the United Nations, should be convened not later than 1990,

Noting that the Programme was reviewed by the Committee on Food Aid Policies and Programmes of the World Food Programme at its twenty-seventh session and by the Economic and Social Council at its second regular session of 1989,

Having considered Economic and Social Council resolution 1989/121 of 28 July 1989, and the recommendation of the Committee on Food Aid Policies and Programmes,

Recognizing the value of and continuing need for multilateral food aid as provided by the World Food Programme, both as a form of capital investment and for meeting emergency food needs,

- 1. <u>Establishes</u> for the period 1991-1992 a target for voluntary contributions to the World Food Programme of \$1.5 billion, of which not less than one third should be in cash and/or services, and expresses the hope that those resources will be substantially augmented by additional contributions from other sources in view of the prospective volume of sound project requests and the capacity of the Programme to operate at a higher level;
- 2. <u>Urges</u> States Members of the United Nations and members and associate members of the Food and Agriculture Organization of the United Nations and appropriate donor organizations to make every effort to ensure that the target is fully attained;
- 3. Requests the Secretary-General, in co-operation with the Director-General of the Food and Agriculture Organization of the United Nations, to convene a pledging conference for this purpose at United Nations Headquarters early in 1990.

DRAFT RESOLUTION II

Report of the Secretary-General on General Assembly resolution 42/165

The General Assembly,

Recalling its resolution 42/165 of 11 December 1987, as adopted,

Taking note of the report of the Secretary-General on international economic security, 3/

Emphasizing the role of the United Nations and the interest of its Member States in strengthening international co-operation for ensuring sustained development, particularly in the developing countries, and balanced growth in the world economy,

- 1. Notes with appreciation the work undertaken by the Secretary-General on the subject;
- 2. Recognizes that the discussions that have taken place on the subject have contributed to a growing common understanding of economic interdependence and have played a useful role in the continuing efforts to increase the efficiency and effectiveness of United Nations economic activities and strengthen multilateral co-operation in international economic affairs to the benefit of all countries, especially developing countries;
- 3. <u>Emphasizes</u> that a universal, constructive and comprehensive dialogue aimed at revitalizing economic growth and development, in particular the development of developing countries, is essential if effective and co-operative approaches to international economic issues are to be found;
- 4. <u>Invites</u> the organs and organizations of the United Nations system concerned, in accordance with their respective mandates, to consider in their current activities the conclusions and recommendations contained in the report of the Secretary-General; <u>1</u>/
- 5. Requests the Secretary-General to take the present resolution into account when preparing his report for the special session of the General Assembly devoted to international economic co-operation, in particular to the revitalization of economic growth and development of the developing countries.
