Il/ The delegations of Cuba and Nicaragua said that, since the Committee did not have time to complete its consideration of all the items on the agenda of its 1985 session, they could, in a constructive spirit, agree to the Chairman' proposal to defer some items of the agenda, including that on quadrennial reports to the 1987 session. However, they wished to express their strong reservations at the fact that the Committee had been unable to consider at its current session the quadrennial report of the Inter-American Press Association, consideration of which had been deferred from the 1984 session to the 1985 session, since a number of delegations had voiced serious concern at the fact that the activities of that organization did not meet the requirements of the relevant resolutions of the Economic and Social Council.

The delegation of Sweden expressed its regret that the review of the quadrennial reports could not be carried out at the current session.
