## I. States parties to the Convention and its Optional Protocol

1. As at 13 September 2013, the closing date of the tenth session of the Committee on the Rights of Persons with Disabilities, there were 134 States parties to the Convention on the Rights of Persons with Disabilities and 77 States parties to its Optional Protocol.
2. The lists of States parties to the Convention and the Optional Protocol are contained in annex I of the present report.

## II. Opening of the tenth session of the Committee

3. The tenth session opened in a public meeting with welcoming remarks by the Chairperson of the Committee.
4. The opening statement of the Office of the United Nations High Commissioner for Human Rights (OHCHR) was delivered by the Chief of Development and Economic and Social Issues Branch, Research and Right to Development Division, who explained the events important to the work of the Committee that would take place at the sixty-eighth session of the General Assembly, due to start on 17 September 2013, including: the High Level Meeting on Disability and Development and the Millennium Development Goals in the post-2015 development agenda, which was to focus on increasing the inclusion of persons with disabilities in the global development goals; and the possible outcome of the treaty body strengthening process during the sixty-eighth session of the General Assembly. He also described the latest advancements for persons with disabilities in the broader United Nations system, such as: the draft bulletin on accessibility of the Secretary-General, which would set the ground for forthcoming work to provide accessible environments and practices within the United Nations; the adoption on 26 June 2013 of the Marrakesh Treaty to Facilitate Access to Published Works for Persons Who Are Blind, Visually Impaired, or Otherwise Print Disabled, negotiated under the auspices of the World Intellectual Property Organization (WIPO) and thereafter signed by 51 States; and the launching in May 2013 of the United Nations Children's Fund (UNICEF) *The State of the World's Children 2013* report focusing on children with disabilities, amongst others.
5. The Committee reviewed and adopted the provisional agenda and tentative programme of work for the tenth session (CRPD/C/10/1).
6. The Chairperson reported on the activities undertaken between the ninth and tenth sessions of the Committee.
7. The Committee issued a press release on the situation of persons with disabilities during the conflict in Syria.<sup>1</sup>

## III. Membership of the Committee

8. The list of members of the Committee as at 13 September 2013, indicating the duration of their terms of office, is contained in annex III to the present report. All members attended the tenth session.

#### **IV. Meeting with States parties**

9. The Committee held a meeting with States parties on 10 September 2013 in Palais Wilson, Geneva. The issues that were discussed included: the treaty bodies strengthening process and its implications for the Committee; the situation of overdue reports; accessibility to the Committee's meetings and to the United Nations in general; the possibility of introducing the simplified reporting procedure; the relationship between the Committee and the Conference of States Parties; and the importance of ensuring the inclusion of a disability-rights approach in the post-2015 agenda on development and disability. The following States took the floor during the meeting: Argentina, Austria, Australia, Chile, Israel, New Zealand, Norway, Slovenia and Thailand.

#### **V. Working methods**

10. The Committee discussed various issues related to its working methods and adopted several decisions in that regard. The Committee:

(a) Decided not to include the text of previously adopted documents in its future biennial reports to the Economic and Social Council and the General Assembly (e.g. concluding observations, general comments, session reports, etc.), and to make them analytical — providing an overview of trends during the relevant period — as opposed to narrative;

(b) Confirmed its practice of requesting combined second and third reports by States parties and decided to offer this possibility to States parties the reports of which were considered at the fifth, sixth, seventh and eighth sessions;

(c) Decided to adopt the simplified reporting procedure with regard to State parties' periodic reports. Under that procedure, the Committee prepares a list of issues prior to the State party submitting its report, and the answers of the State party to the list constitute its periodic report;

(d) Took note of the resignation of one of the co-facilitators of the Working Group on article 12 and appointed a new Chairperson to that Working Group;

(e) Appointed new country rapporteurs for Mexico and New Zealand and confirmed the appointment of other country rapporteurs for its upcoming eleventh session scheduled to take place in April 2014;

(f) Took note of the decision of the Working Group on Communications and Inquiries to discontinue the consideration of the first submission registered under the Committee's early warning and urgent action procedures, in view of the information provided by the State party concerned.

11. The Working Group on the drafting of guidelines for the participation of disabled persons' organizations and non-governmental organizations introduced an outline for the participation of such organizations in the work of the Committee. The Draft Guidelines are due to be presented at the eleventh session.

12. The list of Working Groups members and Rapporteurs of the Committee is contained in annex V to the present report.

## VI. Drafting of general comments

13. The Working Group on equal recognition before the law (article 12) submitted a proposal on a draft general comment for the consideration in plenary of the Committee, which decided to adopt it as a draft general comment. The draft general comment was to be posted on the OHCHR website as of 30 September 2013 for comments by the civil society and partners by early 2014.

14. The Working Group on accessibility (article 9) submitted a proposal on a draft general comment to the Committee in plenary, which decided to adopt it as a draft general comment. The draft was to be posted on the OHCHR website as of 30 September 2013 for comments by the civil society and partners by early 2014.

15. The Working Group on women and girls with disabilities (article 6), which is mandated to draft a general comment on the situation of women and girls with disabilities, agreed on its working methods and on a time frame for the adoption of a draft general comment, as well as on the general structure of that comment. The Working Group will report back to the Committee at its upcoming eleventh session in April 2014.

## VII. Activities related to the Optional Protocol

16. The Committee adopted its Views on communication No. 4/2011, *Bujdosó et al. v. Hungary* (CRPD/C/10/D/4/2011). The case relates to the disenfranchisement of persons with psychosocial or intellectual disabilities of their right to vote. The communication raises the failure by the State party's authorities to eliminate discrimination on the ground of disability, and to respect the obligation to guarantee to persons with disabilities political rights, including the right to vote, on an equal basis with other citizens. The Committee found violations to article 29 of the Convention (participation in political and public life) read alone and in conjunction with article 12 of the Convention (equal recognition before the law).

17. The Committee adopted the note by the Secretary-General on actions taken with regard to all the submissions received between the ninth and tenth session. In the period covered, the Committee received 42 communications, which brings the total of submissions received by the Committee since its creation to 309. All correspondence (related to States parties to the Optional Protocol to the Convention on the Rights of Persons with Disabilities or to States that are not party to the Optional Protocol) has been acknowledged and responses sent.

18. The Committee considered the report of the Rapporteur on New Communications and the report of the Rapporteur on Follow-up to Views on Communications. The Committee also adopted its interim follow-up report with regard the views adopted in *H.M. v. Sweden* (CRPD/C/7/D/3/2011).

19. The Committee appointed a rapporteur to further examine the information related to the first submission registered under the Committee's inquiry procedure. The Committee requested the rapporteur to formulate a course of action for the Committee's consideration.

## VIII. Other decisions

20. The Committee adopted the report of its ninth session (CRPD/C/9/2).

21. The Committee took a number of other decisions, which are listed in annex IV of the present report.

## **IX. Future sessions**

22. The eleventh session of the Committee is scheduled to take place from 31 March to 11 April 2014. For the very first time, the Committee has been allocated session time for a pre-session working group which will take place from 14 to 17 April 2014.

23. The Committee decided that at its next session it would review the initial reports of Azerbaijan (CRPD/C/AZE/1), Costa Rica (CRPD/C/CRI/1) and Sweden (CRPD/C/SWE/1), and adopt lists of issues on the initial reports of Belgium (CRPD/C/BEL/1), Denmark (CRPD/C/DNK/1), Ecuador (CRPD/C/ECU/1), Germany (CRPD/C/DEU/1), Mexico (CRPD/C/MEX/1), New Zealand (CRPD/C/NZL/1) and Republic of Korea (CRPD/C/KOR/1).

## **X. Accessibility of the Committee's meetings**

24. The Committee instructed the Secretariat to disseminate the findings of the Study of Microsoft, Middlesex University and AbilityNet on the accessibility to the Committee's meetings.

25. The Bureau of the Committee held a discussion with the President of Human Rights Council and the Chair of the Human Rights Council's Task Force on Accessibility on ways to increase their cooperation with a view to making the United Nations a more accessible environment for persons with disabilities.

26. The accessibility of Committee meetings benefited from further improvements and captioning was provided at all public and private meetings, although there were some disruptions. International sign language interpretation was provided during all public meetings, in addition to El Salvadorian sign language and Australian sign language during the dialogues with the respective countries. Hearing loops were provided by the United Nations Conferences Services to facilitate the participation of a Committee expert and were tested on a provisional basis. Further improvements have been identified, *inter alia*, in the following areas: accessible accommodation and services in Geneva, increased awareness of the Convention by United Nations staff members in Geneva, travel of experts, transcription of Braille documents, quality of sign language interpretation, recognition of reasonable accommodation for experts and participants with disabilities, accessibility to information, communication and technology, as well as physical accessibility to conference rooms at the Palais des Nations and Palais Wilson.

## **XI. Cooperation with relevant bodies**

### **A. Cooperation with other United Nations organs and specialized agencies**

27. On 2 September 2013, at its 104th meeting, the Committee met with the representatives of the Office of the High Commissioner for Human Rights (OHCHR), WIPO, UNICEF, and the International Labour Organization to discuss ways of cooperation, as provided for under article 38 of the Convention. The Committee met with representatives of World Health Organization (WHO) Secretariat and provided inputs to the WHO Draft Disability Action Plan "Better health for persons with disabilities".

## **B. Cooperation with non-governmental organizations and other concerned bodies**

28. At its 104th meeting on 2 September 2013, the Committee was addressed by representatives of the non-governmental organizations International Disability Alliance, World Network of Users and Survivors of Psychiatry, Disability Council International, Association suisse d'aide aux personnes avec un handicap mental, International Disability and Development Consortium and Human Rights Watch. The Committee also met with representatives of Disability Rights Promotion International, who introduced the initial findings of its global project on monitoring the implementation of the Convention

29. During the meeting, the Committee also met with representatives of the Council of Europe and the Implementation Support Unit of the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction to discuss ways to cooperate.

## **XII. Consideration of reports submitted in accordance with article 35 of the Convention**

30. The Committee considered the initial report of Austria (CRPD/C/AUT/1) at its 105th and 106th meetings held on 2 and 3 September 2013; the initial report of Australia (CRPD/C/AUS/1) at its 107th and 108th meetings held on 3 and 4 September 2013; and the initial report of El Salvador (CRPD/C/SLV/1) at its 109th and 110th meetings held on 4 and 6 September 2013. The Committee adopted concluding observations on the reports at its 121st meeting (see the Committee's webpage at <http://www.ohchr.org/EN/HRBodies/CRPD/Pages/CRPDIndex.aspx>).

31. As a salient development of the Committee's working methods in dealing with States party reports, the Committee accepted the participation of independent national monitoring mechanisms during the dialogue with the delegations of two States parties whose initial reports were considered during the session.

## **XIII. Conference of State parties to the Convention**

### **Sixth Conference of States Parties**

32. From 17 to 19 July 2013, the Chairperson and one of the Vice-Chairpersons of the Committee represented the Committee at the sixth Conference of States Parties in New York. The theme of the Conference of State Parties was "Ensuring an adequate standard of living: empowerment and participation of persons with disabilities within the framework of the Convention on the Rights of Persons with Disabilities". The Chairperson delivered a statement in which she emphasized the importance of mainstreaming disability rights in the post-2015 development agenda. She also briefed the Conference of States parties on the most recent developments in the Committee's methods of work.

33. Other experts present at the Conference intervened as speakers at various side events on persons with disabilities.

34. The Chairperson co-organized with the Chair of the Committee against Torture a side event on the "Intersectionality between the Convention on the Rights of Persons with Disabilities and the Convention against Torture with relation to persons with disabilities",

at which occasion the Vice-Chairperson made a presentation on the Committee's jurisprudence.

35. At the occasion of a side event on "Disability and indigenous peoples: an ongoing challenge", the Chairperson delivered opening remarks on the topic of persons with disabilities and indigenous persons. At a side event on "The interface between ageing and disability: post-2015 development agenda", the Chairperson also delivered opening remarks on persons with disabilities and older adults.

## Annex IV

### Decisions adopted by the Committee during its tenth session

1. To offer States parties the reports of which were considered at the fifth, sixth, seventh and eighth sessions the possibility of submitting combined second and third reports.
2. To offer State parties the reports of which have already been considered at previous sessions the possibility of opting for the simplified reporting procedure in relation to their periodic reports.
3. To grant civil society and other stakeholders the possibility of providing comments on its two draft general comments on equal recognition before the law (art. 12) and accessibility (art. 9), until 31 January 2014.
4. To prepare a letter addressed to the Chair of the Human Rights Committee to express its concerns about the alleged incompatibility of paragraph 19 of the draft general comment on the right to liberty and security, prepared by the Human Rights Committee, with the Convention on the Rights of Persons with Disabilities.
5. To prepare a letter to the open-ended intergovernmental Expert Group on the Standard Minimum Rules for the Treatment of Prisoners expressing the Committee's concerns about the perceived incompatibility of some of the draft revised provisions of the Standard Minimum Rules with the Convention.
6. To appoint Diane Mulligan and Mohammed Al-Tarawneh to represent the Committee at a meeting with the Subcommittee on the Prevention of Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment in Bristol, United Kingdom. The Committee also instructed the Secretariat to attend that meeting.
7. To reaffirm its support to the treaty body strengthening process, welcoming the fact that the draft elements included a reference to the accessibility of the treaty bodies meetings for persons with disabilities and the requirement of reasonable accommodation for experts with disabilities, and draft a letter in support of the process.
8. To appoint two new country rapporteurs and confirm the appointment of the following country rapporteurs for its upcoming eleventh session scheduled to take place in April 2014. For concluding observations, they are: Sweden: Stig Langvad; Azerbaijan: Mwesigwa Martin Babu; and Costa Rica: Silvia Quan-Chang. For lists of issues, they are: New Zealand: Ron McCallum; Mexico: Ana Peláez Narváez; Republic of Korea: Monthian Buntan; Belgium: Lotfi Ben Lallahom; Denmark: Mwesigwa Martin Babu; Ecuador: Carlos Ríos Espinosa; Germany: Diane Mulligan.
9. To adopt a statement on persons with disabilities being forgotten victims of the Syrian conflict.
