ORGANIZATION OF THE FORTY-FOURTH REGULAR SESSION OF THE GENERAL ASSEMBLY, ADOPTION OF THE AGENDA AND ALLOCATION OF ITEMS:

- (a) REQUEST FOR THE INCLUSION OF AN ADDITIONAL ITEM SUBMITTED BY THE SECRETARY-GENERAL (A/44/246 and Add.1);
- (b) REQUEST FOR THE INCLUSION OF AN ADDITIONAL SUB-ITEM SUBMITTED BY THE SECRETARY-GENERAL (A/44/247)

1. <u>The CHAIRMAN</u> drew attention to document A/44/246 and Add.1 containing a request by the Secretary-General for the inclusion in the agenda of the forty-fourth session of an additional item of an important and urgent character, entitled "Financing of the United Nations Observer Group in Central America". The Secretary-General further requested that the item should be allocated to the Fifth Committee.

2. <u>The Committee decided to recommend that the General Assembly should include</u> the additional item in the agenda and that the item should be allocated to the Fifth Committee.

3. <u>The CHAIRMAN</u> drew attention to document A/44/247, in which the General Assembly was requested by the Secretary-General to include under agenda item 16 (Elections to fill vacancies in subsidiary organs) a new sub-item entitled "Election of the United Nations High Commissioner for Refugees", and also to amend the title of agenda item 16 to read "Elections to fill vacancies in subsidiary organs and other elections".

4. The Committee decided to recommend that the General Assembly should include the additional sub-item in the agenda and should amend the title of agenda item 16, and that the sub-item should be considered directly in plenary meeting.
