TRIBUTE TO THE MEMORY OF MR. I. M. PEDANYUK,
REPRESENTATIVE OF THE UKRAINIAN SOVIET
SOCIALIST REPUBLIC ON THE FIFTH COMMITTEE

1. The CHAIRMAN paid tribute to the memory of Mr. Ivan M. Pedanyuk, whose outstanding qualities the Committee had come to know in a very short period of time. He extended his condolences and those of the entire Committee to the Ukrainian delegation, the Government of the Ukrainian Soviet Socialist Republic and Mr. Pedanyuk's family.

3. Mr. BANNIER (Chairman, Advisory Committee on Administrative and Budgetary Questions) extended the Advisory Committee's condolences to the Ukrainian delegation.
