**Right of peoples to self-determination****Report of the Third Committee***Rapporteur:* Ms. Adele Li Wei (Singapore)**I. Introduction**

1. At its 2nd plenary meeting, on 18 September 2015, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventieth session the item entitled “Right of peoples to self-determination” and to allocate it to the Third Committee.

2. The Third Committee held a general discussion on the item jointly with item 70, entitled “Elimination of racism, racial discrimination, xenophobia and related intolerance”, at its 37th to 39th meetings, on 2 and 3 November 2015, and considered proposals and took action on item 71 at its 43rd, 45th, 48th, 52nd and 53rd meetings, on 5, 10, 17 and 20 November. An account of the Committee’s discussion is contained in the relevant summary records.<sup>1</sup>

3. For its consideration of the item, the Committee had before it the following documents:

(a) Report of the Secretary-General on the right of peoples to self-determination (A/70/314);

(b) Note by the Secretary-General transmitting the report of the Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination (A/70/330).

4. At the 37th meeting, on 2 November, the Deputy a.i. to the Head of the Office of the United Nations High Commissioner for Human Rights in New York made an introductory statement and responded to questions raised and comments made by the representatives of Algeria and Cameroon.

5. At the same meeting, the Chair of the Working Group of Experts on People of African Descent made an introductory statement and engaged in an interactive dialogue with the representatives of Morocco, the European Union, Algeria, Mexico, Nigeria and Cameroon.

6. Also at the same meeting, the Chair of the Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination made an oral report and engaged in an interactive dialogue with the representatives of Morocco, Cuba, the European Union and Belgium.

7. At the same meeting, the Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance made an introductory statement and engaged in an interactive dialogue with the representatives of Brazil, Morocco, the European Union, Mexico, the Russian Federation, Armenia, Nigeria, Turkey and the United States of America.

## II. Consideration of proposals

### A. Draft resolution [A/C.3/70/L.42](#)

8. At the 43rd meeting, on 5 November, the representative of Egypt, on behalf of the States Members of the United Nations that are members of the Organization of Islamic Cooperation and Armenia, Bolivia (Plurinational State of), Cabo Verde, Cuba, the Democratic People's Republic of Korea, Ecuador, Nicaragua, Saint Vincent and the Grenadines, Sri Lanka, the former Yugoslav Republic of Macedonia, Venezuela (Bolivarian Republic of), Viet Nam and the State of Palestine, introduced a draft resolution entitled "The right of the Palestinian people to self-determination" ([A/C.3/70/L.42](#)) and orally corrected preambular paragraph 11.<sup>2</sup>

9. Subsequently, Andorra, Angola, Austria, Belarus, Belgium, Belize, Bosnia and Herzegovina, Brazil, Bulgaria, Burundi, Chile, China, Costa Rica, Croatia, Cyprus, the Czech Republic, the Democratic Republic of the Congo, Denmark, El Salvador, Eritrea, Estonia, Ethiopia, Finland, France, Germany, Ghana, Greece, Grenada, Hungary, Iceland, Ireland, Italy, Jamaica, the Lao People's Democratic Republic, Latvia, Lesotho, Liberia, Liechtenstein, Lithuania, Luxembourg, Madagascar, Malta, Mauritius, Monaco, Montenegro, Myanmar, Namibia, the Netherlands, New Zealand, Norway, Peru, Poland, Portugal, the Republic of Moldova, Romania, the Russian Federation, Rwanda, San Marino, Serbia, Seychelles, Slovakia, Slovenia, South Africa, Spain, Sweden, Switzerland, Timor-Leste, Ukraine, the United Kingdom of Great Britain and Northern Ireland, the United Republic of Tanzania, Uruguay, Zambia and Zimbabwe joined in co-sponsoring the draft resolution.

10. At its 53rd meeting, on 20 November, the Committee adopted draft resolution [A/C.3/70/L.42](#), as orally corrected, by a recorded vote of 170 to 6, with 4 abstentions (see para. 22, draft resolution I). The voting was as follows:<sup>3</sup>

11. Before the vote, a statement was made by the representative of Israel; after the vote, statements were made by the representative of Argentina and the observer of the State of Palestine.

**B. Draft resolution [A/C.3/70/L.58](#)**

12. At the 48th meeting, on 17 November, the representative of Cuba, on behalf of Algeria, Belarus, Bolivia (Plurinational State of), China, Cuba, the Democratic People's Republic of Korea, Ecuador, Eritrea, Libya, Nicaragua, Sri Lanka, the Sudan, the Syrian Arab Republic and Venezuela (Bolivarian Republic of), introduced a draft resolution entitled "Use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination" ([A/C.3/70/L.58](#)).

13. At the 53rd meeting, on 20 November, the representative of Cuba made a statement.

14. Subsequently, Angola, Antigua and Barbuda, Benin, Brazil, Burundi, the Central African Republic, Chile, the Comoros, the Congo, Côte d'Ivoire, the Dominican Republic, Egypt, El Salvador, Ethiopia, Ghana, Guinea, India, Iran (Islamic Republic of), the Lao People's Democratic Republic, Lesotho, Madagascar, Malaysia, Myanmar, Namibia, the Niger, Nigeria, Peru, Saint Vincent and the Grenadines, Senegal, South Africa, South Sudan, Uganda, the United Republic of Tanzania, Uruguay and Zimbabwe joined in co-sponsoring the draft resolution.

15. At the same meeting, the Committee adopted draft resolution [A/C.3/70/L.58](#) by a recorded vote of 121 to 53, with 6 abstentions (see para. 22, draft resolution II). The voting was as follows:

At the 45th meeting, on 10 November, the representative of Pakistan, on behalf of Algeria, Armenia, Azerbaijan, Bahrain, Bangladesh, Belarus, Benin, Bolivia (Plurinational State of), Burkina Faso, Cameroon, Chad, China, the Comoros, Ecuador, Egypt, Grenada, Guinea, Guyana, Haiti, Iran (Islamic Republic of), Jordan, Kuwait, Kyrgyzstan, Lebanon, Libya, Madagascar, Malaysia, Mauritania, Mozambique, Nicaragua, the Niger, Nigeria, Oman, Pakistan, Palau, Qatar, the Russian Federation, Saudi Arabia, Sierra Leone, Singapore, the Sudan, Thailand, Togo, Tunisia, the United Arab Emirates, Venezuela (Bolivarian Republic of) and Viet Nam, introduced a draft resolution entitled “Universal realization of the right of peoples to self-determination” ([A/C.3/70/L.60](#)).

18. At the 52nd meeting, on 20 November, the representative of Pakistan made a statement.

19. Subsequently, Albania, Angola, Antigua and Barbuda, Belize, Brazil, Brunei Darussalam, Burundi, the Central African Republic, the Congo, Côte d’Ivoire, El Salvador, Eritrea, Ghana, Honduras, Jamaica, Kenya, Lesotho, Liberia, Maldives, Mauritius, Namibia, Paraguay, Rwanda, Senegal, Seychelles, Somalia, South Sudan, Swaziland, Tajikistan, Uganda, the United Republic of Tanzania, Zambia and Zimbabwe joined in co-sponsoring the draft resolution.

20. At the same meeting, the Committee adopted draft resolution [A/C.3/70/L.60](#) (see para. 22, draft resolution III).

21. After the adoption of the draft resolution, statements were made by the representatives of the United States of America, Argentina and Spain.

### III. Recommendations of the Third Committee

22. The Third Committee recommends to the General Assembly the adoption of the following draft resolutions:

#### **Draft resolution I** **The right of the Palestinian people to self-determination**

*The General Assembly,*

*Aware* that the development of friendly relations among nations, based on respect for the principle of equal rights and self-determination of peoples, is among the purposes and principles of the United Nations, as defined in the Charter,

*Recalling*, in this regard, its resolution 2625 (XXV) of 24 October 1970, entitled “Declaration on Principles of International Law concerning Friendly Relations and Cooperation among States in accordance with the Charter of the United Nations”,

*Bearing in mind* the International Covenants on Human Rights,<sup>1</sup> the Universal Declaration of Human Rights,<sup>2</sup> the Declaration on the Granting of Independence to Colonial Countries and Peoples<sup>3</sup> and the Vienna Declaration and Programme of Action adopted at the World Conference on Human Rights on 25 June 1993,<sup>4</sup>

*Recalling* the Declaration on the Occasion of the Fiftieth Anniversary of the United Nations,<sup>5</sup>

*Recalling also* the United Nations Millennium Declaration,<sup>6</sup>

*Recalling further* the advisory opinion rendered on 9 July 2004 by the International Court of Justice on the legal consequences of the construction of a wall in the Occupied Palestinian Territory,<sup>7</sup> and noting in particular the reply of the Court, including on the right of peoples to self-determination, which is a right *erga omnes*,<sup>8</sup>

*Recalling* the conclusion of the Court, in its advisory opinion of 9 July 2004, that the construction of the wall by Israel, the occupying Power, in the Occupied Palestinian Territory, including East Jerusalem, along with measures previously taken, severely impedes the right of the Palestinian people to self-determination,<sup>9</sup>

*Stressing* the urgency of achieving without delay an end to the Israeli occupation that began in 1967 and a just, lasting and comprehensive peace settlement between the Palestinian and Israeli sides, based on the relevant resolutions of the United Nations, the Madrid terms of reference, including the

principle of land for peace, the Arab Peace Initiative<sup>10</sup> and the Quartet road map to a permanent two-State solution to the Israeli-Palestinian conflict,<sup>11</sup>

*Stressing also* the need for respect for and preservation of the territorial unity, contiguity and integrity of all of the Occupied Palestinian Territory, including East Jerusalem, and recalling in this regard its resolution 58/292 of 6 May 2004,

*Recalling* its resolution 69/165 of 18 December 2014,

*Recalling also* its resolution 67/19 of 29 November 2012,

*Affirming* the right of all States in the region to live in peace within secure and internationally recognized borders,

1. *Reaffirms* the right of the Palestinian people to self-determination, including the right to their independent State of Palestine;

2. *Urges* all States and the specialized agencies and organizations of the United Nations system to continue to support and assist the Palestinian people in the early realization of their right to self-determination.

## **Draft resolution II**

### **Use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination**

*The General Assembly,*

*Recalling* all of its previous resolutions on the subject, including resolution 69/163 of 18 December 2014, and Human Rights Council resolutions 15/12 of 30 September 2010,<sup>1</sup> 15/26 of 1 October 2010,<sup>2</sup> 18/4 of 29 September 2011,<sup>3</sup> 21/8 of 27 September 2012,<sup>4</sup> 24/13 of 26 September 2013,<sup>5</sup> 27/10 of 25 September 2014<sup>6</sup> and 30/6 of 1 October 2015, as well as all resolutions adopted by the Commission on Human Rights in this regard,

*Recalling also* all of its relevant resolutions, in which, inter alia, it condemned any State that permitted or tolerated the recruitment, financing, training, assembly, transit or use of mercenaries with the objective of overthrowing the Governments of States Members of the United Nations, especially those of developing countries, or of fighting against national liberation movements, and recalling further the relevant resolutions and international instruments adopted by the General Assembly, the Security Council, the Economic and Social Council and the Organization of African Unity, inter alia, the Organization of African Unity Convention for the elimination of mercenarism in Africa,<sup>7</sup> as well as by the African Union,

*Reaffirming* the purposes and principles enshrined in the Charter of the United Nations concerning the strict observance of the principles of sovereign equality, political independence, the territorial integrity of States, the self-determination of peoples, the non-use of force or of the threat of use of force in international relations and non-interference in affairs within the domestic jurisdiction of States,

*Reaffirming also* that, by virtue of the principle of self-determination, all peoples have the right freely to determine their political status and to pursue their economic, social and cultural development and that every State has the duty to respect this right in accordance with the provisions of the Charter,

*Reaffirming further* the Declaration on Principles of International Law concerning Friendly Relations and Cooperation among States in accordance with the Charter of the United Nations,<sup>8</sup>

*Welcoming* the establishment of the open-ended intergovernmental working group of the Human Rights Council with the mandate of considering the possibility of elaborating an international regulatory framework, including the option of

elaborating a legally binding instrument on the regulation, monitoring and oversight of the activities of private military and security companies,

*Alarmed and concerned* at the danger that the activities of mercenaries constitute to peace and security in developing countries in various parts of the world, in particular in areas of conflict,

*Deeply concerned* at the loss of life, the substantial damage to property and the negative effects on the policy and economies of affected countries resulting from international criminal mercenary activities,

*Extremely alarmed and concerned* about recent mercenary activities in some developing countries in various parts of the world, including in areas of armed conflict, and the threat they pose to the integrity of and respect for the constitutional order of the affected countries,

*Convinced* that, notwithstanding the way in which mercenaries or mercenary-related activities are used or the form that they take to acquire some semblance of legitimacy, they are a threat to peace, security and the self-determination of peoples and an obstacle to the enjoyment of all human rights by peoples,

1. *Acknowledges with appreciation* the work and contributions of the Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination, including its research activities, and takes note with appreciation of its latest report;<sup>9</sup>

2. *Reaffirms* that the use of mercenaries and their recruitment, financing, protection and training are causes for grave concern to all States and violate the purposes and principles enshrined in the Charter of the United Nations;

3. *Recognizes* that armed conflict, terrorism, arms trafficking and covert operations by third Powers encourage, inter alia, the demand for mercenaries on the global market;

4. *Urges once again* all States to take the steps necessary and to exercise the utmost vigilance against the menace posed by the activities of mercenaries and to take legislative measures to ensure that their territories and other territories under their control, as well as their nationals, are not used for the recruitment, assembly, financing, training, protection or transit of mercenaries for the planning of activities designed to impede the right of peoples to self-determination, to destabilize or overthrow the Government of any State or to dismember or impair, totally or in part, the territorial integrity or political unity of sovereign and independent States conducting themselves in compliance with the right of peoples to self-determination;

5. *Requests* all States to exercise the utmost vigilance against any kind of recruitment, training, hiring or financing of mercenaries by private companies offering international military consultancy and security services, as well as to impose a specific ban on such companies intervening in armed conflicts or actions to destabilize constitutional regimes;

6. *Encourages* States that import the military assistance, consultancy and security services provided by private companies to establish regulatory national

mechanisms for the registering and licensing of those companies in order to ensure that imported services provided by those private companies neither impede the enjoyment of human rights nor violate human rights in the recipient country;

7. *Emphasizes its utmost concern* about the impact of the activities of private military and security companies on the enjoyment of human rights, in particular when operating in armed conflicts, and notes that private military and security companies and their personnel are rarely held accountable for violations of human rights;

8. *Calls upon* all States that have not yet done so to consider taking the action necessary to accede to or ratify the International Convention against the Recruitment, Use, Financing and Training of Mercenaries;<sup>10</sup>

9. *Welcomes* the cooperation extended by those countries that received a visit by the Working Group on the use of mercenaries and the adoption by some States of national legislation that restricts the recruitment, assembly, financing, training and transit of mercenaries;

10. *Condemns* recent mercenary activities in developing countries in various parts of the world, in particular in areas of conflict, and the threat they pose to the integrity of and respect for the constitutional order of those countries and the exercise of the right of their peoples to self-determination, and stresses the importance for the Working Group on the use of mercenaries of looking into sources and root causes, as well as the political motivations of mercenaries and for mercenary-related activities;

11. *Calls upon* States to investigate the possibility of mercenary involvement whenever and wherever criminal acts of a terrorist nature occur and to bring to trial those found responsible or to consider their extradition, if so requested, in accordance with national law and applicable bilateral or international treaties;

12. *Condemns* any form of impunity granted to perpetrators of mercenary activities and to those responsible for the use, recruitment, financing and training of mercenaries, and urges all States, in accordance with their obligations under international law, to bring them, without distinction, to justice;

13. *Calls upon* Member States, in accordance with their obligations under international law, to cooperate with and assist the judicial prosecution of those accused of mercenary activities in transparent, open and fair trials;

14. *Acknowledges with appreciation* the work and contributions made by the Working Group on the use of mercenaries, including its research activities, and takes note of its latest report;<sup>11</sup>

15. *Recalls* the holding of the fourth session of the open-ended intergovernmental working group to consider the possibility of elaborating an international regulatory framework on the regulation, monitoring and oversight of the activities of private military and security companies, expresses satisfaction at the participation of experts, including of the members of the Working Group on the use of mercenaries, as resource persons at the above-mentioned session, and

requests the Working Group and other experts to continue their participation during the fifth session of the open-ended intergovernmental working group;

16. *Welcomes* the holding of the panel on the phenomenon of foreign fighters, held in New York on 23 July 2015, and recognizes the efforts of the Working Group on the use of mercenaries in its organization;

17. *Requests* the Working Group on the use of mercenaries to continue the work already done by previous Special Rapporteurs on the use of mercenaries on the strengthening of the international legal framework for the prevention and sanction of the recruitment, use, financing and training of mercenaries, taking into account the proposal for a new legal definition of a mercenary drafted by the Special Rapporteur on the use of mercenaries as a means of impeding the exercise of the right of peoples to self-determination in his report to the Commission on Human Rights at its sixtieth session;<sup>12</sup>

18. *Also requests* the Working Group on the use of mercenaries to continue to study and identify sources and causes, emerging issues, manifestations and trends regarding mercenaries or mercenary-related activities and their impact on human rights, particularly on the right of peoples to self-determination;

19. *Requests* the Office of the United Nations High Commissioner for Human Rights, as a matter of priority, to publicize the adverse effects of the activities of mercenaries on the right of peoples to self-determination and, when requested and where necessary, to render advisory services to States that are affected by those activities;

20. *Recommends* that all Member States, including those confronted with the phenomenon of private military and security companies, as contracting States, States of operations, home States or States whose nationals are employed to work for a private military and security company, contribute to the work of the open-ended intergovernmental working group, taking into account the initial work done by the Working Group on the use of mercenaries;

21. *Urges* all States to cooperate fully with the Working Group on the use of mercenaries in the fulfilment of its mandate;

22. *Requests* the Secretary-General and the United Nations High Commissioner for Human Rights to continue to provide the Working Group on the use of mercenaries with all the assistance and support necessary for the fulfilment of its mandate, both professional and financial, including through the promotion of cooperation between the Working Group and other components of the United Nations system that deal with countering mercenary-related activities, in order to meet the demands of its current and future activities;

23. *Requests* the Working Group on the use of mercenaries to consult States and intergovernmental and non-governmental organizations in the implementation of the present resolution and to report, with specific recommendations, to the General Assembly at its seventy-first session its findings on the use of mercenaries to undermine the enjoyment of all human rights and to impede the exercise of the right of peoples to self-determination;

24. *Decides* to consider at its seventy-first session the question of the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination under the item entitled “Right of peoples to self-determination”.

### **Draft resolution III**

## **Universal realization of the right of peoples to self-determination**

*The General Assembly,*

*Reaffirming* the importance, for the effective guarantee and observance of human rights, of the universal realization of the right of peoples to self-determination enshrined in the Charter of the United Nations and embodied in the International Covenants on Human Rights,<sup>1</sup> as well as in the Declaration on the Granting of Independence to Colonial Countries and Peoples contained in General Assembly resolution 1514 (XV) of 14 December 1960,

*Welcoming* the progressive exercise of the right to self-determination by peoples under colonial, foreign or alien occupation and their emergence into sovereign statehood and independence,

*Deeply concerned* at the continuation of acts or threats of foreign military intervention and occupation that are threatening to suppress, or have already suppressed, the right to self-determination of peoples and nations,

*Expressing grave concern* that, as a consequence of the persistence of such actions, millions of people have been and are being uprooted from their homes as refugees and displaced persons, and emphasizing the urgent need for concerted international action to alleviate their condition,

*Recalling* the relevant resolutions regarding the violation of the right of peoples to self-determination and other human rights as a result of foreign military intervention, aggression and occupation adopted by the Commission on Human Rights at its sixty-first<sup>2</sup> and previous sessions,

*Reaffirming* its previous resolutions on the universal realization of the right of peoples to self-determination, including resolution 69/164 of 18 December 2014,

*Reaffirming also* its resolution 55/2 of 8 September 2000, containing the United Nations Millennium Declaration, and recalling its resolution 60/1 of 16 September 2005, containing the 2005 World Summit Outcome, which, inter alia, upheld the right to self-determination of peoples under colonial domination and foreign occupation,

*Taking note* of the report of the Secretary-General on the right of peoples to self-determination,<sup>3</sup>

1. *Reaffirms* that the universal realization of the right of all peoples, including those under colonial, foreign and alien domination, to self-determination is a fundamental condition for the effective guarantee and observance of human rights and for the preservation and promotion of such rights;

2. *Declares its firm opposition* to acts of foreign military intervention, aggression and occupation, since these have resulted in the suppression of the right of peoples to self-determination and other human rights in certain parts of the world;

3. *Calls upon* those States responsible to cease immediately their military intervention in and occupation of foreign countries and territories and all acts of repression, discrimination, exploitation and maltreatment, in particular the brutal and inhuman methods reportedly employed for the execution of those acts against the peoples concerned;

4. *Deplores* the plight of millions of refugees and displaced persons who have been uprooted as a result of the aforementioned acts, and reaffirms their right to return to their homes voluntarily in safety and with honour;

5. *Requests* the Human Rights Council to continue to give special attention to violations of human rights, especially the right to self-determination, resulting from foreign military intervention, aggression or occupation;

6. *Requests* the Secretary-General to report on the question to the General Assembly at its seventy-first session under the item entitled "Right of peoples to self-determination".
