DEVELOPMENT AND INTERNATIONAL ECONOMIC CO-OPERATION

Report of the Second Committee (Part I)*

I. INTRODUCTION

1. At its 3rd plenary meeting, on 22 September 1989, the General Assembly, on the recommendation of the General Committee, decided to include in its agenda the item entitled:

"Development and international economic co-operation":

"(a) Preparation of an international development strategy for the fourth United Nations development decade (1991-2000);

"(b) Trade and development;

"(c) Charter of Economic Rights and Duties of States;

"(d) Effective mobilization and integration of women in development;

"(e) Economic and technical co-operation among developing countries;

"(f) Environment;

"(g) Desertification and drought;

"(h) Human settlements;

"(j) Environmental protection of extraterritorial spaces for present and future generations"

and to allocate it to the Second Committee.

2.
