ВЫБОРЫ ЧЛЕНОВ ПОДКОМИССИИ ПО ПРЕДУПРЕЖДЕНИЮ ДИСКРИМИНАЦИИ И ЗАЩИТЕ МЕНЬШИНСТВ

Записка Генерального секретаря

- 1. В соответствии с резолюциями 1334 (XLIV) от 31 мая 1968 года и 1986/35 от 23 мая 1986 года и решениями 1978/21 от 5 мая 1978 года и 1987/102 от 6 февраля 1987 года Экономического и Социального Совета Комиссия по правам человека на своей сорок четвертой сессии (39-е заседание, 29 февраля 1988 года) избрала тайным голосованием 26 членов Подкомиссии по предупреждению дискриминации и защите меньшинств из числа экспертов, выдвинутых государствами членами Организации Объединенных Наций, на следующей основе: а) семь членов от африканских государств; b) пять от азиатских государств; c) три от восточноевропейских государств; d) пять от латиноамериканских государств; e) шесть от западноевропейских и других государств.
- 2. Согласно резолюции 1986/35 Совета члены Подкомиссии избираются сроком на четыре года, а половина членского состава Подкомиссии и соответствующих заместителей, если таковые имеются, избирается каждые два года. Председатель сорок четвертой сессии Комиссии по правам человека провел жеребьевку с целью избрания членов и, в случае необходимости, их соответствующих заместителей, срок полномочий которых истечет через два года, в соответствии со следующей схемой: три члена от африканских государств; три от азиатских государств; один от восточноевропейских государств; три от латиноамериканских государств и три от западноевропейских и других государств.
- 3. Список настоящих членов Подкомиссии, избранных в соответствии с этой процедурой, приводится в приложении II.

- 4. Поскольку срок полномочий половины членского состава Подкомиссии истек, Комиссии по правам человека необходимо избрать новых членов Подкомиссии и их заместителей в соответствии со следующей скемой: три члена от африканских государств; три от азиатских государств; один от восточноевропейских государств; три от латиноамериканских государств и три от западноевропейских и других государств.
- 5. В своей резолюции 1989/36 от 6 марта 1989 года Комиссия по правам человека призвала государства назначать членами и их заместителями лиц, отвечающих требованиям, предъявляемым к независимым экспертам, которые должны в этом качестве выполнять свои функции как члены Подкомиссии. Подкомиссия в своей резолюции 1987/32 от 4 сентября 1987 года рекомендовала, чтобы Комиссия по правам человека стремилась убеждать правительства всех стран назначать больше женщин для избрания в Подкомиссию.
- 6. В отношении назначения заместителей Экономический и Социальный Сорет принял резолюцию 1983/32, в которой постановил, что:
 - "... вопреки положениям пункта 2 правила 13 правил процедуры функциональных комиссий Экономического и Социального Совета в отношении Подкомиссии по предупреждению дискриминации и защите меньшинств впредь будут действовать следующие правила:
 - а) назначение кандидата в члены Подкомиссии может сопровождаться назначением эксперта из той же страны, который должен выбираться одновременно с кандидатом в члены Подкомиссии и может временно являться его заместителем в случае отсутствия данного члена;
 - в) к заместителям предъявляются те же требования, что и к членам;
 - с) заместителем члена не может быть никто, помимо выбранного вместе с ним эксперта, в соответствии с подпунктом а) выше".
- 7. По состоянию на 23 октября 1989 года, Генеральный секретарь получил кандидатуры для избрания в состав Подкомиссии от правительств Алжира, Аргентины, Бразилии, Бурунди, Гамбии, Греции, Индии, Иордании, Испании, Коста-Рики, Мексики, Нигерии, Панамы, Сенегала, Соединенного Королевства Великобритании и Северной Ирландии, Союза Советских Социалистическиз Республик, Франции, Центральноафриканской Республики и Чада.
- 8. Дальнейшие сообщения и фамилии кандидатов, представленные правительствами, будут распространены в качестве добавлений к настоящему документу.
- 9. Фамилии кандидатов, полученные от правительств к настоящему времени, перечислены ниже, а касающиеся их биографические данные включены в приложение I к настоящему документу.
