FINANCING OF THE UNITED NATIONS ANGOLA VERIFICATION MISSION

#### Report of the Fifth Committee

#### I. INTRODUCTION

- 1. At its 3rd plenary meeting, on 22 September 1989, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its forty-fourth session the item entitled "Financing of the United Nations Angola Verification Mission", and to allocate it to the Fifth Committee.
- 2. At its 58th meeting, on 18 December 1989, the Fifth Committee considered the report of the Secretary-General on the financing of the United Nations Angola Verification Mission (A/44/877) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/44/881).

#### II. CONSIDERATION OF DRAFT RESOLUTION A/C.5/44/L.16

- 3. At its 58th meeting, on 18 December 1989, the Chairman introduced a draft resolution (A/C.5/44/L.16).
- 4. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 6).
- 5. Statements and observations made in the course of the Committee's consideration of this item are reflected in the relevant summary record (see A/C.5/44/SR.58).

### III. RECOMMENDATION OF THE FIFTH COMMITTEE

6. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

## Financing of the United Nations Angola Verification Mission

The General Assembly,

<u>Having considered</u> the report of the Secretary-General on the financing of the United Nations Angola Verification Mission  $\underline{1}$ / and the related report of the Advisory Committee on Administrative and Budgetary Questions,  $\underline{2}$ /

Bearing in mind Security Council resolution 626 (1988) of 20 December 1988, by which the Council established the United Nations Angola Verification Mission for a period of thirty-one months,

Recognizing that the costs of the United Nations Angola Verification Mission are expenses of the Organization to be borne by Member States in accordance with Article 17, paragraph 2, of the Charter of the United Nations,

Mindful of the fact that it is essential to provide the United Nations Angola Verification Mission with the necessary financial resources to enable it to fulfil its responsibilities under the relevant resolution of the Security Council,

Recognizing that, in order to meet the expenditures caused by the United Nations Angola Verification Mission, a different procedure is required from the one applied to meet expenditures of the regular budget of the United Nations,

Taking into account the fact that the economically more developed countries are in a position to make relatively larger contributions and that the economically less developed countries have a relatively limited capacity to contribute towards such an operation,

Bearing in mind the special responsibilities of the States permanent members of the Security Council in the financing of such operations, as indicated in General Assembly resolution 1874 (S-IV) of 27 June 1963,

Mindful of the views expressed in the Fifth Committee 3/ on the requests of some Member States to change their placement in the existing groups "b", "c" and "d" of Member States, on the basis of the criteria set out in General Assembly resolution 3101 (XXVIII) of 11 December 1973,

- 1. <u>Concurs</u> with the observations, recommendations and conclusions contained in the report of the Advisory Committee on Administrative and Budgetary Questions;
- 2. <u>Urges</u> all Member States to make every possible effort to ensure payment of their assessed contributions to the United Nations Angola Verification Mission in full and on time;
- 3. <u>Decides</u>, taking into account the outstanding assessed contributions due to the Special Account of the United Nations Angola Verification Mission, to defer any further action on the estimated unencumbered balance of the appropriations as may be called for until its forty-fifth session;
- 4. <u>Decides also</u> to appropriate an amount of 5,826,400 United States dollars for the operations of the United Nations Angola Verification Mission from 3 January 1990 to 2 January 1991, inclusive;
- 5. <u>Decides further</u>, as an <u>ad hoc</u> arrangement, to apportion the amount of 5,826,400 United States dollars for the above-mentioned period among Member States in accordance with the composition of groups set out in paragraphs 3 and 4 of General Assembly resolution 43/232 of 1 March 1989, to be adjusted by the decision to be taken by the Assembly at its forty-fourth session on the composition of the four groups "a", "b", "c" and "d" of Member States and taking into account the scale of assessments for the years 1989, 1990 and 1991; 4/
- 6. <u>Decides</u> that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among the Member States, as provided for in paragraph 5 above, their respective share in the Tax Equalization Fund of the estimated staff assessment income of 210,000 United States dollars approved for the above-mentioned period;
- 7. <u>Invites</u> voluntary contributions to the United Nations Angola Verification Mission both in cash and in the form of services and supplies acceptable to the Secretary-General, to be administered, as appropriate, in accordance with the procedure to be established by the General Assembly at its forty-fourth session;

- 8. Requests the Secretary-General to take all necessary action to ensure that the United Nations Angola Verification Mission is administered with the maximum of efficiency and economy, bearing in mind the relevant observations contained in the report of the Advisory Committee on Administrative and Budgetary Questions;
- 9. <u>Decides</u> to include in the provisional agenda of its forty-fifth session the item entitled "Financing of the United Nations Angola Verification Mission" and to request the Secretary-General to submit to the General Assembly at its forty-fifth session a report on the implementation of the present resolution.
