STATUS OF THE CONVENTION AGAINST TORTURE AND OTHER CRUEL, INHUMAN OR DEGRADING TREATMENT OR PUNISHMENT

Report of the Secretary-General

- 1. The General Assembly, by its resolution 39/46 of 10 December 1984, adopted and opened for signature, ratification and accession the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, and called upon all Governments to consider signing and ratifying the Convention as a matter or priority.
- 2. The Convention was opened for signature in New York on 4 February 1985. In accordance with article 27 thereof, the Convention entered into force on 26 June 1987, on the thirtieth day after the date of the deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession.
- 3. By its resolution 1989/29 of 6 March 1989, the Commission on Human Rights reiterated its request to all States to become parties to the Convention as a matter of priority; invited all States ratifying or acceding to the Convention and those States parties which had not yet done so to consider the possibility of making the declarations provided for in articles 21 and 22 of the Convention; and requested the Secretary-General to continue submitting to the General Assembly and to the Commission on Human Rights annual reports on the Status of the Convention.

- 4. As at 15 December 1989, the Convention had been ratified or acceded to by 49 States. In addition, 22 States had signed the Convention. The list of States that have signed, ratified or acceded to the Convention, as well as the dates of their signature, ratification or accession, is contained in the annex to the present report.
- As at the same date, 23 of the States parties to the Convention, namely, 5. Algeria, Argentina, Austria, Canada, Denmark, Ecuador, Finland, France, Greece, Hungary, Italy, Luxembourg, Netherlands, New Zealand, Norway Portugal, Spain, Sweden, Switzerland, Togo, Tunisia, Turkey and Uruguay, had made the declarations provided for in articles 21 and 22 of the Convention. addition, one State party, namely the United Kingdom of Great Britain and Northern Ireland, had only made the declaration provided for in article 21 thus bringing the total of declarations under this article to 24. $\underline{1}/$ Under article 21, a State party to the Convention may declare at any time that it recognizes the competence of the Committee against Torture to receive and consider communications to the effect that a State party claims that another State party is not fulfilling its obligations under the Convention. Under article 22, a State party to the Convention may declare at any time that it recognizes the competence of the Committee to receive and consider communciations from or on behalf of individuals subject to its jurisdiction who claim to be victims of a violation by a State party of the provisions of the Convention.
 - 6. The provisions of articles 21 and 22 entered into force on 26 June 1987 in accordance with paragraph 2 of article 21 and paragraph 8 of article 22.
 - 7. The Committee against Torture held its second and third sessions at the United Nations Office at Geneva from 17 to 28 April 1989 and from 13 to 24 November 1989, respectively. in accordance with article 24 of the Convention, the Committee submitted its annual report, 2/ which covered the activities of the Committee at its second session, to the States parties and to the General Assembly at its forty-fourth session.
 - 8. The Second Meeting of the States parties to the Covention was convened by the Secretary-General at the United Nations Office at Geneva, on 28 November 1989, to elect five members of the Committee against Torture to replace those whose terms of office were due to expire on 31 December 1989 and to decide on questions relating to their financial obligations under the Convention. 3/ In accordance with article 17 of the Convention, the meeting re-elected the five members of the Committee against Torture whose terms of office were due to expire on 31 December 1989 for a term of four years beginning 1 January 1990. Accordingly, the membership of the Committee for 1990-1991 will be as follows:

By its resolution 44/144 of 15 December 1989, the General Assembly, inter alia, welcomed the report of the Committee against Torture; stressed the importance of strict adherence by States parties to the obligations under the Convention regarding the financing of the Committee against Torture, thus enabling it to carry out in an effective and efficient manner all the functions entrusted to it under the Convention, and appealed to all States parties not to take any measures which might impair the financing of all the functions of the Committee under the Convention, so as to ensure the long-term viability of the Committee as an essential mechanism for overseeing the effective implementation of the provisions of the Convention. The Assembly also welcomed the attention which the Committee against Torture had given to the development of an effective reporting system on implementation by States parties to the Convention, and especially its decision to revise its general guidelines for the submission of initial reports by States parties; took note with appreciation of the adoption by the Committee against Torture of its rules of procedure; welcomed the exchange of views that had taken place between the Committee against Torture and the Special Rapporteur of the Commission on Human Rights on questions relating to torture and requestd that this exchange be continued.
