### Organization of the session

### A. Opening and duration of the session

1. The Commission for Social Development held its fifty-fourth session at United Nations Headquarters on 13 February 2015 and from 3 to 12 February 2016. The Commission held [ ] meetings (1st to [ ]).

#### B. Attendance

2. The session was attended by representatives of [ ] States members of the Commission. Observers for other States Members of the United Nations and for non-member States, representatives of organizations of the United Nations system and observers for intergovernmental, non-governmental and other organizations also attended. #### C. Election of officers

- 3. In its decision 2002/210, the Economic and Social Council decided that, immediately following the closure of a regular session, the Commission would hold the first meeting of its subsequent regular session for the sole purpose of electing the new Chair and other members of the Bureau.
- 4. At its 1st meeting, on 13 February 2015, pursuant to decision 2002/210, the Commission elected the following officers for the fifty-fourth session by acclamation:

- 5. At its 2nd meeting, on 3 February 2016, the Commission was informed that, subsequently, Simona Mirela Miculescu (Romania) had resigned as Chair of the fifty-fourth session.
- 6. The Commission then elected, by acclamation, Ion Jinga (Romania) as Chair of the fifty-fourth session of the Commission.
- 7. Also at the 2nd meeting, the Chair recalled that, at the 1st meeting of the fifty-third session, held on 21 February 2014, the Commission had elected, by acclamation, Amina Smaila (Nigeria) and Janina Hasse-Mohsine (Germany) as Vice-Chairs for its fifty-third and fifty-fourth sessions, and that, subsequently, Janina Hasse-Mohsine (Germany) had resigned as Vice-Chair of the Commission at its fifty-fourth session.
- 8. The Commission then elected, by acclamation, Mohammad Hassani Nejad Pirkouhi (Islamic Republic of Iran) and Maria Inês de Almeida Coroa (Portugal) as Vice-Chairs of the fifty-fourth session of the Commission.
- 9. Also at its 2nd meeting, the Commission designated the Vice-Chair of the Commission, Mohammad Hassani Nejad Pirkouhi (Islamic Republic of Iran), as Rapporteur of the fifty-fourth session.

      - (v) Family issues, policies and programmes;
