After division, the advances to be made by India and Pakistan separately were \$650,000 and \$140,000, respectively. The question whether India should receive credit for the total advance of \$790,000 or whether India and Pakistan should share proportionately is the subject of consultations between the two Governments. In the meantime the sum of \$140,000 is held in suspense.
