The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 24/2 of 26 September 2013, in which the Council requested the Advisory Committee to prepare, from within existing resources, a research-based report on the role of local government in the promotion and protection of human rights, including human rights mainstreaming in local administration and public services, with a view to compiling best practices and main challenges, and to present a progress report on the requested research-based report to the Council at its twenty-seventh session,

Recalling also Human Rights Council resolution 27/4 of 25 September 2014, in which the Council took note with appreciation that the Advisory Committee had presented to the Council at its twenty-seventh session a progress report based on research on the role of local government in the promotion and protection of human rights, including human rights mainstreaming in local administration and public services, and requested the Committee to continue its research, from within existing resources, and to submit a final report on the role of local government in the promotion and protection of human rights to the Council at its thirtieth session.

Recalling further that at its twelfth session the Advisory Committee established a drafting group, which is currently composed of Mr. Coriolano, Ms. Elsadda (Rapporteur), Ms. Pabel (Chairperson), Ms. Reyes Prado, and Mr. Yigezu, as well as Mr. Benanni, Ms. Crăciunean and Mr. Soh, who joined the drafting group at the current session,
