(a) An advance of \$790,000 was made in 1946 by undivided India to the Working Capital Fund. After division, the advances to be made by India and Pakistan separately were \$650,000 and \$140,000 respectively. The question whether India should receive credit for the total advance of \$790,000 or whether India and Pakistan should share proportionately is the subject of consultation between the two Governments. In the meantime the sum of \$140,000 is held in suspense.
