Note by the Secretariat

1. The annex to the present note contains the calendar of conferences and meetings of the United Nations for 2016 and 2017, as adopted by the General Assembly in paragraph 2 of section I of its resolution 70/9, and taking into account other resolutions and decisions adopted by the Assembly at its seventieth session.
