- ⁴ The communication contained a petition listing the names of 101 Georgian nationals condemning the war in the Syrian Arab Republic.
- ⁵ The communication was transmitted by the managing attorney of the Institute for Justice and Democracy in Haiti and contained 2,602 letters from cholera victims in Boucan Carré, Mirebalais and Saut d'Eau, Haiti.
- ⁶ The communication contained a petition listing the names of 852 students at the Collège Bourget in Rigaud.
- ⁷ A similar communication dated 29 December 2015 was received from the same person.
- ⁸ The communication was signed by the Co-Chief of the International Anti-Corruption Court. Similar communications dated 10 April and 20 December 2015 were received from the same person.
