古阿姆集团地区旷日持久的冲突 及其对国际和平、安全与发展的影响 阿塞拜疆被占领土局势

2016年4月27日阿塞拜疆常驻联合国代表团临时代办给秘书长和安全理事会主席的同文信

继 2016 年 4 月 20 日阿塞拜疆共和国外交部长埃利马尔•马梅德亚罗关于最近亚美尼亚和阿塞拜疆武装部队接触线以及两国边界附近局势升级的信之后,我谨提请你注意亚美尼亚共和国武装部队最近严重违反 2016 年 4 月 5 日停火协定的行为,该停火协定是阿塞拜疆共和国与亚美尼亚共和国武装部队总参谋长在俄罗斯联邦武装部队总参谋长的协助下在莫斯科达成的。

亚美尼亚武装部队在接触线上集结了更多部队和军事装备,并自 2016 年 4 月 23 日起,使用大口径武器、迫击炮、榴弹发射器和重型火炮,向对峙线附近的阿塞拜疆武装部队阵地和平民居住区猛烈开火。应当指出,阿塞拜疆人居住的村庄仅限于阿塞拜疆控制的领土,因为在亚美尼亚控制的土地上的所有其他居民区已经遭到亚美尼亚武装部队的彻底种族清洗。4 月 24 日午夜,由于亚美尼亚武装部队的炮击,阿塞拜疆 Tartar 地区 Shikharkh 住区一户居民的房屋被毁(见附件一照片)。当晚,亚美尼亚武装部队从集结在对峙线沿线的坦克上向阿塞拜疆武装部队阵地密集开火,并企图增加兵力发动攻击。

亚美尼亚武装部队最近的这些进攻行动违反了2016年4月5日的停火协定, 严重阻碍了欧洲安全与合作组织明斯克小组为解决冲突而开展的外交努力。





对此,阿塞拜疆共和国再次呼吁国际社会谴责亚美尼亚公然违反国际法和停火制度,要求该国严格遵守 2016 年 4 月 5 日的停火承诺,建设性地参与关于从阿塞拜疆被占领土撤出其武装部队的实质性谈判,从而为进一步考虑和解决其余政治问题铺平道路。

亚美尼亚共和国武装部队再次严重违反了 2016 年 4 月 5 日阿塞拜疆共和国与亚美尼亚共和国武装部队总参谋长达成的停火协定。

亚美尼亚武装部队在 Aghdere 方向集结了更多部队和军事装备,并自 2016 年 4 月 23 日起,使用大口径武器、迫击炮、榴弹发射器和重型火炮,向对峙线附近 Tartar 地区的阿塞拜疆武装部队阵地和平民居住区猛烈开火。

亚美尼亚武装部队使用 122 毫米 D-30 型榴弹炮,向阿塞拜疆武装部队阵地发射了多达 20 枚射弹。4 月 24 日午夜,由于亚美尼亚武装部队的炮击,Tartar地区 Shikharkh 住区一户居民的房屋被毁(见下文照片)。


阿塞拜疆武装部队立即朝该方向实行对抗措施,以遏制亚美尼亚武装部队的 敌对活动。4月24日午夜,亚美尼亚武装部队从集结在对峙线沿线的坦克上向阿 塞拜疆武装部队阵地密集开火,并企图增加兵力发动攻击。

亚美尼亚武装部队的坦克在靠近阿塞拜疆武装部队阵地时遭炮火拦截,其中一辆坦克及所载士兵被摧毁。随后亚美尼亚部队被迫向 Aghdere 方向撤退。 Sugovushan (Madagiz)军事基地周围的亚美尼亚炮兵部队也遭到预防性措施的压制。





5 April 2016

The armed forces of Armenia violated the ceasefire 115 times along various directions of the front using large-calibre machine guns, mortars and grenade launchers as well as artillery systems of 60, 82 and 120 mm. As a result, one military serviceman was killed and eight military servicemen were wounded.

From their positions in Berkaber village in the Ijevan district, Aygepar village in the Berd district and nameless heights in the Krasnoselsk district of Armenia, the armed forces of Armenia fired on the positions of the armed forces of Azerbaijan in Gizilhajili village in the Gazakh district, Alibayli village in the Tovuz district and nameless heights in the Gadabay district.

The positions of the armed forces of Azerbaijan were also subjected to fire from positions on heights near Gulustan village in the Goranboy district; Goyarkh, Yarimja and Chileburt villages in the Tartar district; Shikhlar, Bash Garvand, Javahirli, Sarijali, Kangarli, Novruzlu, Shuraabad, Marzili and Yusifjanli villages in the Aghdam district; Kuropatkino village in the Khojavand district; Garakhanbayli, Horadiz, Gorgan and Ashaghi Seyidahmadli villages in the Fuzuli district; and Mehdili village in the Jabrayil district, as well as on heights in the Goygol, Goranboy, Khojavand, Fizuli and Jabrayil districts.

6 April 2016

The armed forces of Armenia violated the ceasefire 119 times along various directions of the front using large-calibre machine guns and artillery systems. As a result, three military servicemen were killed and seven military servicemen were wounded.

From their positions in Berkaber and Paravakar villages in the Ijevan district, Mosesgekh village of the Berd district and nameless heights in the Krasnoselsk district of Armenia, the armed forces of Armenia fired on the positions of the armed forces of Az.erbaijan in Gizilhajili village in the Gazakh district, Kohnagishlag village in the Aghstafa district, Alibayli and Aghdam villages in the Tovuz district and nameless

heights in the Gadabay district.

The positions of the armed forces of Az.erbaijan were also subjected to fire from positions in heights near Gulustan village in the Goranboy district; Goyarkh, Yarimja and Chileburt villages in the Tartar district; Shikhlar, Bash Garvand, Javahirli, Sarijali, Kangarli, Novruzlu, Shuraabad, Marzili, Yusifjanli, Garagashli and Namirli villages in the Aghdam district, Kuropatkino village in the Khojavand district, Garakhanbayli, Horadiz, Gorgan, Ashaghi Seyidahmadli villages in the Fuzuli district; and Mehdili village in the Jabrayil district, as well as in the Goygol, Goranboy, Khojavand, Fizuli and Jabrayil districts.

From their positions in Dovekh, Voskepar and Barekamavan villages in the Noyamberyan district, Berkaber and Paravakar villages in the Ijevan district, Aygepar village in the Berd district and nameless heights in the Krasnoselsk and Sisian districts of Armenia, the armed forces of Armenia fired on the positions of the armed forces of Azerbaijan in Kamarli, Mazam, Gaymagli and Gizilhajili villages in the Gazakh district; Alibayli village in the Tovuz district and nameless heights in the Gadabay and Julfa districts.

The positions of the armed forces of Azerbaijan were also subjected to fire from positions in heights near Gulustan village in the Goranboy district; Goyarkh,

The armed forces of Armenia violated the ceasefire 110 times on various directions of the front, also using large-calibre machine guns and 60-mm mortars.

From their positions in Parakavar and Berkaber villages in the Ijevan district, Dovekh and Barekamavan villages in the Noyemberyan district, Aygepar and Mosesgekh villages in the Berd district and nameless heights in the Krasnoselsk district of Armenia, the armed forces of Armenia fired on the positions of the armed forces of Azerbaijan in nameless heights and Gizilhajili, Kamarli and Gaymagli villages in the Gazakh district; Alibayli and Aghdam villages in the Tovuz district and nameless heights in the Gadabay district.

The positions of the armed forces of Azerbaijan were also subjected to fire from positions in heights near Chileburt, Yarimja and Goyarkh villages in the Tartar district; Shikhlar, Javahirli, Sarijali, Kangarli, Novruzlu, Shuraabad, Garagashli, Marzili and Yusifjanli villages in the Aghdam district; Kuropatkino village in the Khojavand district; Garakhanbayli, Horadiz, Gorgan and Ashaghi Seyidahmadli villages in the Fuzuli district; and Mehdili village in the Jabrayil district, as well as in nameless heights in the Goygol, Goranboy, Khojavand, Fizuli and Jabrayil districts.

23 April 2016

The armed forces of Armenia violated the ceasefire 108 times on various directions of the front using large-calibre machine guns, mortars, grenade launchers and artillery systems of 60, 82 and 120 mm, as well as battle tanks. From their positions in nameless heights, as well as Parakavar and Berkaber villages in the Ijevan district, Dovekh village in the Noyemberyan district, Mosesgekh, Chinari and Aygepar villages in the Berd district and nameless heights in the Krasnoselsk district of Armenia, the armed forces of Armenia fired on the positions of the armed forces of Azerbaijan in Kohnagishlag village in the Aghstafa district; nameless heights and Gizilhajili and Kamarli villages in the Gazakh district; nameless heights in the Gadabay district.

The positions of the armed forces of Azerbaijan were also subjected to fire from positions in heights near Chileburt and Yarimja villages in the Tartar district; Shikhlar, Bash Garvand, Kangarli, Novruzlu, Marzili, Garagashli, Yusifjanli and Namirli villages in the Aghdam district; Kuropatkino village in the Khojavand district; Garakhanbayli, Horadiz, Gorgan and Ashaghi Seyidahmadli villages in the Fuzuli district; and Mehdili village in the Jabrayil district, as well as in nameless heights in the Goygol, Goranboy, Khojavand, Fizuli and Jabrayil districts.

24 April 2016

The armed forces of Armenia violated the ceasefire 130 times along various directions of the front using 60-mm mortars, as well as 122 mm D-30 howitzers.

From their positions in nameless heights, as well as Parakavar and Berkaber villages in the Ijevan district, Mosesgekh and Chinari villages in the Berd district and nameless heights in the Krasnoselsk district of Armenia, the armed forces of Armenia fired on the positions of the armed forces of Azerbaijan in Kohnagishlag village in the Aghstafa district; nameless heights and Gizilhajili village in the Gazakh district; Aghdam and Kokhanabi villages in the Tovuz district and nameless heights in the Gadabay district.

The positions of the armed forces of Azerbaijan were also subjected to fire from positions in heights near Chileburt, Yarimja and Goyarkh villages in the Tartar district; Shikhlar, Bash Garvand, Kangarli, Javahirli, Sarijali and Namirli villages in the Aghdam district; Kuropatkino village in the Khojavand district; Garakhanbayli, Horadiz, Gorgan and Ashaghi Seyidahmadli villages in the Fuzuli district; and Mehdili village in the Jabrayil district, as well as in nameless heights in the Goygol, Goranboy, Khojavand, Fizuli and Jabrayil districts.
